


This section contains visualisations of the EMDB entry EMD-1507. These allow visual inspection of the internal detail of the map and identification of artifacts.




The images above show the map projected in three orthogonal directions.













3 Map analysis (i)

This section contains the results of statistical analysis of the map.


3.1 Map-value distribution (i)



The map-value distribution is plotted in 128 intervals along the x-axis. The y-axis is logarithmic. A spike in this graph at zero usually indicates that the volume has been masked.



3.2 Volume estimate (i)



The volume at the recommended contour level is 10169 nm³; this corresponds to an approximate mass of 9186 kDa.

The volume estimate graph shows how the enclosed volume varies with the contour level. The recommended contour level is shown as a vertical line and the intersection between the line and the curve gives the volume of the enclosed surface at the given level.

3.3 Rotationally averaged power spectrum (i)
