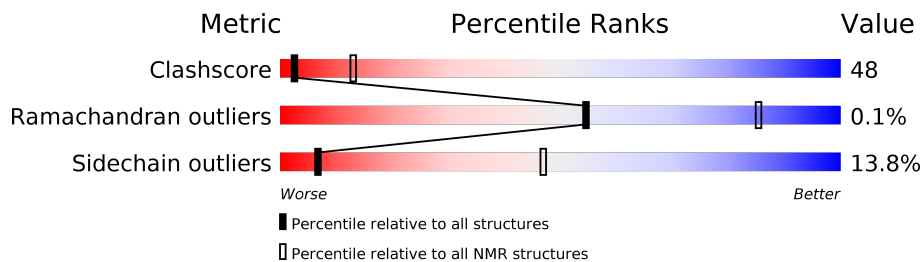
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment is 92%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

2 Ensemble composition and analysis i

This entry contains 40 models. Model 6 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *closest to the average*.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 3 clusters and 6 single-model clusters were found.

3 Entry composition

There are 2 unique types of molecules in this entry. The entry contains 1833 atoms, of which 923 are hydrogens and 0 are deuteriums.

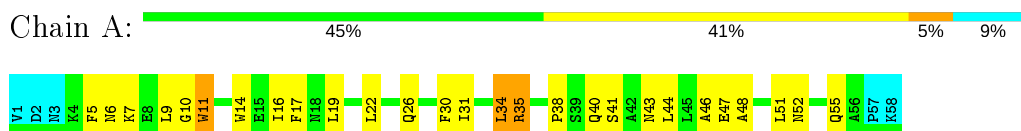

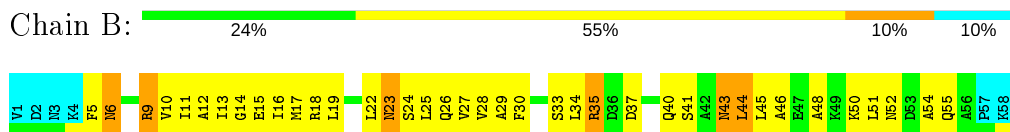
4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

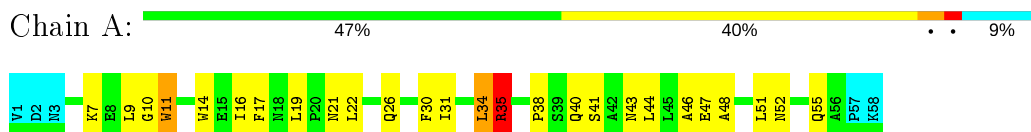

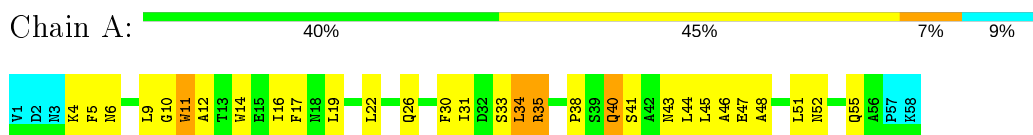

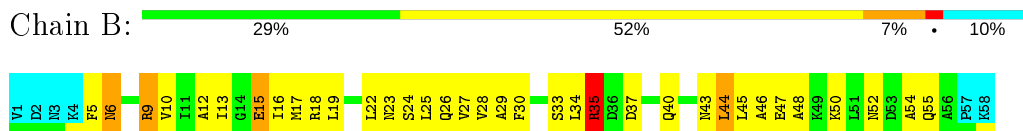

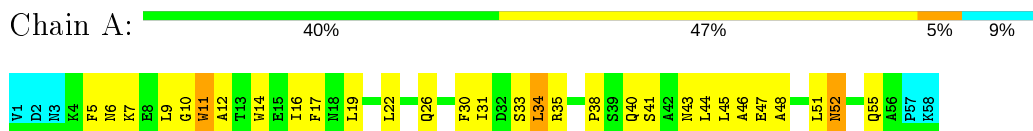

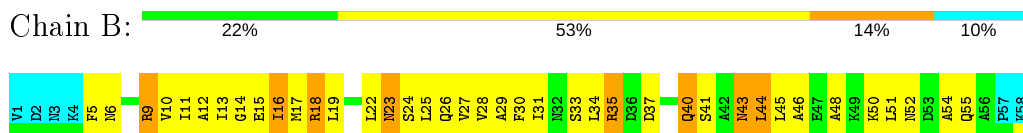

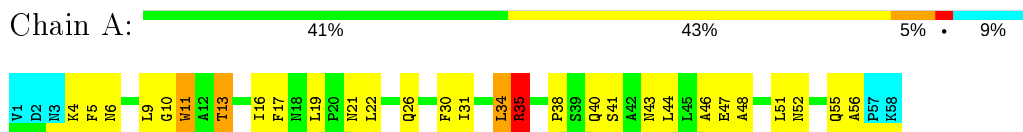

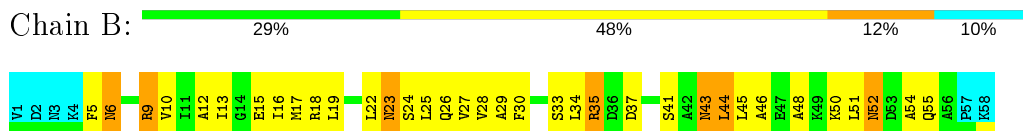

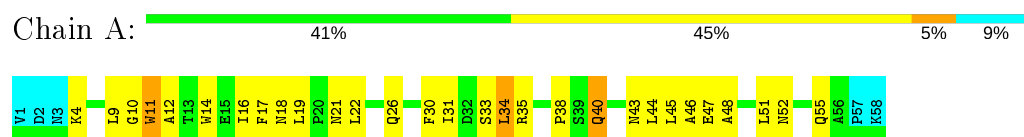

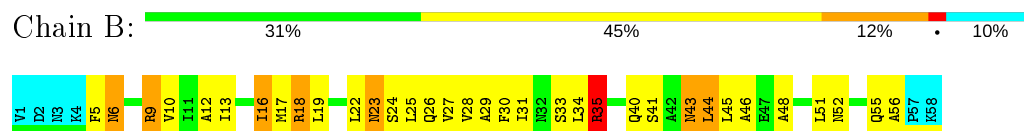

- Molecule 1: ZTaq affibody

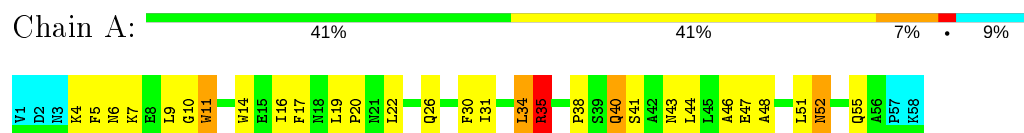

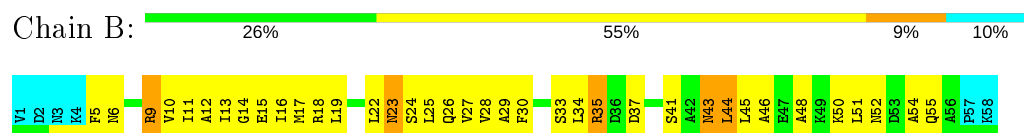


4.2.6 Score per residue for model 6 (medoid)

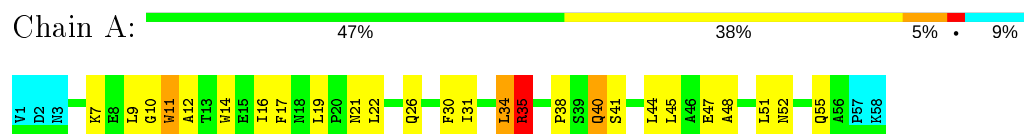

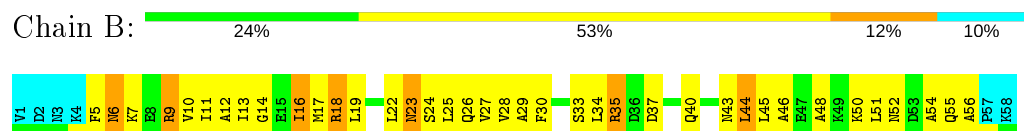

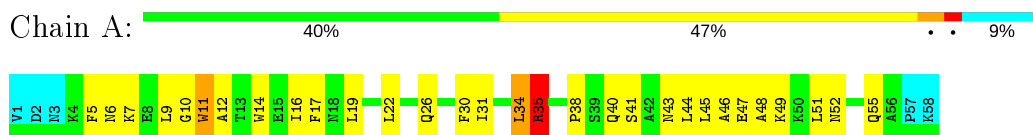

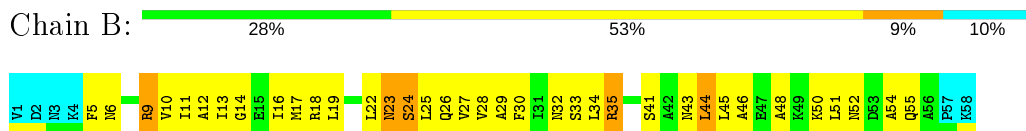

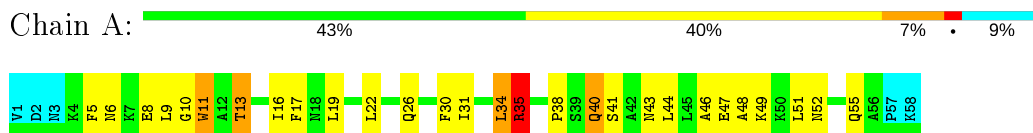

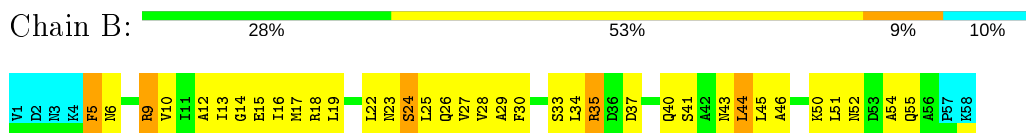

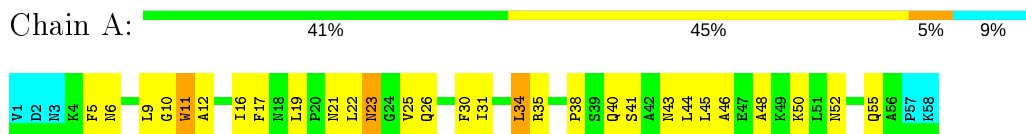

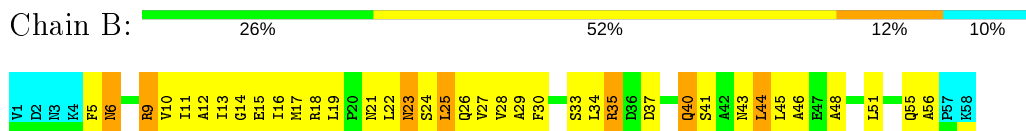

- Molecule 1: ZTaq affibody

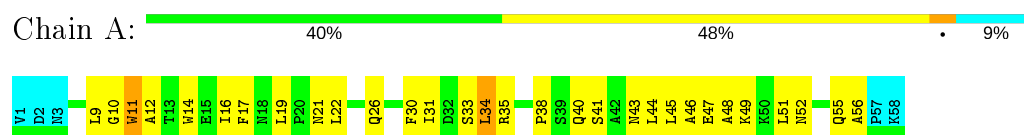

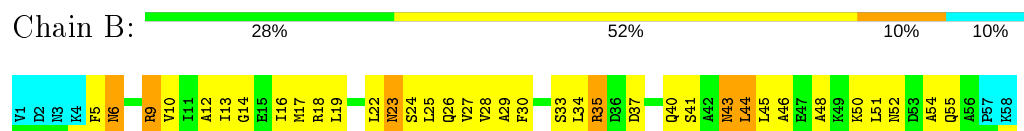

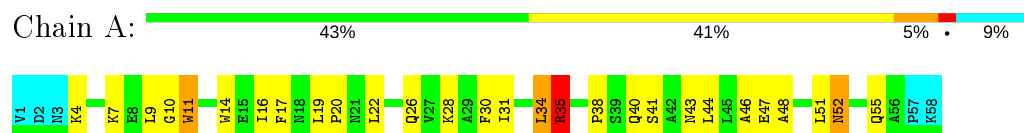

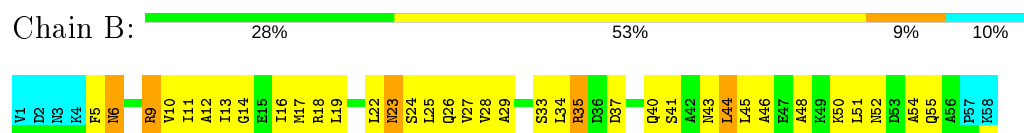

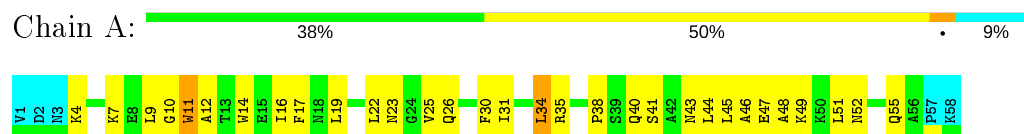

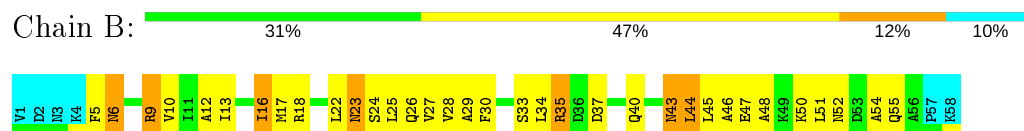

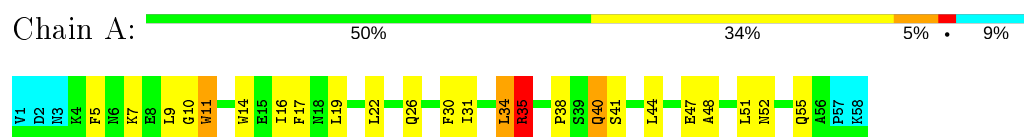

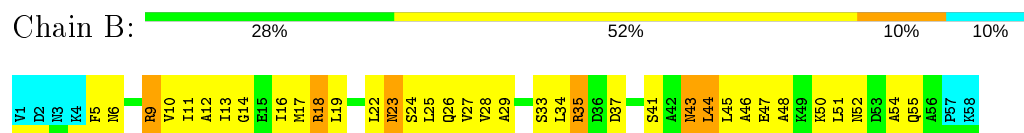

- Molecule 1: ZTaq affibody

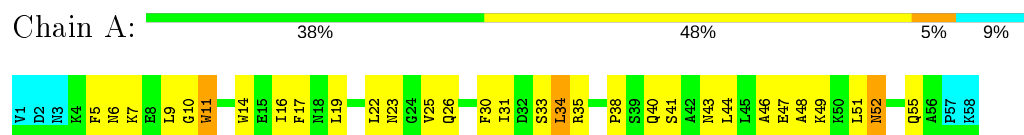

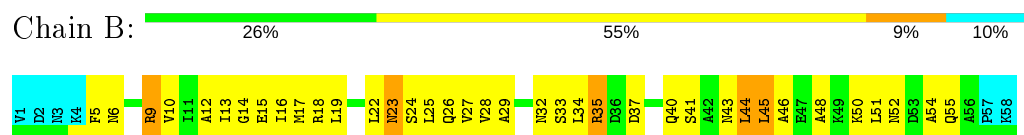


4.2.15 Score per residue for model 15

- Molecule 1: ZTaq affibody

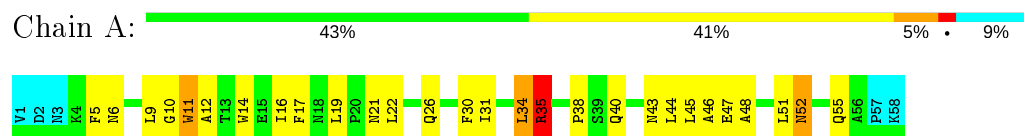

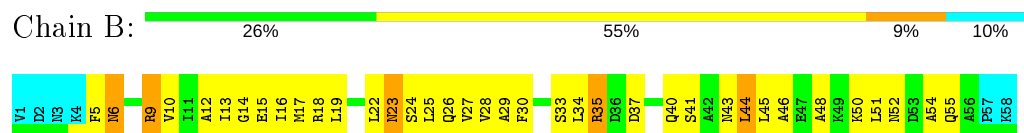


4.2.16 Score per residue for model 16

- Molecule 1: ZTaq affibody

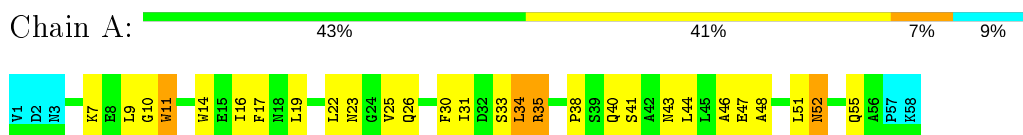

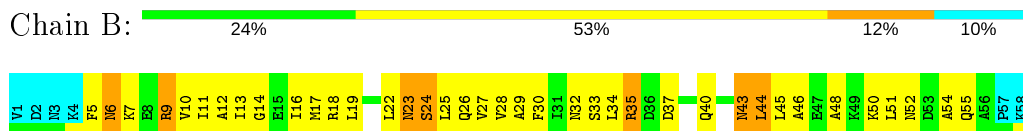

- Molecule 1: ZTaq affibody

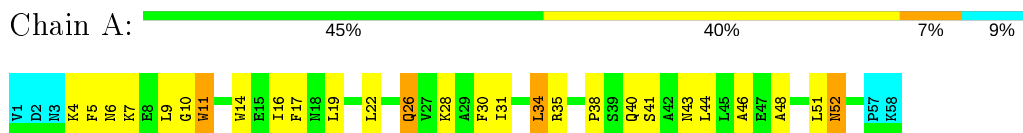

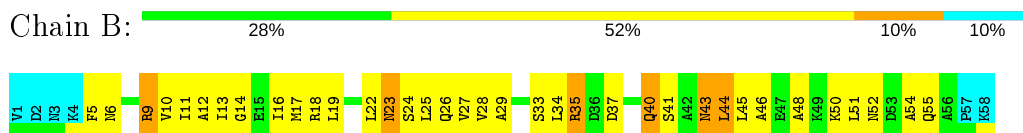

- Molecule 1: ZTaq affibody

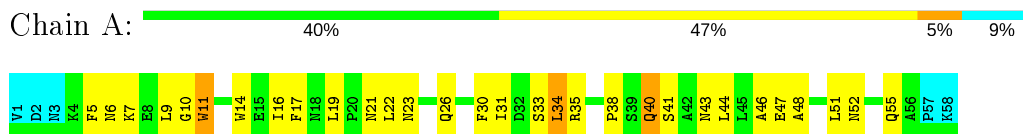

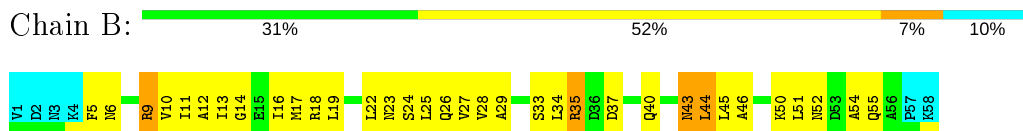

- Molecule 1: ZTaq affibody

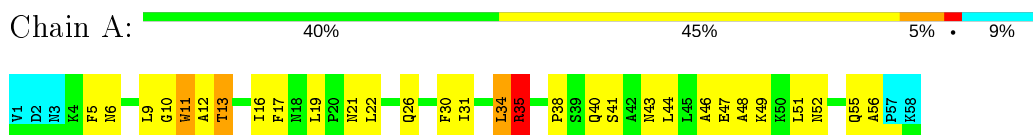


- Molecule 2: anti-ZTaq affibody

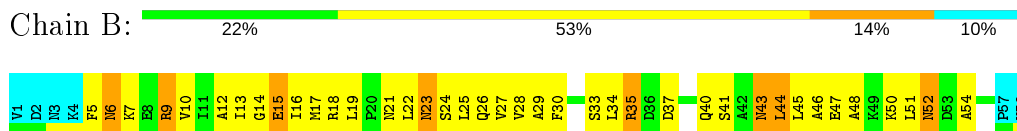


4.2.20 Score per residue for model 20

- Molecule 1: ZTaq affibody

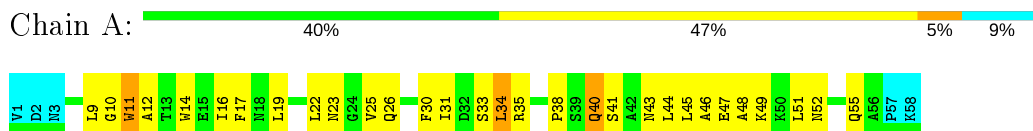

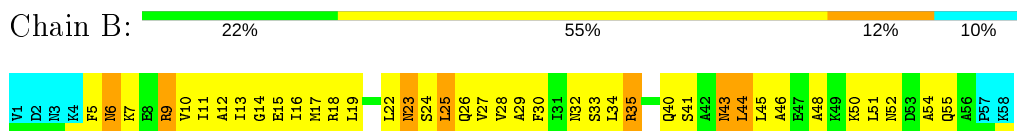


4.2.21 Score per residue for model 21

- Molecule 1: ZTaq affibody

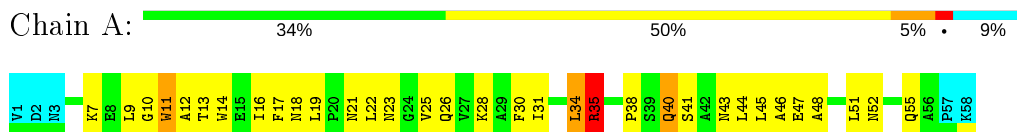

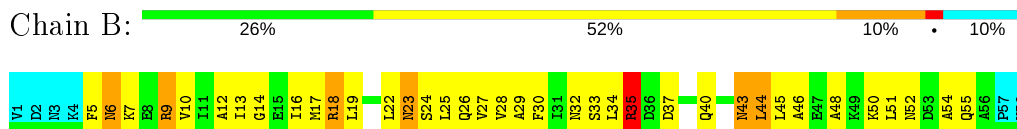

- Molecule 1: ZTaq affibody

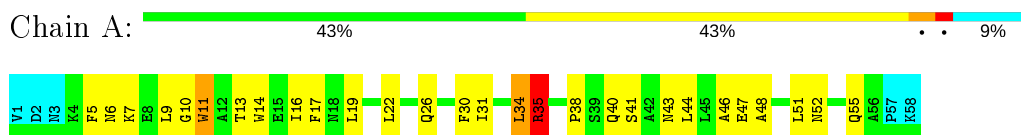


- Molecule 2: anti-ZTaq affibody

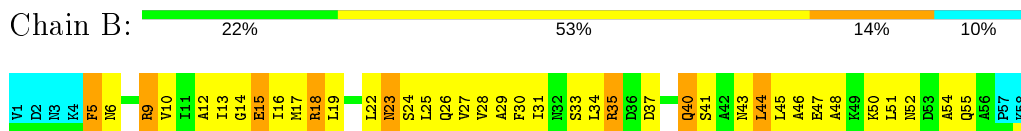


4.2.23 Score per residue for model 23

- Molecule 1: ZTaq affibody

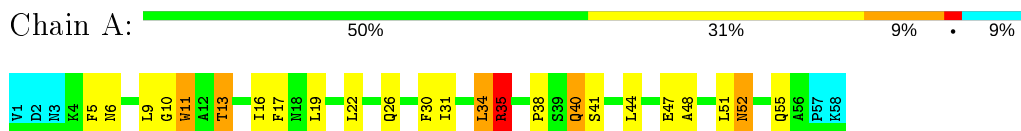

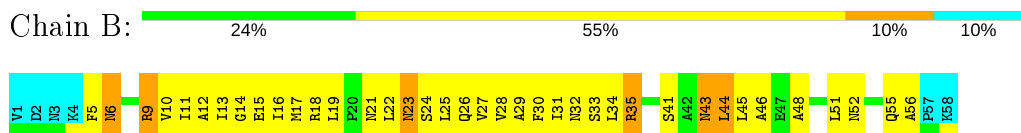


4.2.24 Score per residue for model 24

- Molecule 1: ZTaq affibody

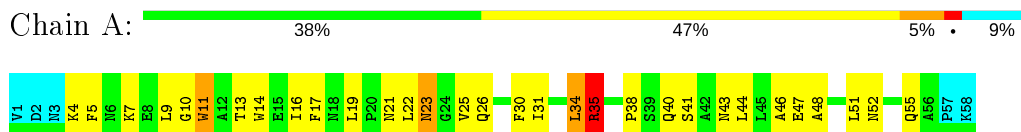

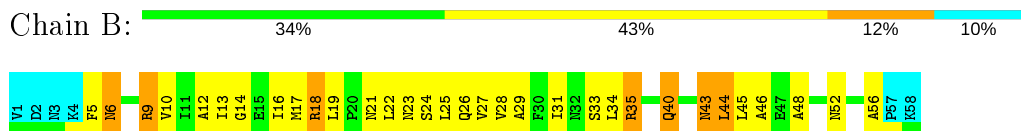


4.2.25 Score per residue for model 25

- Molecule 1: ZTaq affibody

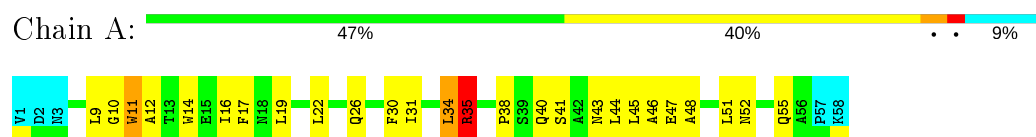


- Molecule 2: anti-ZTaq affibody

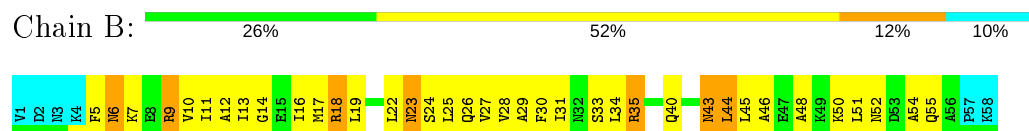


4.2.26 Score per residue for model 26

- Molecule 1: ZTaq affibody

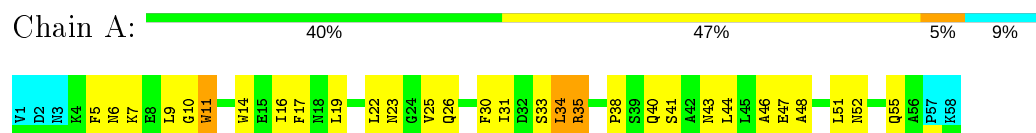


- Molecule 2: anti-ZTaq affibody

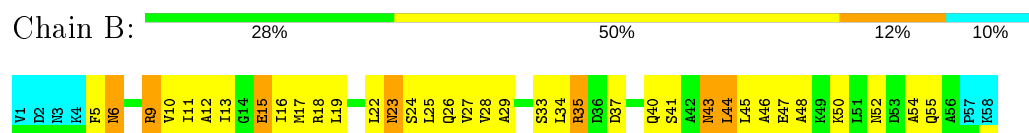


4.2.27 Score per residue for model 27

- Molecule 1: ZTaq affibody

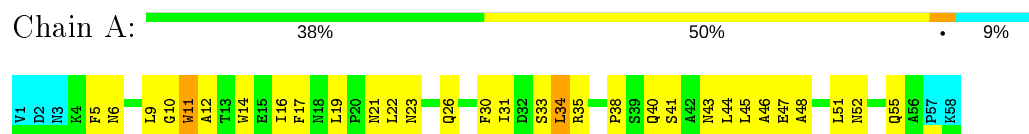


- Molecule 2: anti-ZTaq affibody

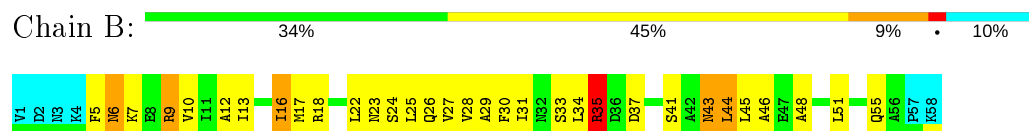

- Molecule 1: ZTaq affibody

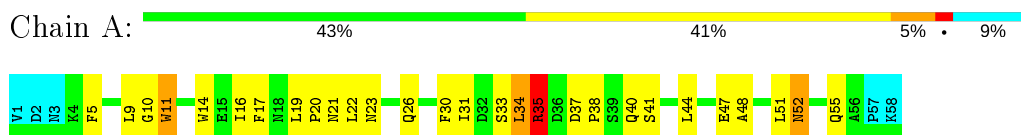

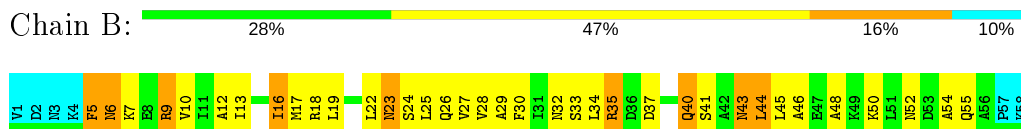

- Molecule 1: ZTaq affibody

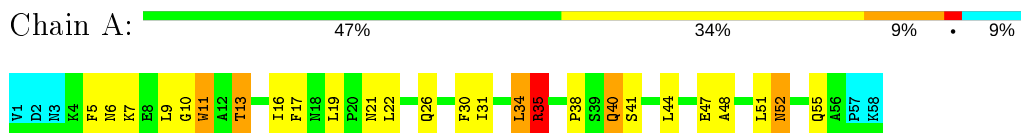

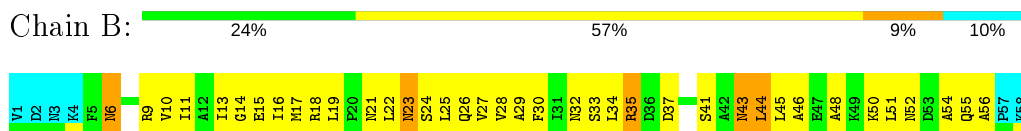

- Molecule 1: ZTaq affibody

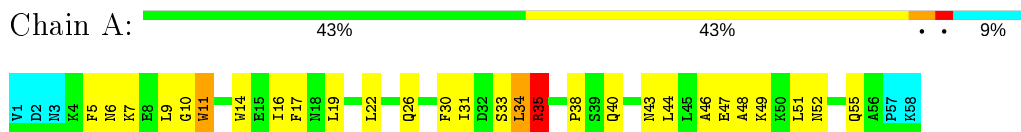


- Molecule 2: anti-ZTaq affibody

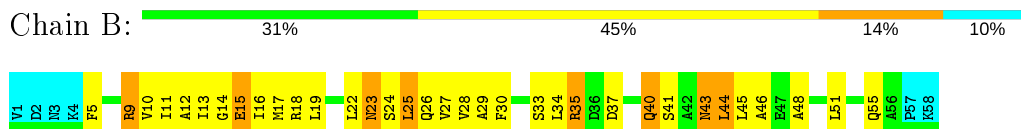

- Molecule 1: ZTaq affibody

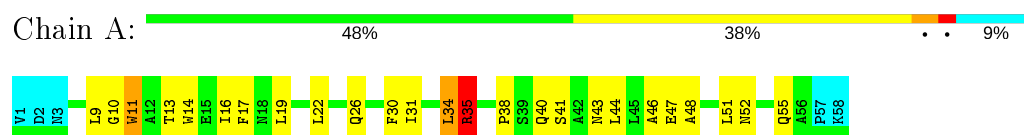

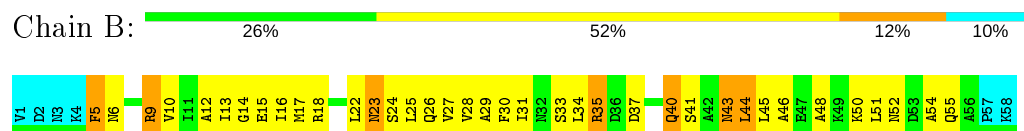

- Molecule 1: ZTaq affibody

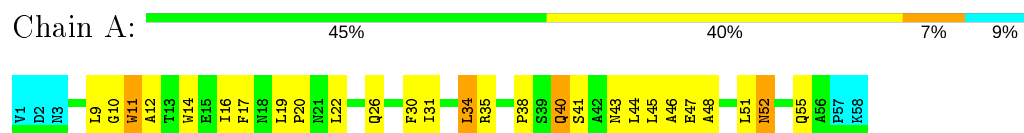


- Molecule 2: anti-ZTaq affibody

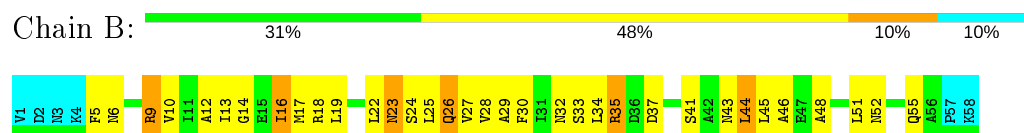

- Molecule 1: ZTaq affibody

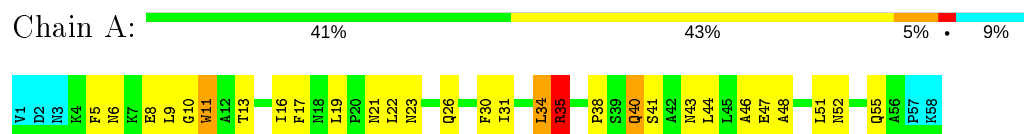

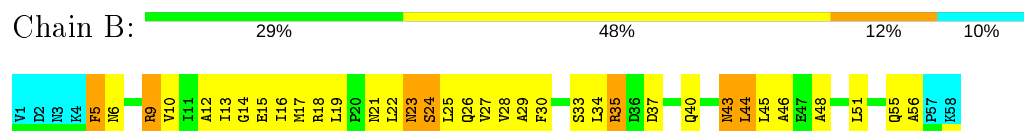

- Molecule 1: ZTaq affibody

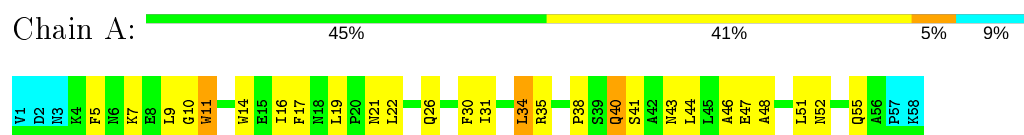

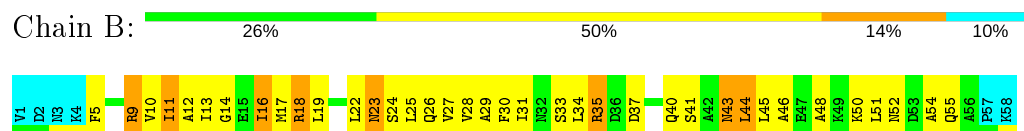

- Molecule 1: ZTaq affibody

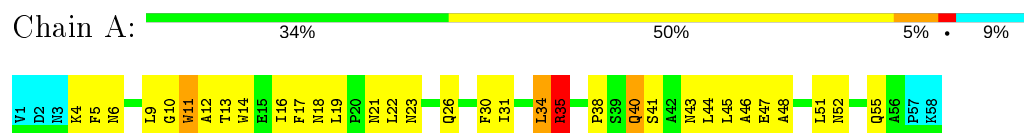


- Molecule 2: anti-ZTaq affibody

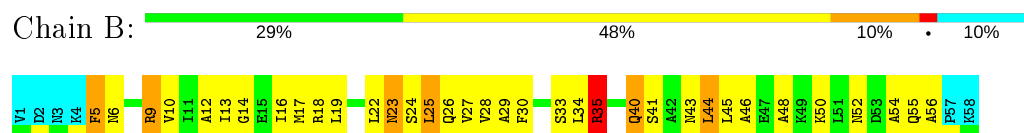

- Molecule 1: ZTaq affibody

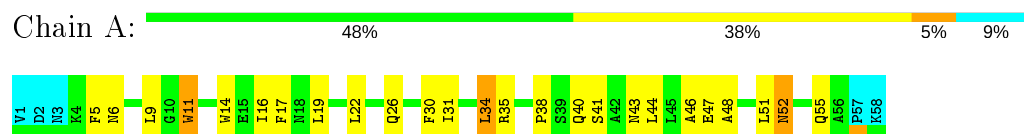

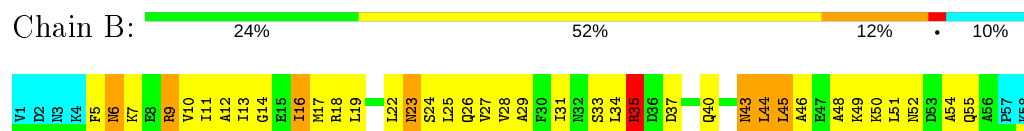

- Molecule 1: ZTaq affibody

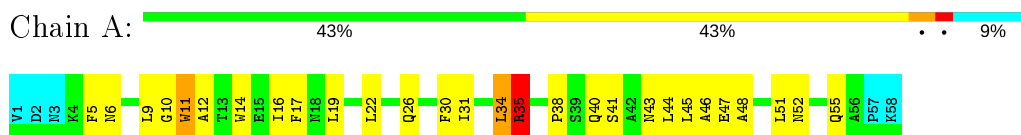


- Molecule 2: anti-ZTaq affibody

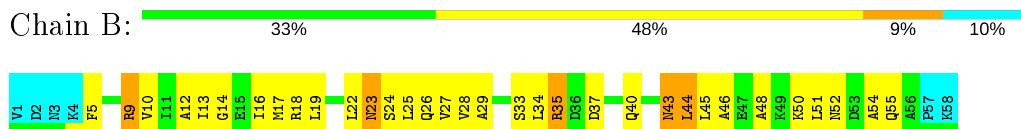

- Molecule 1: ZTaq affibody

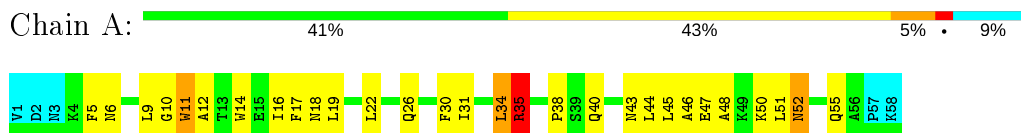


- Molecule 2: anti-ZTaq affibody

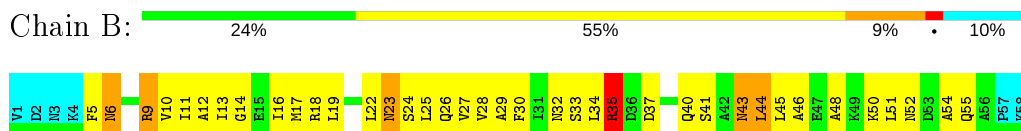

- Molecule 1: ZTaq affibody

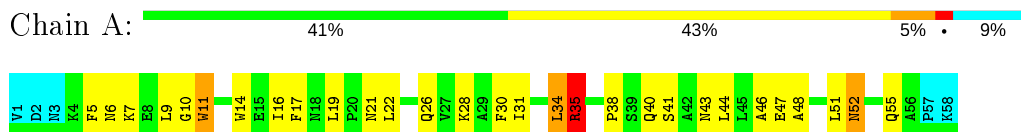

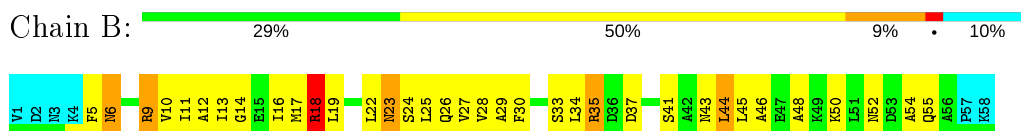


4.2.40 Score per residue for model 40

5 Refinement protocol and experimental data overview

The models were refined using the following method: *simulated annealing*.

Of the 100 calculated structures, 40 were deposited, based on the following criterion: *structures with the least restraint violations, structures with the lowest energy, good ramachandran plots*.

6 Model quality [i](#)

6.1 Standard geometry [i](#)

There are no covalent bond-length or bond-angle outliers.

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

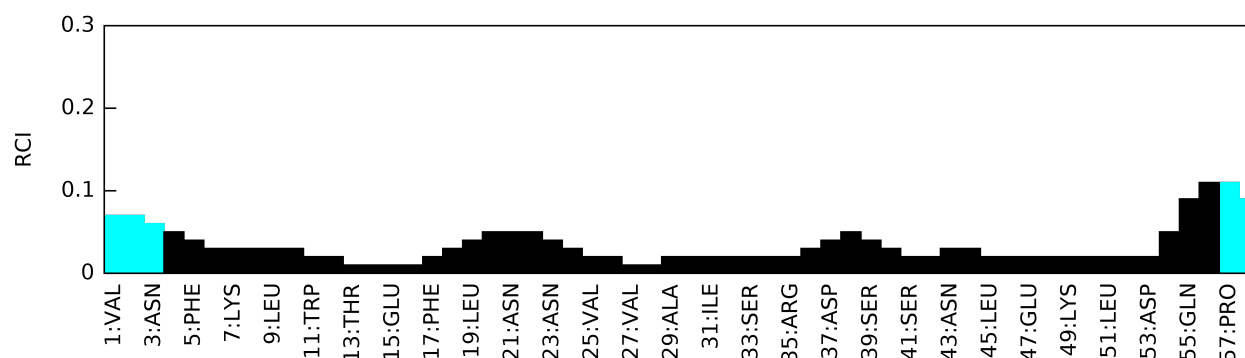
