

1 Overall quality at a glance (i)

The overall completeness of chemical shifts assignment was not calculated.

The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%

2 Ensemble composition and analysis (i)

This entry contains 10 models. The atoms present in the NMR models are not consistent. Some calculations may have failed as a result. All residues are included in the validation scores. Model 3 is the overall representative, medoid model (most similar to other models).

The following residues are included in the computation of the global validation metrics.


3 Entry composition (i)

There are 2 unique types of molecules in this entry. The entry contains 661 atoms, of which 329 are hydrogens and 0 are deuteriums.

4 Residue-property plots (i)

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.



The Link column lists molecule types, if any, to which the group is linked. The Z score for a bond length is the number of standard deviations the observed value is removed from the expected value. A bond length with |Z| > 2 is considered an outlier worth inspection. RMSZ is the average root-mean-square of all Z scores of the bond lengths.


