

1 Overall quality at a glance (i)

2 Entry composition (i)

There are 3 unique types of molecules in this entry. The entry contains 2469 atoms, of which 0 are hydrogens and 0 are deuteriums.

In the tables below, the ZeroOcc column contains the number of atoms modelled with zero occupancy, the AltConf column contains the number of residues with at least one atom in alternate conformation and the Trace column contains the number of residues modelled with at most 2 atoms.

• Molecule 1 is a protein called GLUCOSE-RESISTANCE AMYLASE REGULATOR.

Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 4.42% of the height of the origin peak. No significant pseudotranslation is detected.

²Theoretical values of <|L|>, $<L^2>$ for acentric reflections are 0.5, 0.333 respectively for untwinned datasets, and 0.375, 0.2 for perfectly twinned datasets.

The OWAB column contains the minimum, median, 95^{th} percentile and maximum values of the occupancy-weighted average B-factor per residue. The column labelled 'Q< 0.9' lists the number of (and percentage) of residues with an average occupancy less than 0.9.
