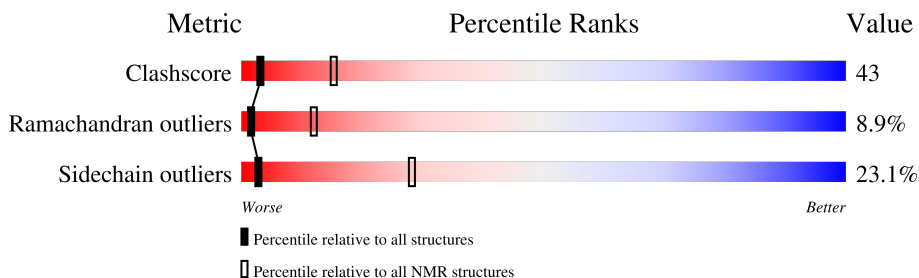
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment is 19%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$.

2 Ensemble composition and analysis

This entry contains 10 models. Model 3 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *all equally good*.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 4 clusters and 2 single-model clusters were found.

3 Entry composition

There is only 1 type of molecule in this entry. The entry contains 1691 atoms, of which 832 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called Ribonuclease.

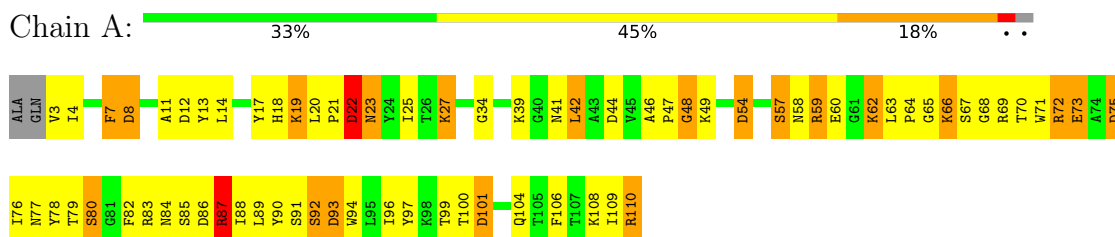

4 Residue-property plots [i](#)

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

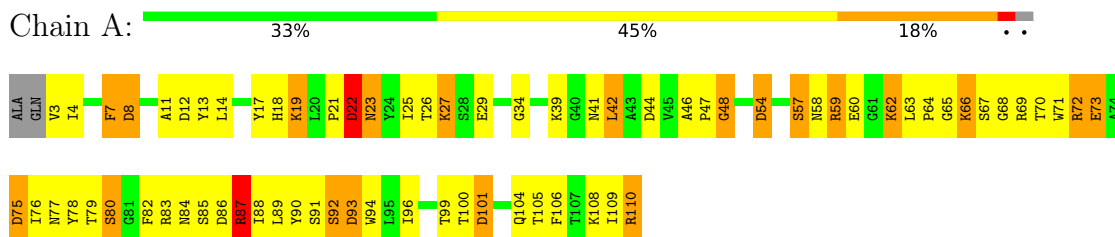
- Molecule 1: Ribonuclease

Of the 50 calculated structures, 10 were deposited, based on the following criterion: *10 randomly selected*.

6 Model quality [i](#)

6.1 Standard geometry [i](#)

There are no covalent bond-length or bond-angle outliers.

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

6.2 Too-close contacts [i](#)

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in each chain respectively. The H(added) column lists the number of hydrogen atoms added and optimized by MolProbity. The Clashes column lists the number of clashes averaged over the ensemble.

The all-atom clashscore is defined as the number of clashes found per 1000 atoms (including hydrogen atoms). The all-atom clashscore for this structure is 43.

The completeness of assignment taking into account all chemical shift lists is 19% for the well-defined parts and 19% for the entire structure.

7.1.2 Chemical shift referencing

No chemical shift referencing corrections were calculated (not enough data).

7.1.3 Completeness of resonance assignments

The following table shows the completeness of the chemical shift assignments for the well-defined regions of the structure. The overall completeness is 19%, i.e. 254 atoms were assigned a chemical shift out of a possible 1320. 0 out of 11 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

7.1.4 Statistically unusual chemical shifts [i](#)

The following table lists the statistically unusual chemical shifts. These are statistical measures, and large deviations from the mean do not necessarily imply incorrect assignments. Molecules containing paramagnetic centres or hemes are expected to give rise to anomalous chemical shifts.

7.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition.
