1 Overall quality at a glance (i)

2 Entry composition (i)

There are 6 unique types of molecules in this entry. The entry contains 2249 atoms, of which 0 are hydrogens and 0 are deuteriums.



Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 12.96% of the height of the origin peak. No significant pseudotranslation is detected.

length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with |Z| > 2 is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

In the following table, the Chirals column lists the number of chiral outliers, the number of chiral centers analysed, the number of these observed in the model and the number defined in the Chemical Component Dictionary.
