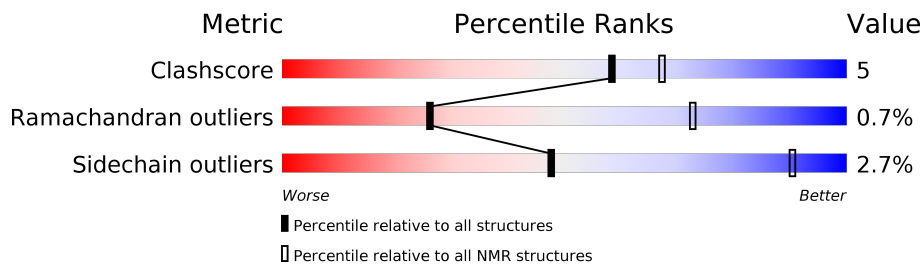
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment is 91%.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

2 Ensemble composition and analysis

This entry contains 20 models. Model 12 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: *lowest energy*.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 5 clusters and 8 single-model clusters were found.

3 Entry composition [i](#)

There are 2 unique types of molecules in this entry. The entry contains 1342 atoms, of which 662 are hydrogens and 0 are deuteriums.

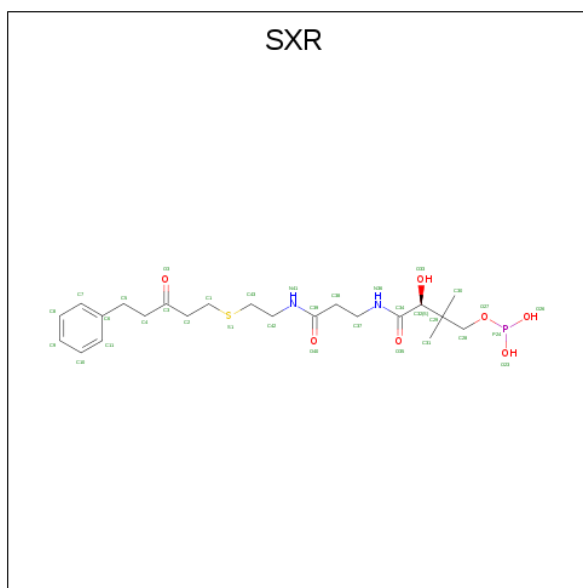
- Molecule 1 is a protein called Actinorhodin polyketide synthase acyl carrier protein.

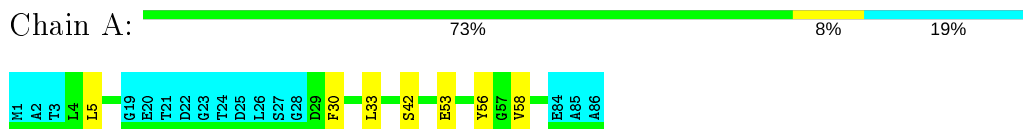

4 Residue-property plots

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

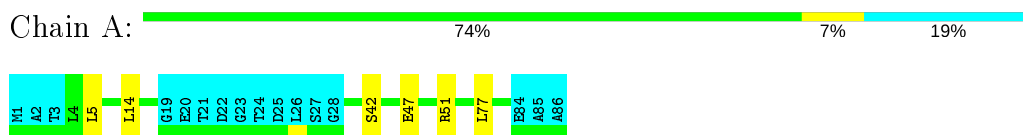
- Molecule 1: Actinorhodin polyketide synthase acyl carrier protein

5 Refinement protocol and experimental data overview

The models were refined using the following method: *simulated annealing*.

Of the 100 calculated structures, 20 were deposited, based on the following criterion: *structures with the lowest energy*.

5.1 Too-close contacts

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in each chain respectively. The H(added) column lists the number of hydrogen atoms added and optimized by MolProbity. The Clashes column lists the number of clashes averaged over the ensemble.

A bond length with $|Z| > 2$ is considered an outlier worth inspection. RMSZ is the average root-mean-square of all Z scores of the bond lengths.

In the following table, the Counts columns list the number of angles for which Mogul statistics could be retrieved, the number of angles that are observed in the model and the number of angles that are defined in the chemical component dictionary. The Link column lists molecule types, if any, to which the group is linked. The Z score for a bond angle is the number of standard deviations the observed value is removed from the expected value. A bond angle with $|Z| > 2$ is considered an outlier worth inspection. RMSZ is the average root-mean-square of all Z scores of the bond angles.

In the following table, the Chirals column lists the number of chiral outliers, the number of chiral centers analysed, the number of these observed in the model and the number defined in the chemical component dictionary. 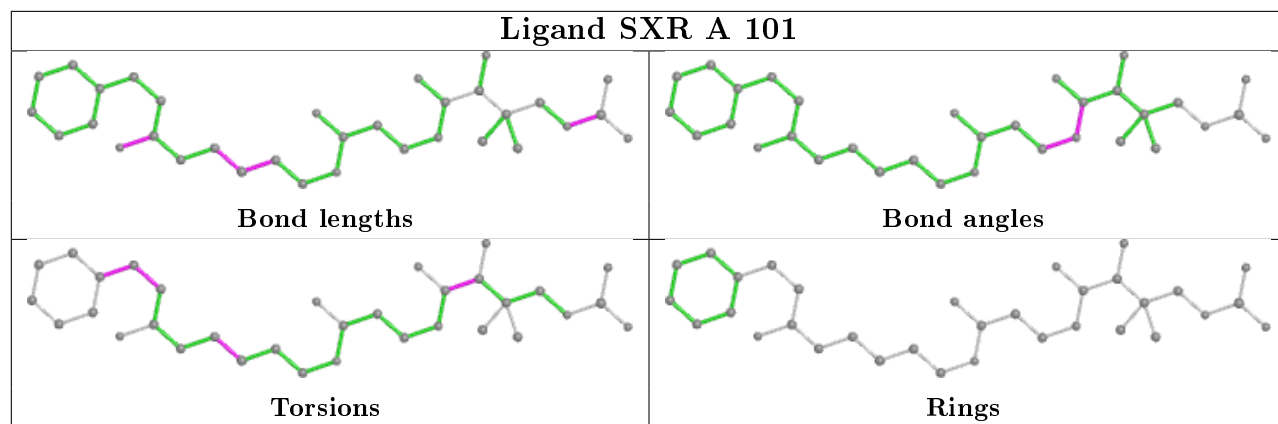

The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. In addition, ligands with molecular weight > 250 and outliers as shown on the validation Tables will also be included. For torsion angles, if less than 5% of the Mogul distribution of torsion angles is within 10 degrees of the torsion angle in question, then that torsion angle is considered an outlier. Any bond that is central to one or more torsion angles identified as an outlier by Mogul will be highlighted in the graph. For rings, the root-mean-square deviation (RMSD) between the ring in question and similar rings identified by Mogul is calculated over all ring torsion angles. If the average RMSD is greater than 60 degrees and the minimal RMSD between the ring in question and any Mogul-identified rings is also greater than 60 degrees, then that ring is considered an outlier. The outliers are highlighted in purple. The color gray indicates Mogul did not find sufficient equivalents in the CSD to analyse the geometry.

6 Chemical shift validation [i](#)

The completeness of assignment taking into account all chemical shift lists is 91% for the well-defined parts and 89% for the entire structure.

6.1.3 Completeness of resonance assignments [i](#)

The following table shows the completeness of the chemical shift assignments for the well-defined regions of the structure. The overall completeness is 91%, i.e. 761 atoms were assigned a chemical shift out of a possible 838. 1 out of 17 assigned methyl groups (LEU and VAL) were assigned stereospecifically.

6.1.4 Statistically unusual chemical shifts [i](#)

There are no statistically unusual chemical shifts.

6.1.5 Random Coil Index (RCI) plots [i](#)

The image below reports *random coil index* values for the protein chains in the structure. The height of each bar gives a probability of a given residue to be disordered, as predicted from the available chemical shifts and the amino acid sequence. A value above 0.2 is an indication of significant predicted disorder. The colour of the bar shows whether the residue is in the well-defined core (black) or in the ill-defined residue ranges (cyan), as described in section 2 on ensemble composition.
