• Molecule 1 is a protein called Acetylcholinesterase.





Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 2.23% of the height of the origin peak. No significant pseudotranslation is detected.









The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for oligosaccharide.
