

1 Overall quality at a glance (i)

2 Entry composition (i)

There are 3 unique types of molecules in this entry. The entry contains 1802 atoms, of which 0 are hydrogens and 0 are deuteriums.

3 Residue-property plots (i)

These plots are drawn for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic for a chain summarises the proportions of the various outlier classes displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.

Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 7.98% of the height of the origin peak. No significant pseudotranslation is detected.

²Theoretical values of $\langle |L| \rangle$, $\langle L^2 \rangle$ for acentric reflections are 0.5, 0.333 respectively for untwinned datasets, and 0.375, 0.2 for perfectly twinned datasets.

5.1 Standard geometry (i)

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

5.2 Too-close contacts (i)
