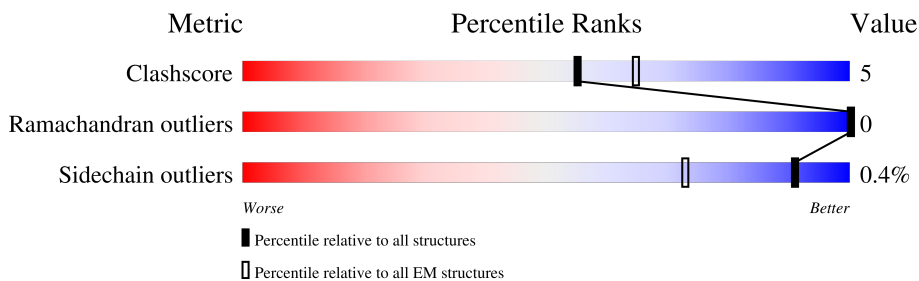
1 Overall quality at a glance

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.



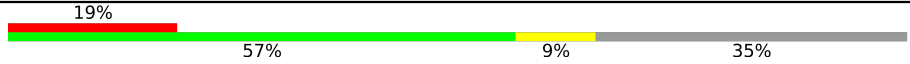
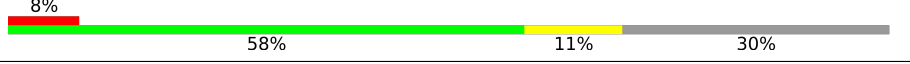


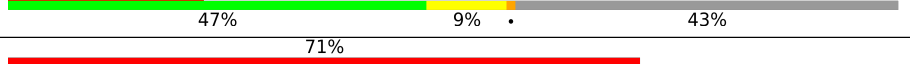
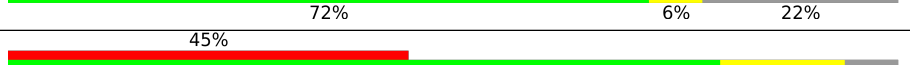

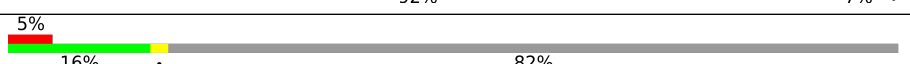

The table below summarises the geometric issues observed across the polymeric chains and their fit to the map. The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

• Molecule 5: Inner kinetochore subunit MCM22

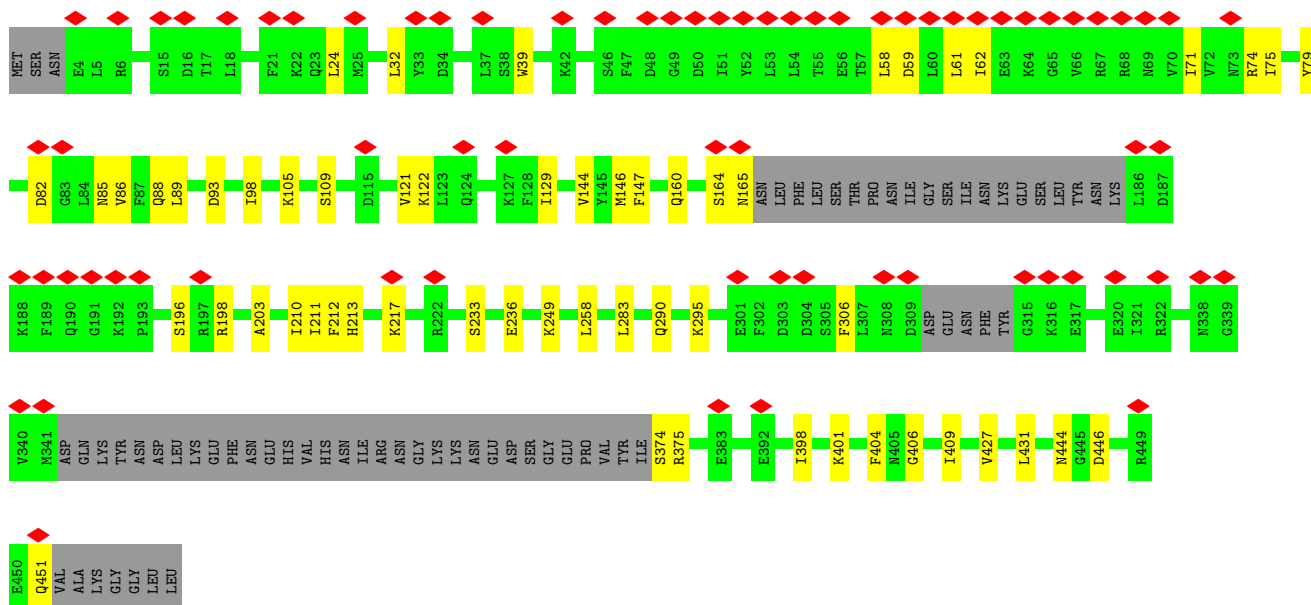
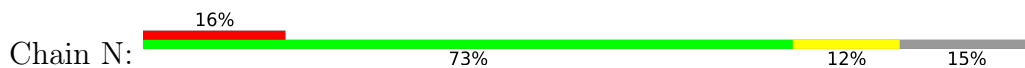


• Molecule 6: Inner kinetochore subunit IML3

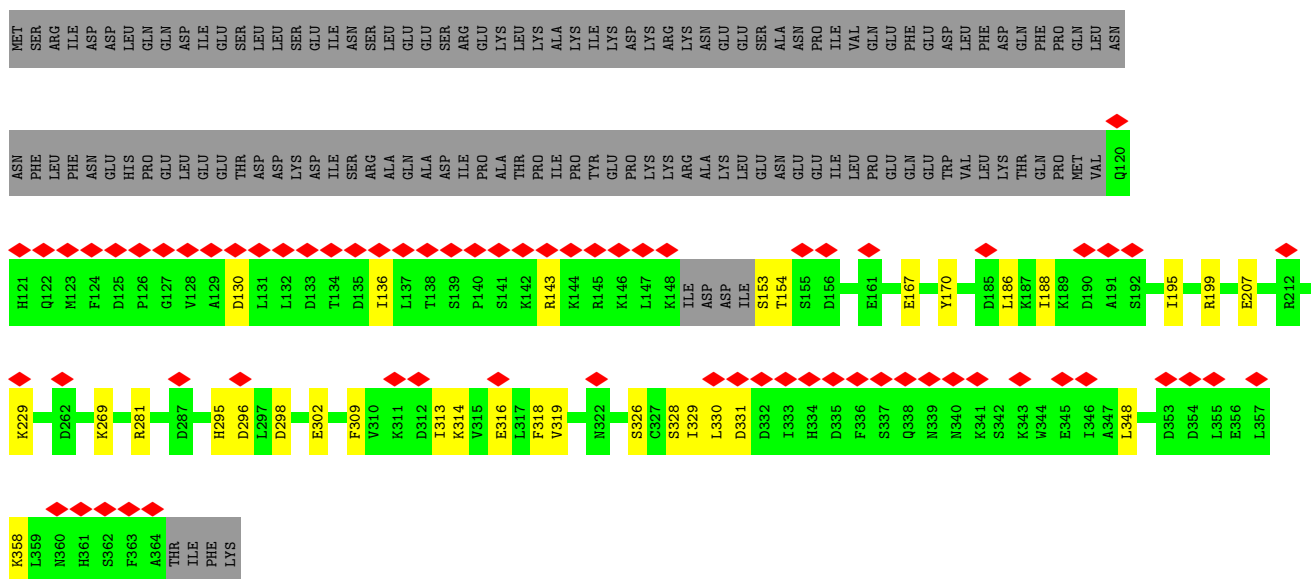




• Molecule 7: Inner kinetochore subunit CHL4

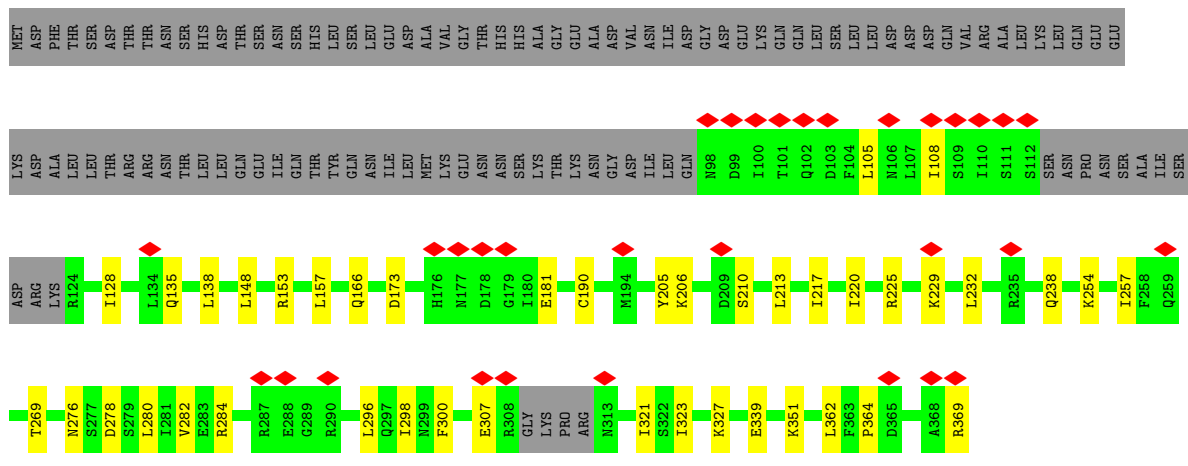


• Molecule 8: Inner kinetochore subunit MCM21

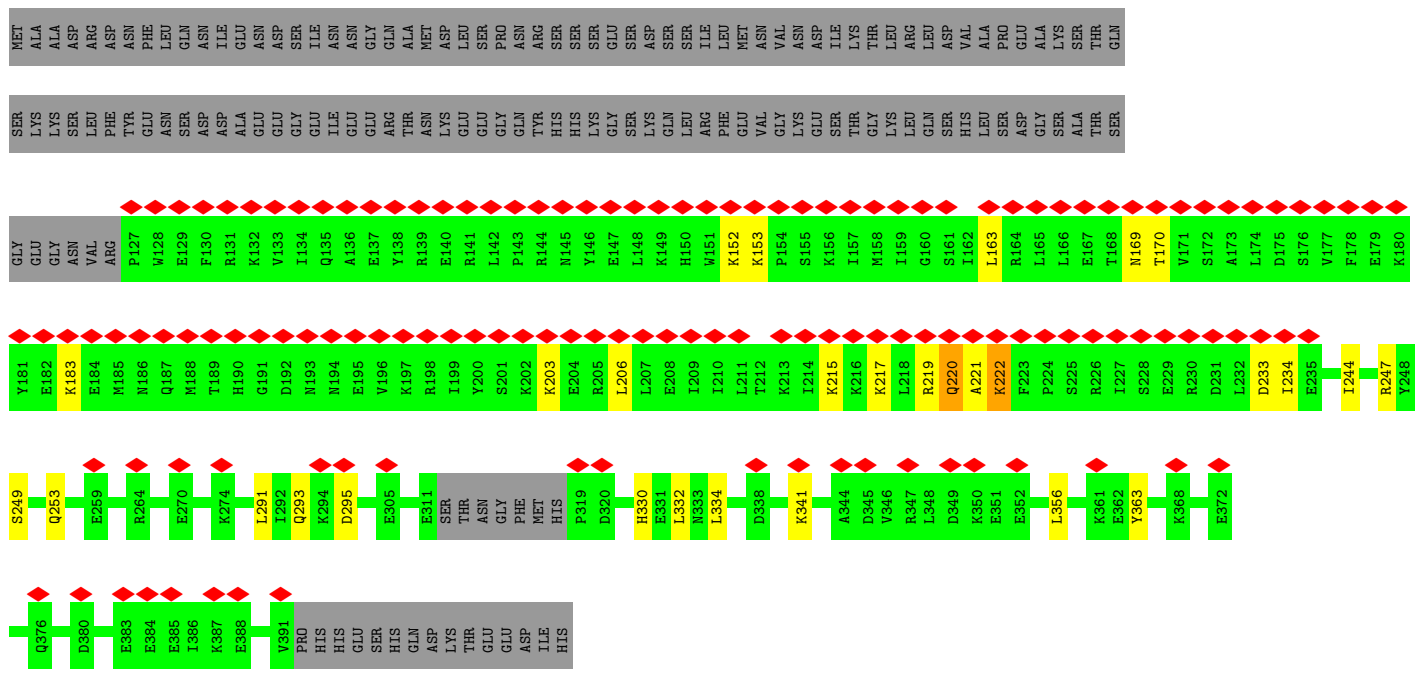


• Molecule 9: Inner kinetochore subunit CTF19

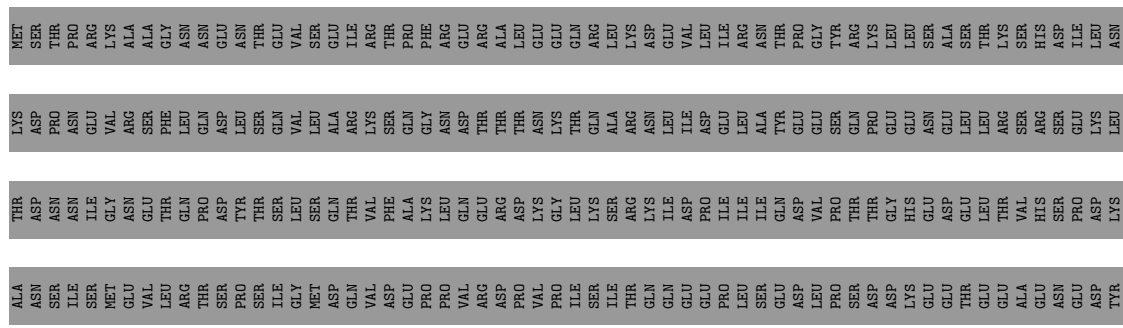




● Molecule 10: Inner kinetochore subunit OKP1



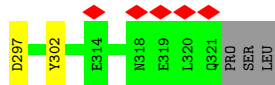
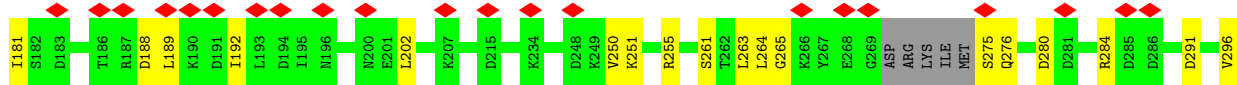
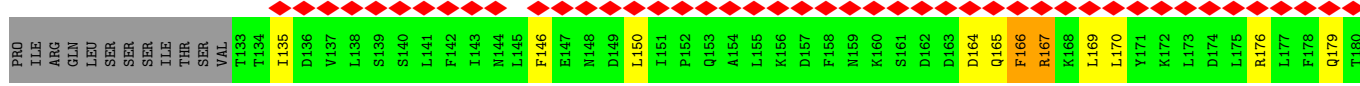
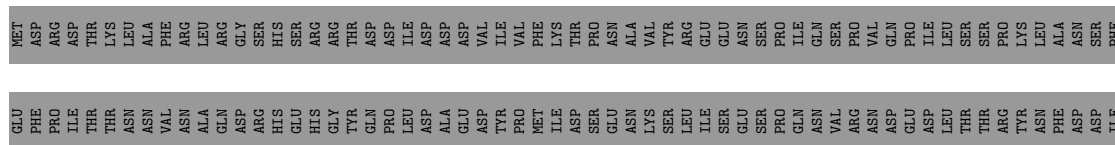

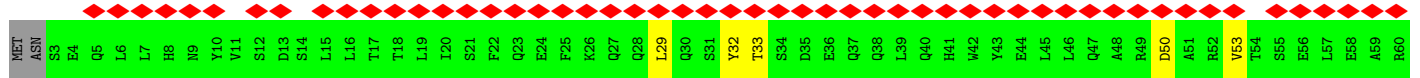
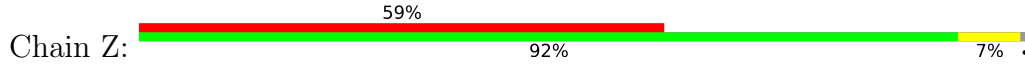


• Molecule 14: Inner kinetochore subunit NKP1

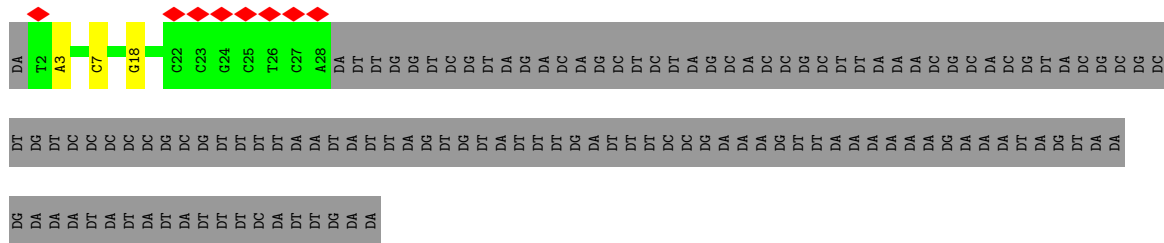

5.1 Standard geometry [i](#)

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

Chiral center outliers are detected by calculating the chiral volume of a chiral center and verifying if the center is modelled as a planar moiety or with the opposite hand. A planarity outlier is detected by checking planarity of atoms in a peptide group, atoms in a mainchain group or atoms of a sidechain that are expected to be planar.

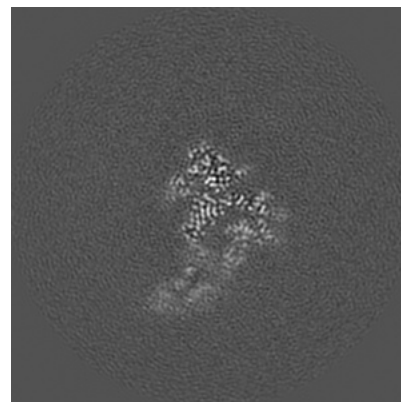

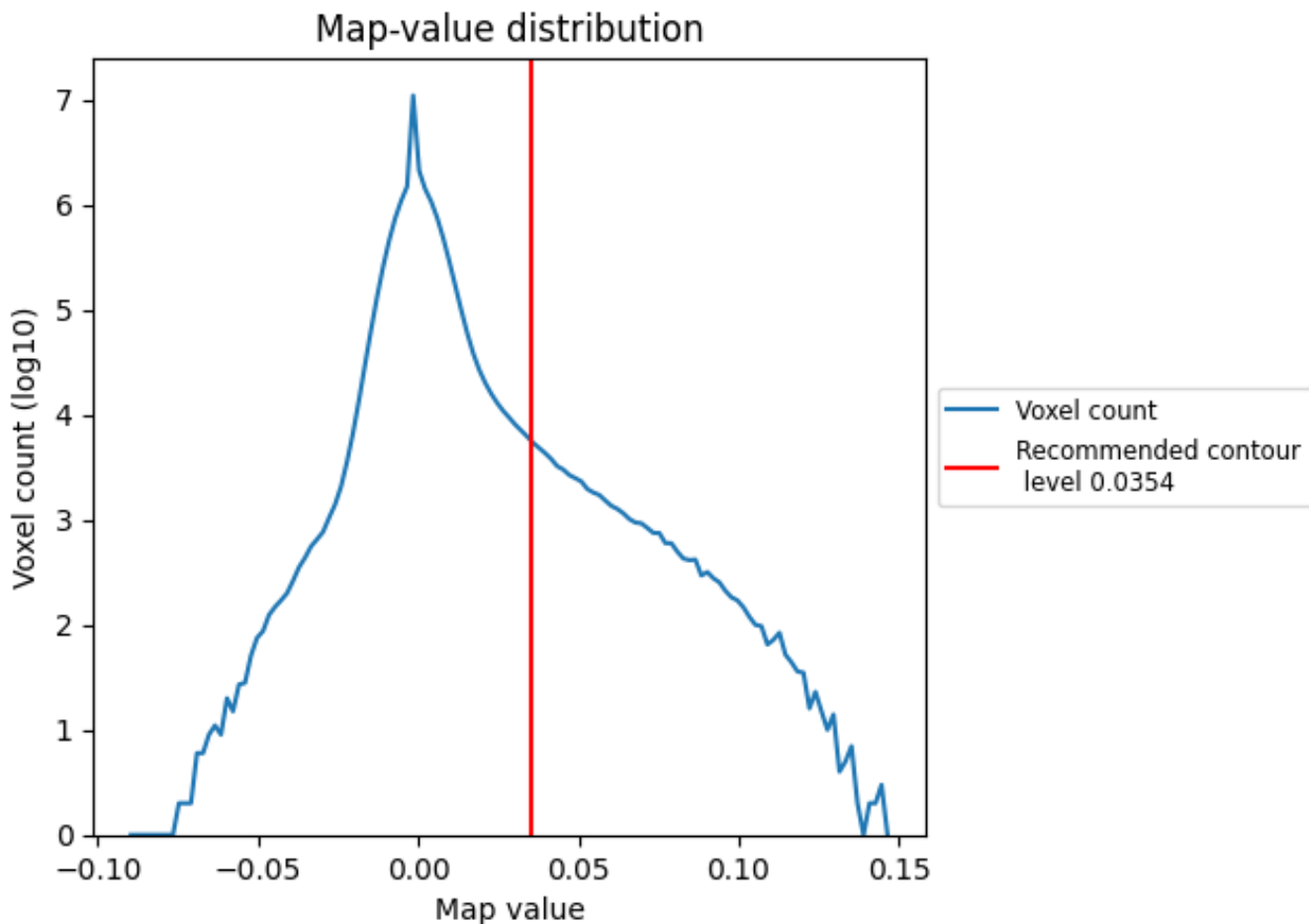

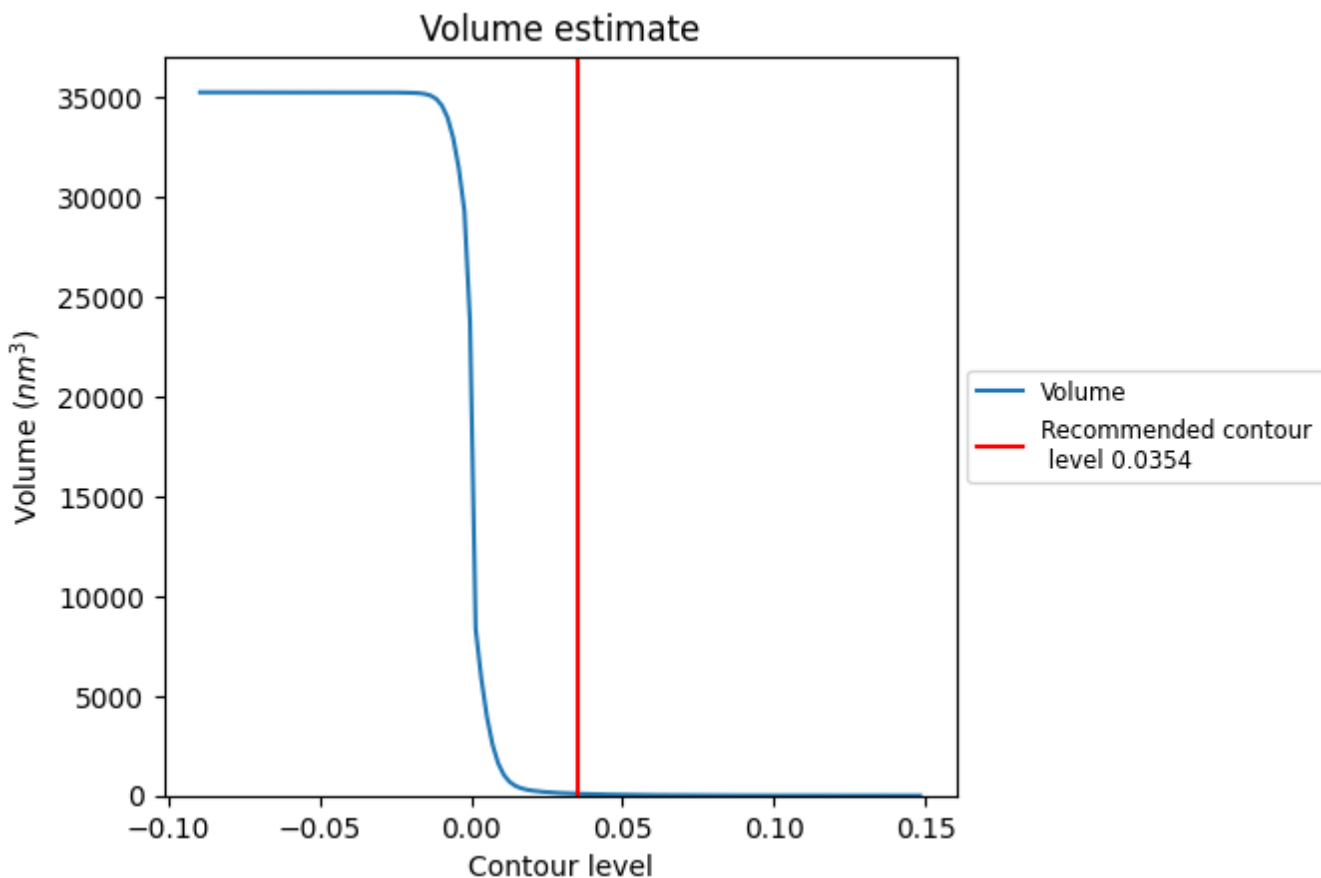

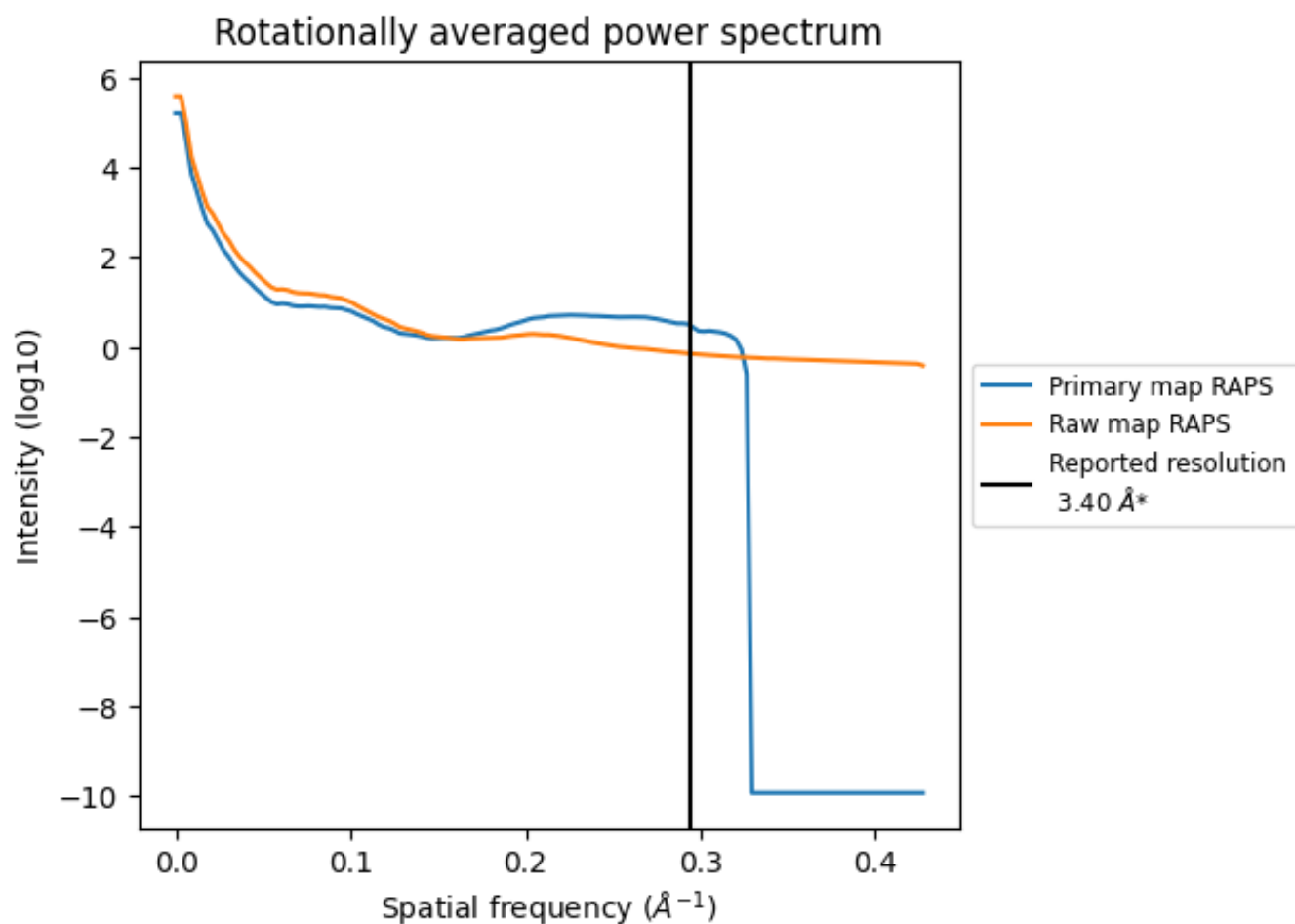

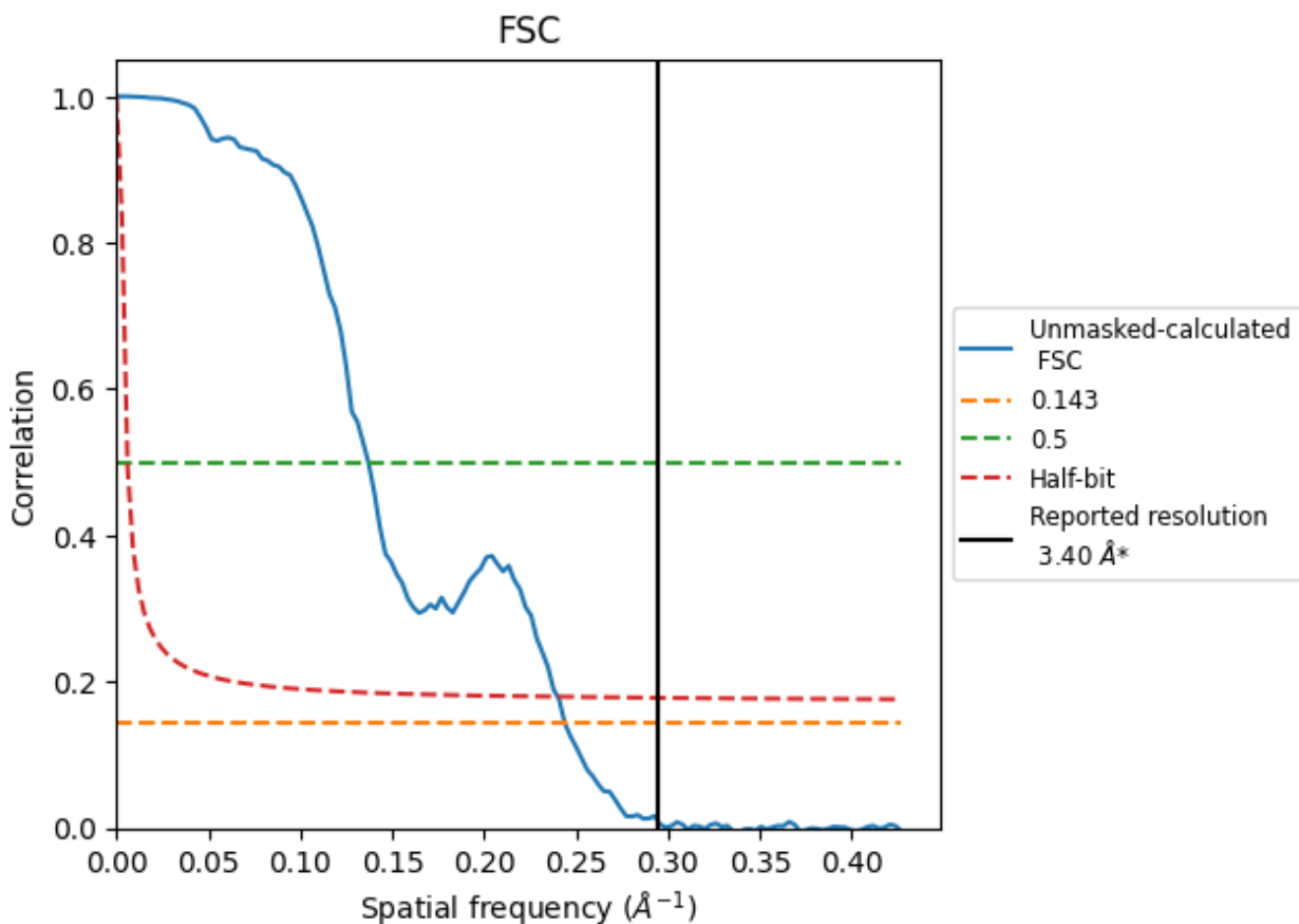

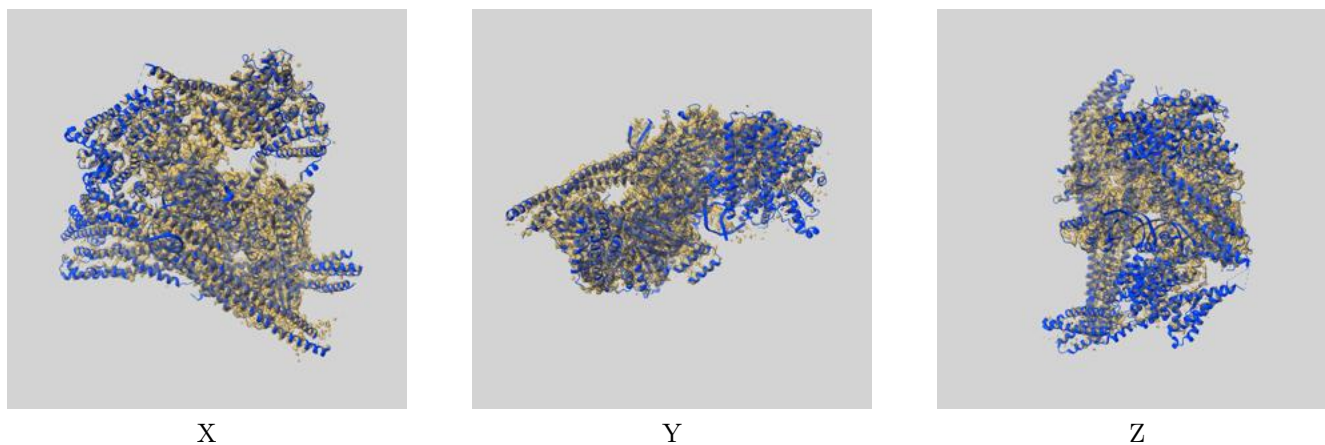

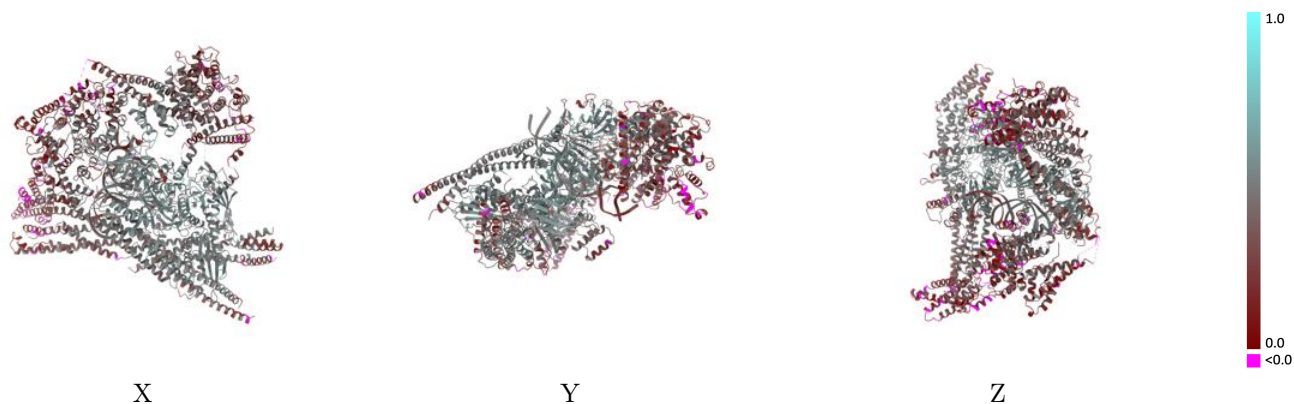

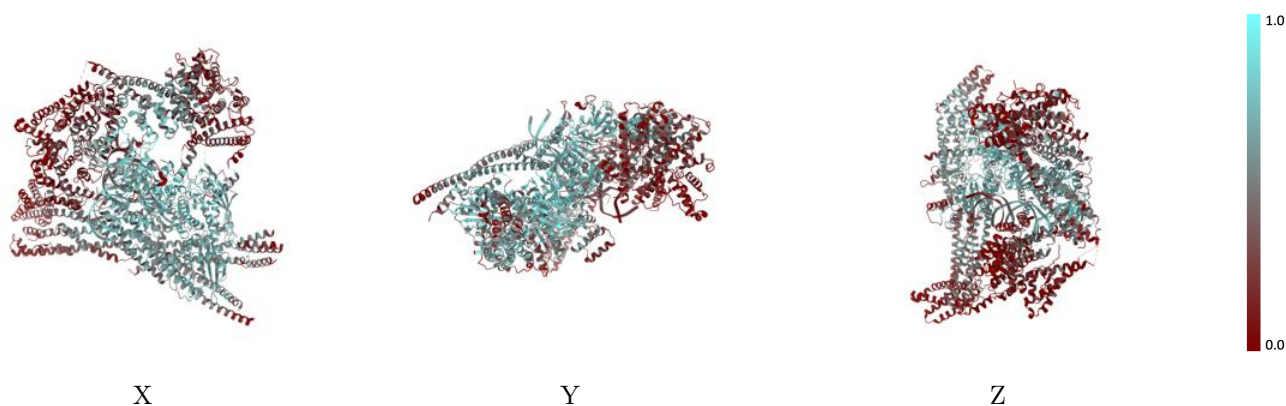

9.2 Q-score mapped to coordinate model [\(i\)](#)



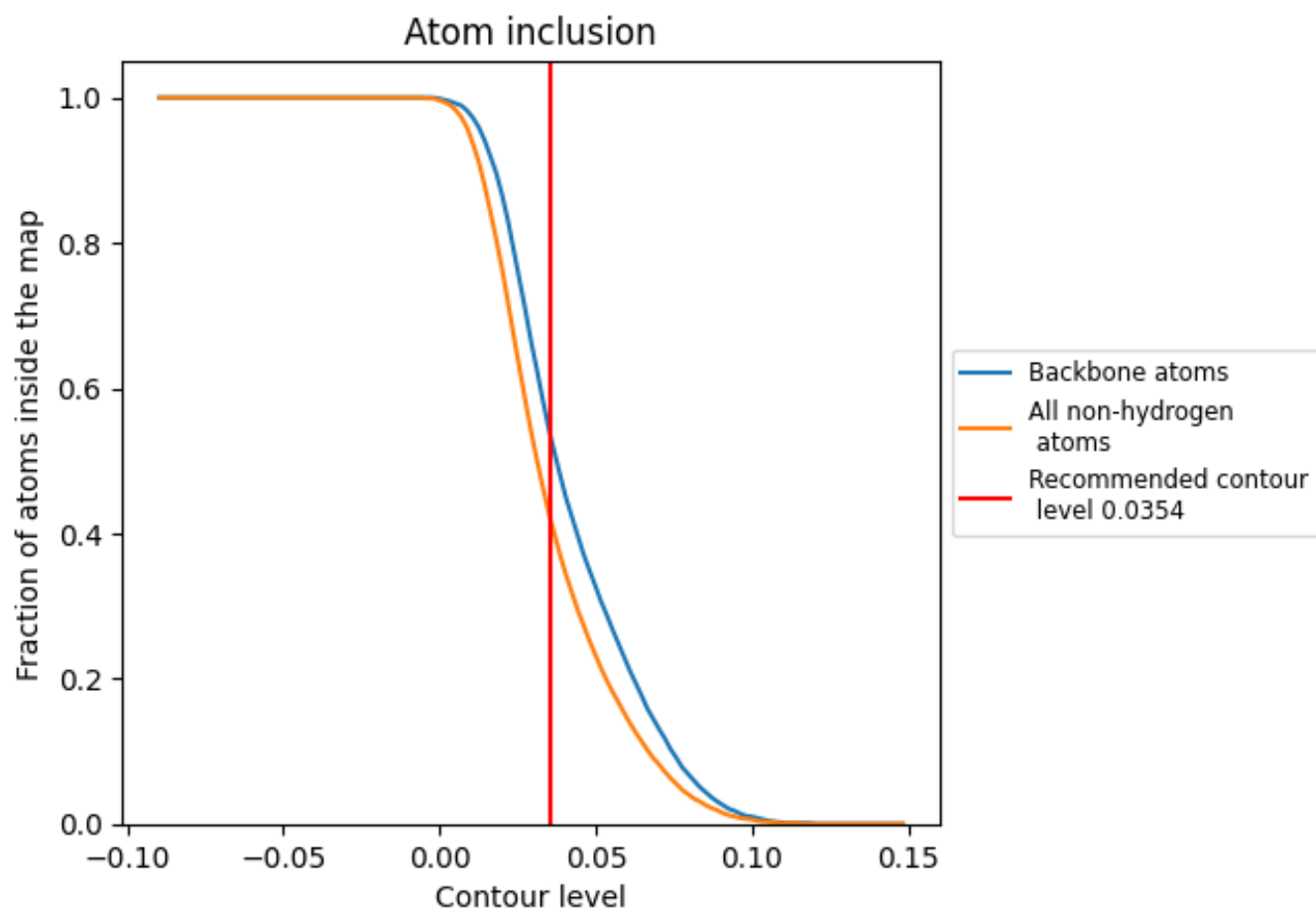

Low Q-score values may therefore be expected for many entries.

9.3 Atom inclusion mapped to coordinate model [\(i\)](#)



The images above show the model with each residue coloured according to its atom inclusion. This shows to what extent they are inside the map at the recommended contour level (0.0354).





































9.4 Atom inclusion [i](#)



At the recommended contour level, 54% of all backbone atoms, 42% of all non-hydrogen atoms, are inside the map.
