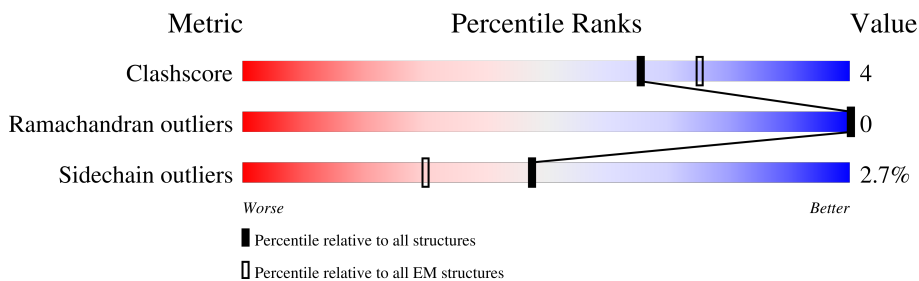
1 Overall quality at a glance i










The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

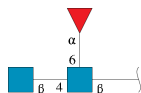
There are 8 unique types of molecules in this entry. The entry contains 9582 atoms, of which 0 are hydrogens and 0 are deuteriums.

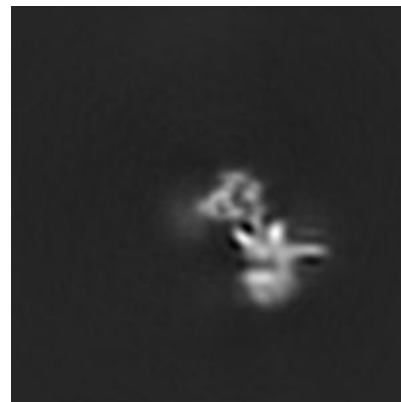

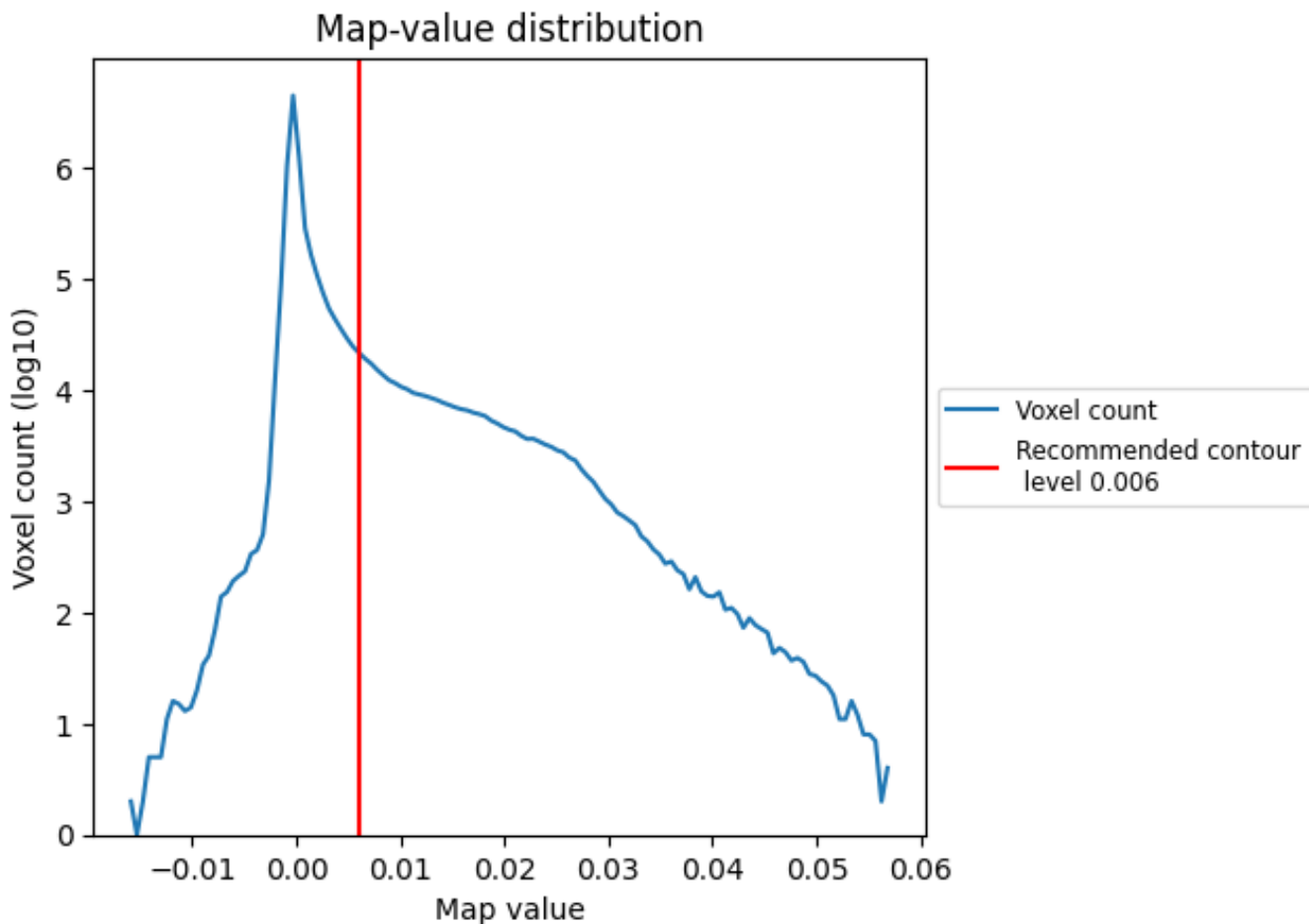

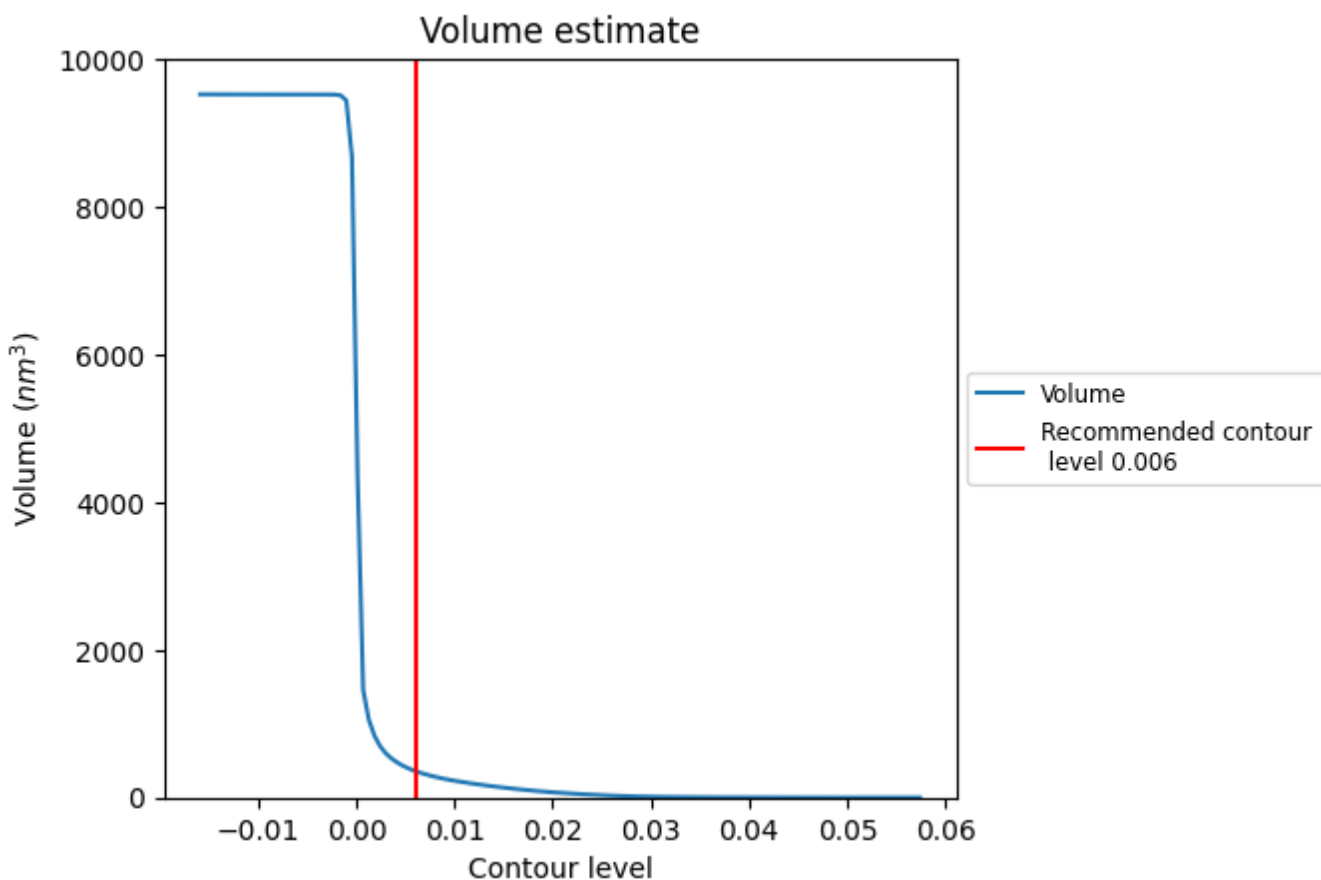

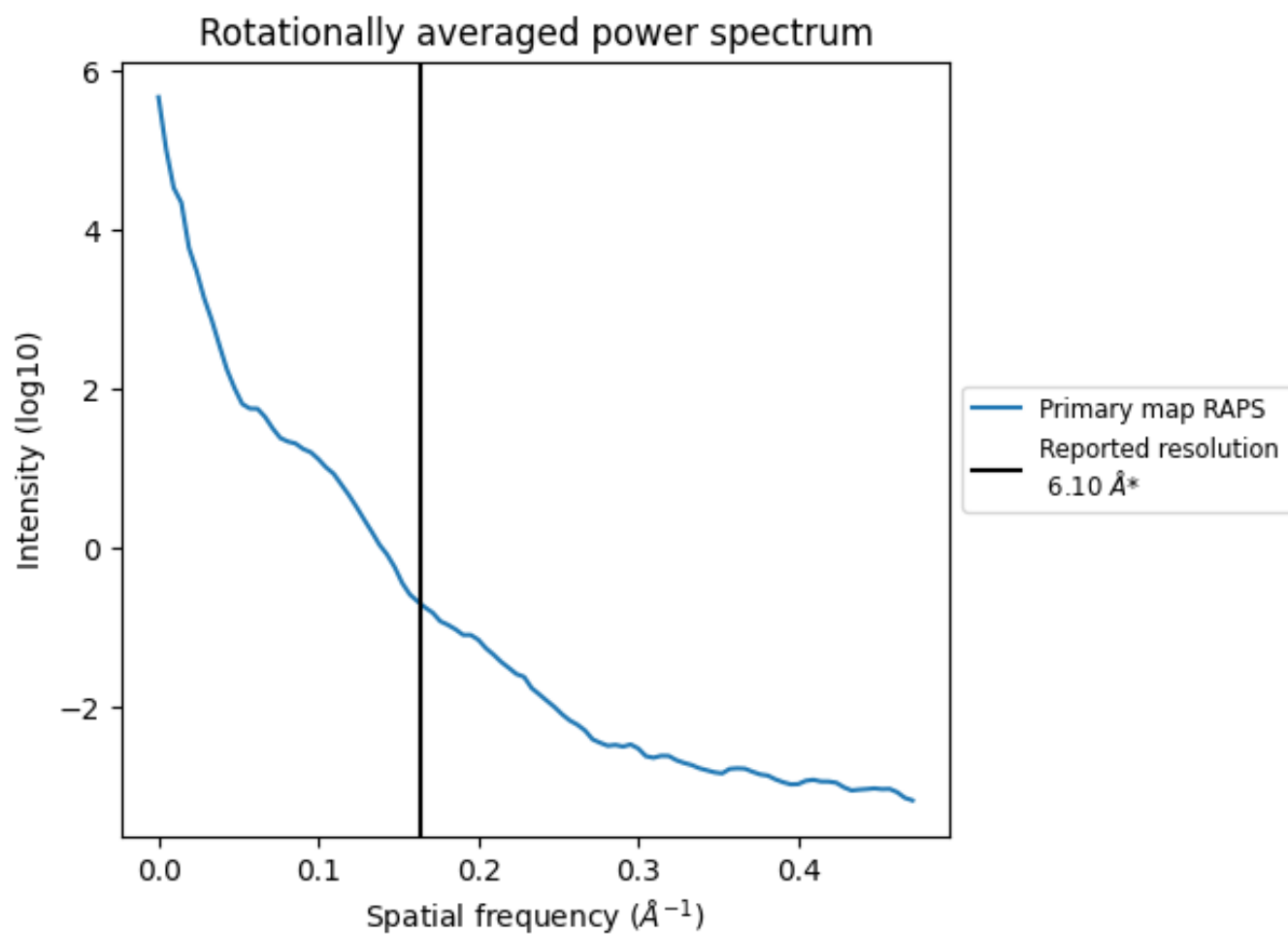

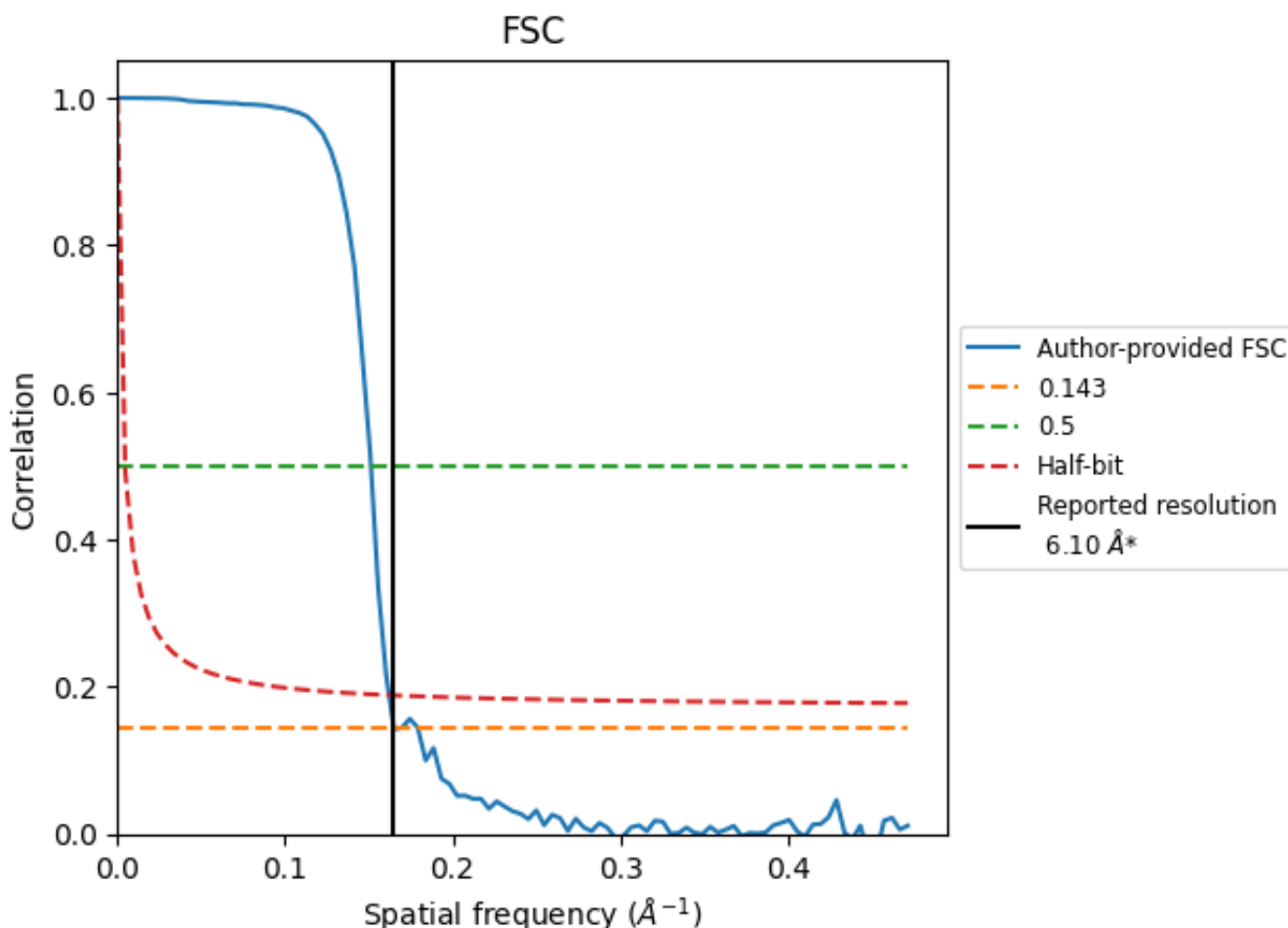

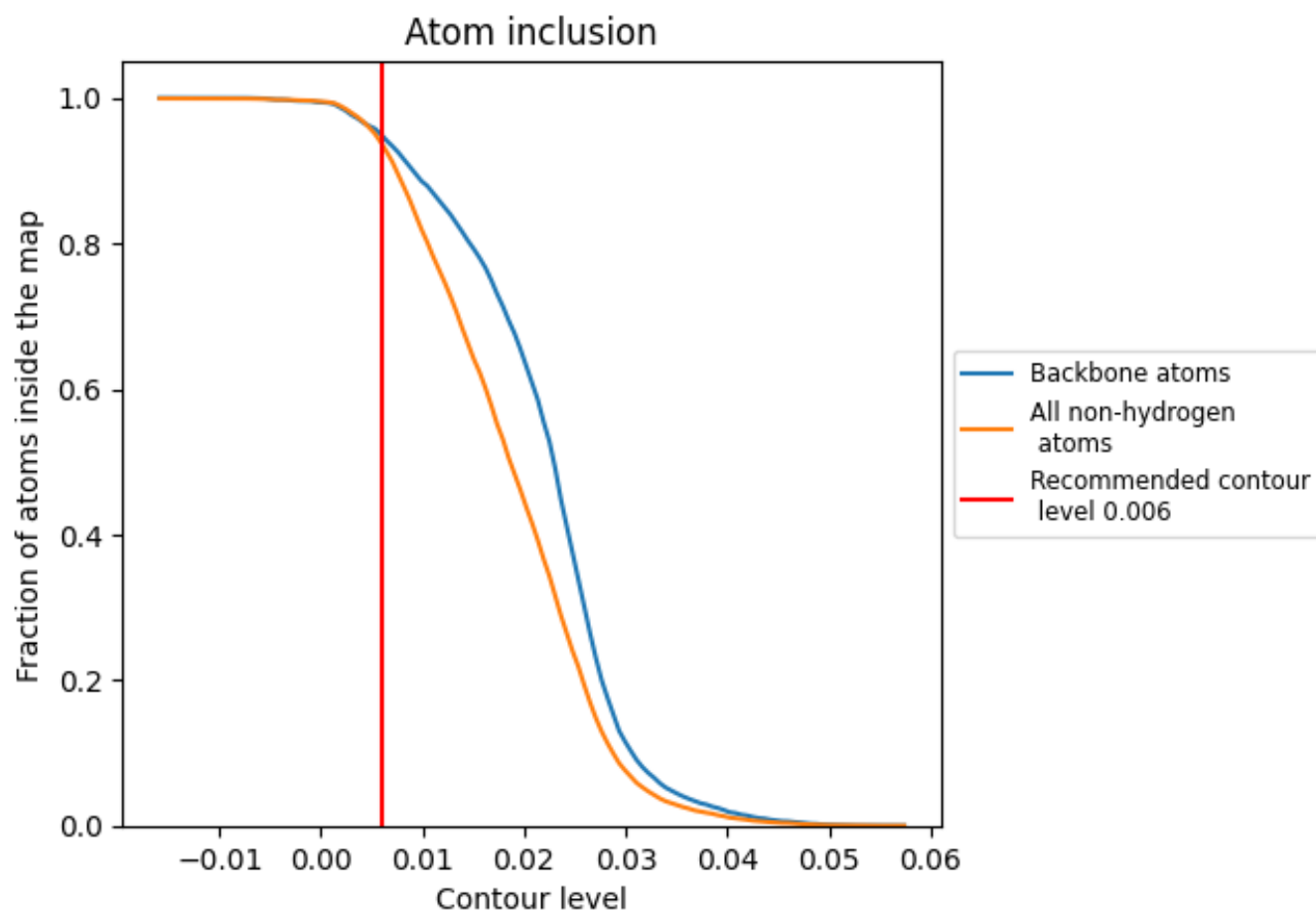
