

2 Entry composition (i)



Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 3.15% of the height of the origin peak. No significant pseudotranslation is detected.

²Theoretical values of $\langle |L| \rangle$, $\langle L^2 \rangle$ for acentric reflections are 0.5, 0.333 respectively for untwinned datasets, and 0.375, 0.2 for perfectly twinned datasets.

A bond length (or angle) with |Z| > 2 is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).


