

# 1 Overall quality at a glance (i)

## 2 Entry composition (i)

There are 5 unique types of molecules in this entry. The entry contains 2102 atoms, of which 0 are hydrogens and 0 are deuteriums.



Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 2.90% of the height of the origin peak. No significant pseudotranslation is detected.



The following is a graphical depiction of the model fit to experimental electron density of all instances of the Ligand of Interest. In addition, ligands with molecular weight > 250 and outliers as shown on the geometry validation Tables will also be included.
