

1 Overall quality at a glance (i)







Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 9.03% of the height of the origin peak. No significant pseudotranslation is detected.



The following is a graphical depiction of the model fit to experimental electron density of all instances of the Ligand of Interest. In addition, ligands with molecular weight > 250 and outliers as shown on the geometry validation Tables will also be included. Each fit is shown from different orientation to approximate a three-dimensional view.
