

1 Overall quality at a glance (i)

The following experimental techniques were used to determine the structure: $SOLUTION\ NMR$

The overall completeness of chemical shifts assignment was not calculated.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for >=3, 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions <=5%

2 Ensemble composition and analysis (i)

This entry contains 20 models. Model 12 is the overall representative, medoid model (most similar to other models). The authors have identified model 1 as representative, based on the following criterion: similarity to average, few violations, and low energy.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

The models can be grouped into 4 clusters and 1 single-model cluster was found.

3 Entry composition (i)

There is only 1 type of molecule in this entry. The entry contains 1603 atoms, of which 785 are hydrogens and 0 are deuteriums.

• Molecule 1 is a protein called conserved hypothetical protein.




4 Residue-property plots (i)

4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.


• Molecule 1: conserved hypothetical protein

5 Refinement protocol and experimental data overview (i)



The models were refined using the following method: automated generation of initial distance restraint set distance geometry simulated annealing final refinement in explicit solvent.

Of the 30 calculated structures, 20 were deposited, based on the following criterion: structures with fewest restraint violations and lowest energy.

The following table shows the software used for structure solution, optimisation and refinement.

6.1 Standard geometry (i)

There are no covalent bond-length or bond-angle outliers.

6.2 Too-close contacts (i)

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in each chain respectively. The H(added) column lists the number of hydrogen atoms added and optimized by MolProbity. The Clashes column lists the number of clashes averaged over the ensemble.

The all-atom clashscore is defined as the number of clashes found per 1000 atoms (including hydrogen atoms). The all-atom clashscore for this structure is 4.

6.3.1 Protein backbone (i)

In the following table, the Percentiles column shows the percent Ramachandran outliers of the chain as a percentile score with respect to all PDB entries followed by that with respect to all NMR entries. The Analysed column shows the number of residues for which the backbone conformation was analysed and the total number of residues.

The Analysed column shows the number of residues for which the sidechain conformation was analysed and the total number of residues.
