# 2 Ensemble composition and analysis (i)

This entry contains 10 models. This entry does not contain polypeptide chains, therefore identification of well-defined residues and clustering analysis are not possible. All residues are included in the validation scores.



# 3 Entry composition (i)

There are 2 unique types of molecules in this entry. The entry contains 755 atoms, of which 269 are hydrogens and 0 are deuteriums.

# 4 Residue-property plots (i)

## 4.1 Average score per residue in the NMR ensemble

These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

# 5 Refinement protocol and experimental data overview (i)

The models were refined using the following method: *simulated annealing*.

Of the 256 calculated structures, 10 were deposited, based on the following criterion: structures with the least restraint violations.

# 6.1 Standard geometry (i)

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with |Z| > 5 is considered an outlier worth inspection. RMSZ is the (average) root-mean-square of all Z scores of the bond lengths (or angles).

#### 7.1.3 Completeness of resonance assignments (i)

The overall completeness is 54%, i.e. 258 atoms were assigned a chemical shift out of a possible 477. 0 out of 0 assigned methyl groups (LEU and VAL) were assigned stereospecifically.








