1 Overall quality at a glance (i)

• Molecule 1 is a protein called Alpha-(1,6)-fucosyltransferase.



Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 5.01% of the height of the origin peak. No significant pseudotranslation is detected.
