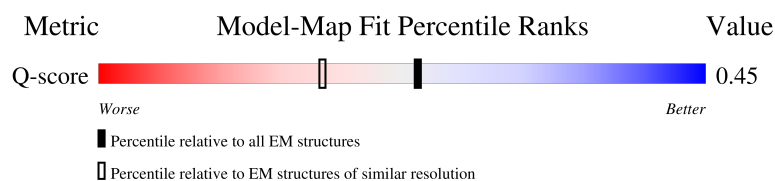
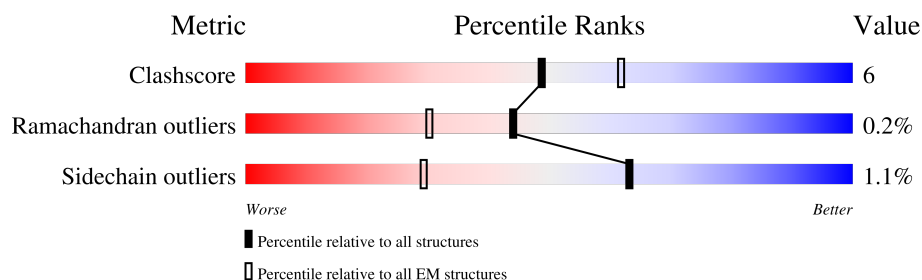

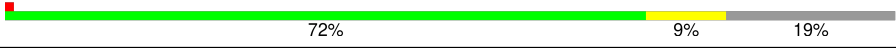

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

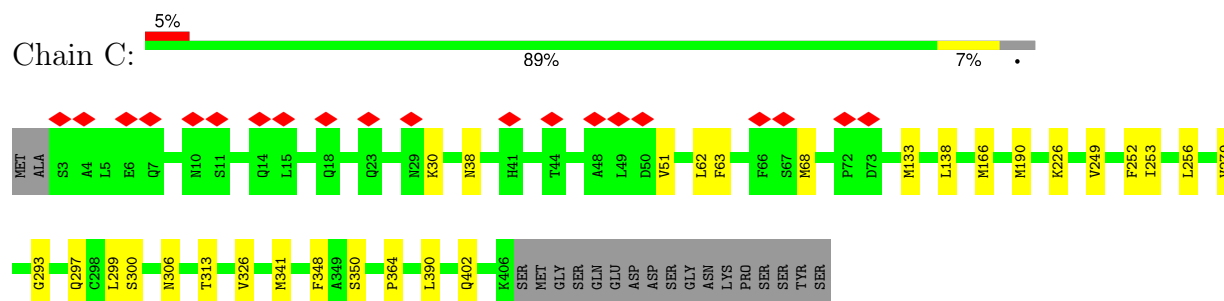

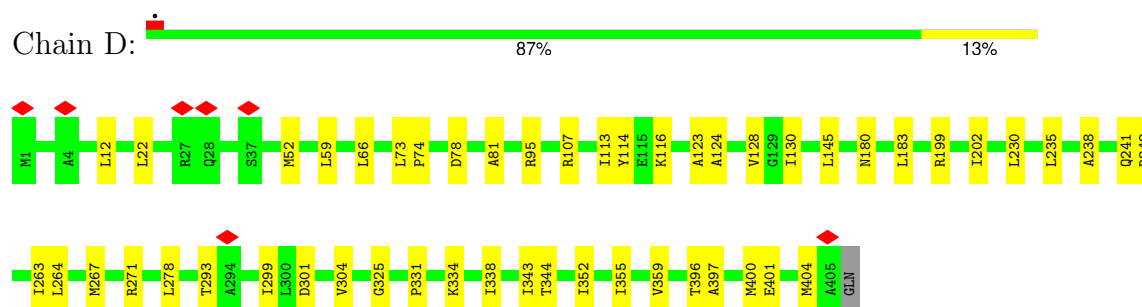

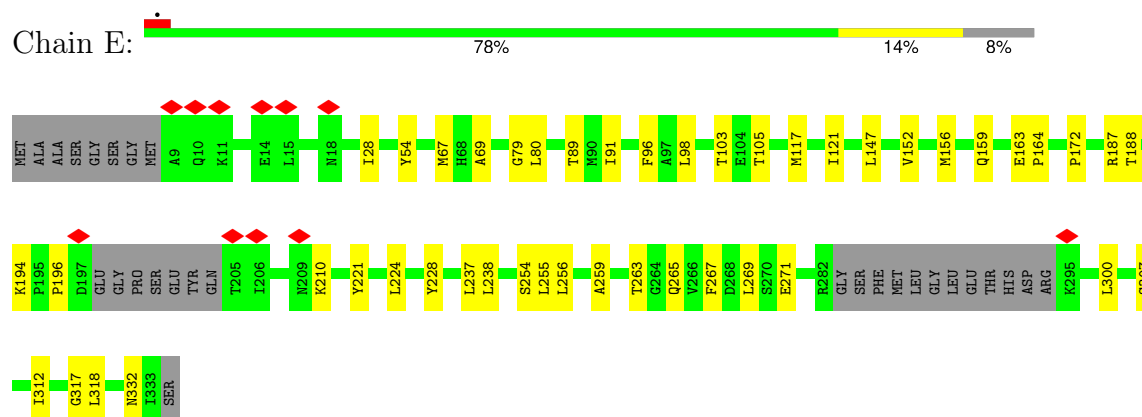
• Molecule 3: COP9 signalosome complex subunit 3



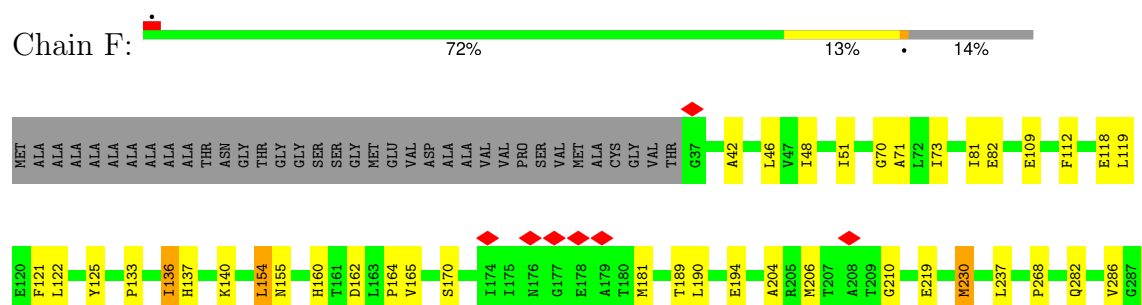
• Molecule 4: COP9 signalosome complex subunit 4

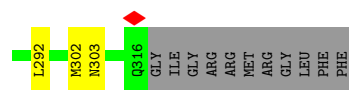


• Molecule 5: COP9 signalosome complex subunit 5

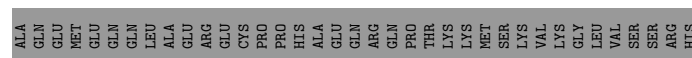


• Molecule 6: COP9 signalosome complex subunit 6

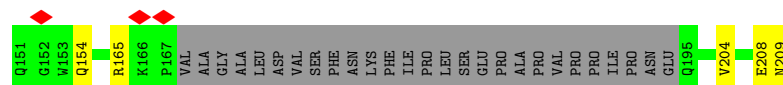




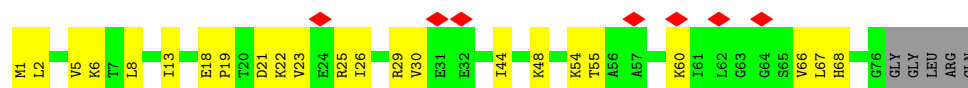

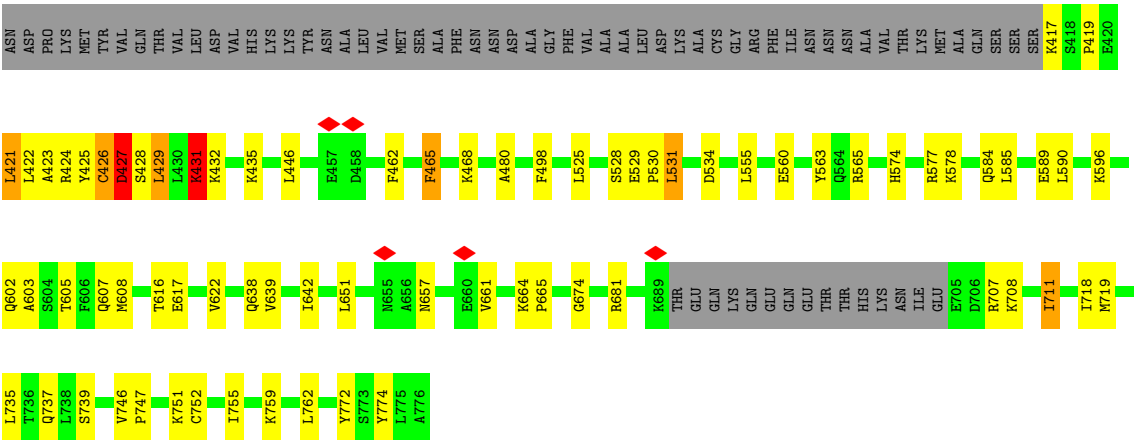


• Molecule 9: NEDD8

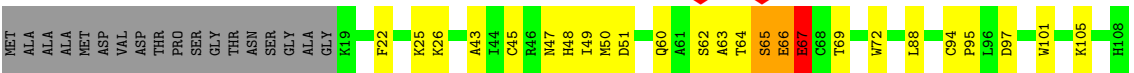


• Molecule 10: Cullin-1

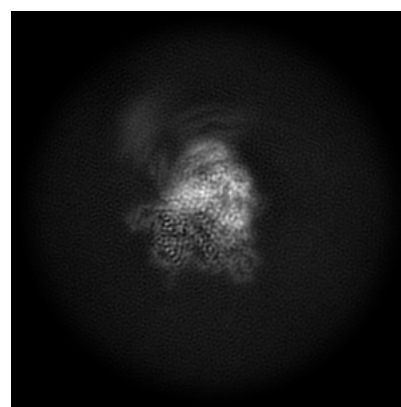

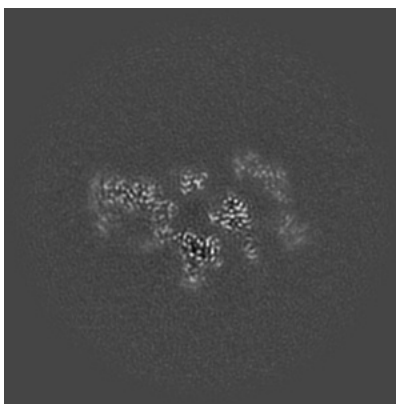

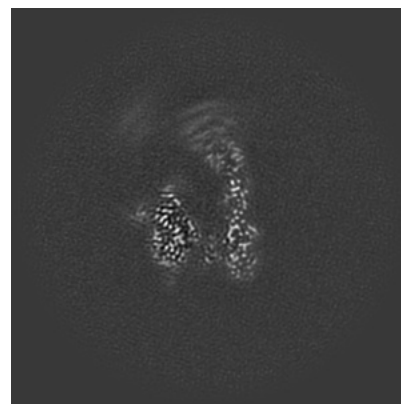

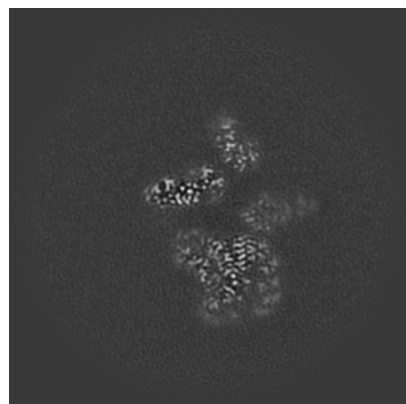

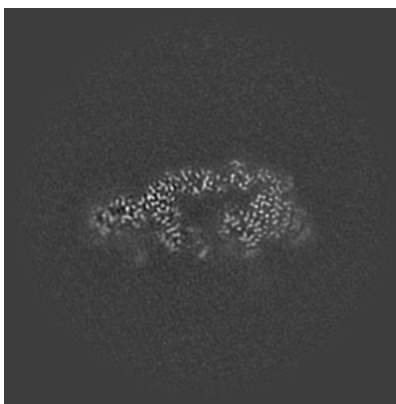
The images above show central slices of the map in three orthogonal directions.

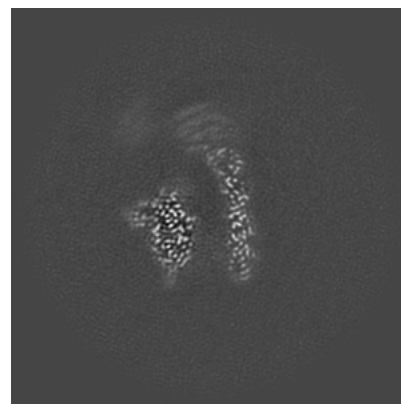

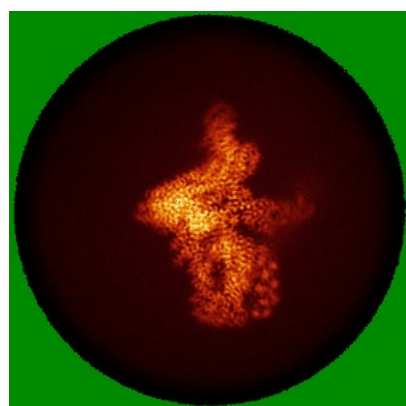

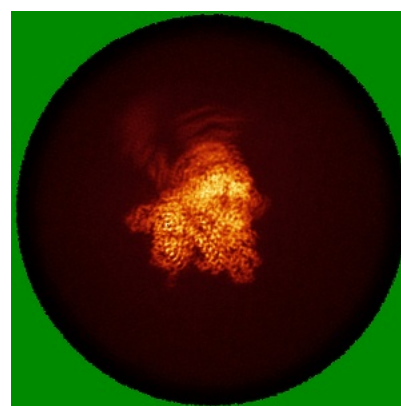

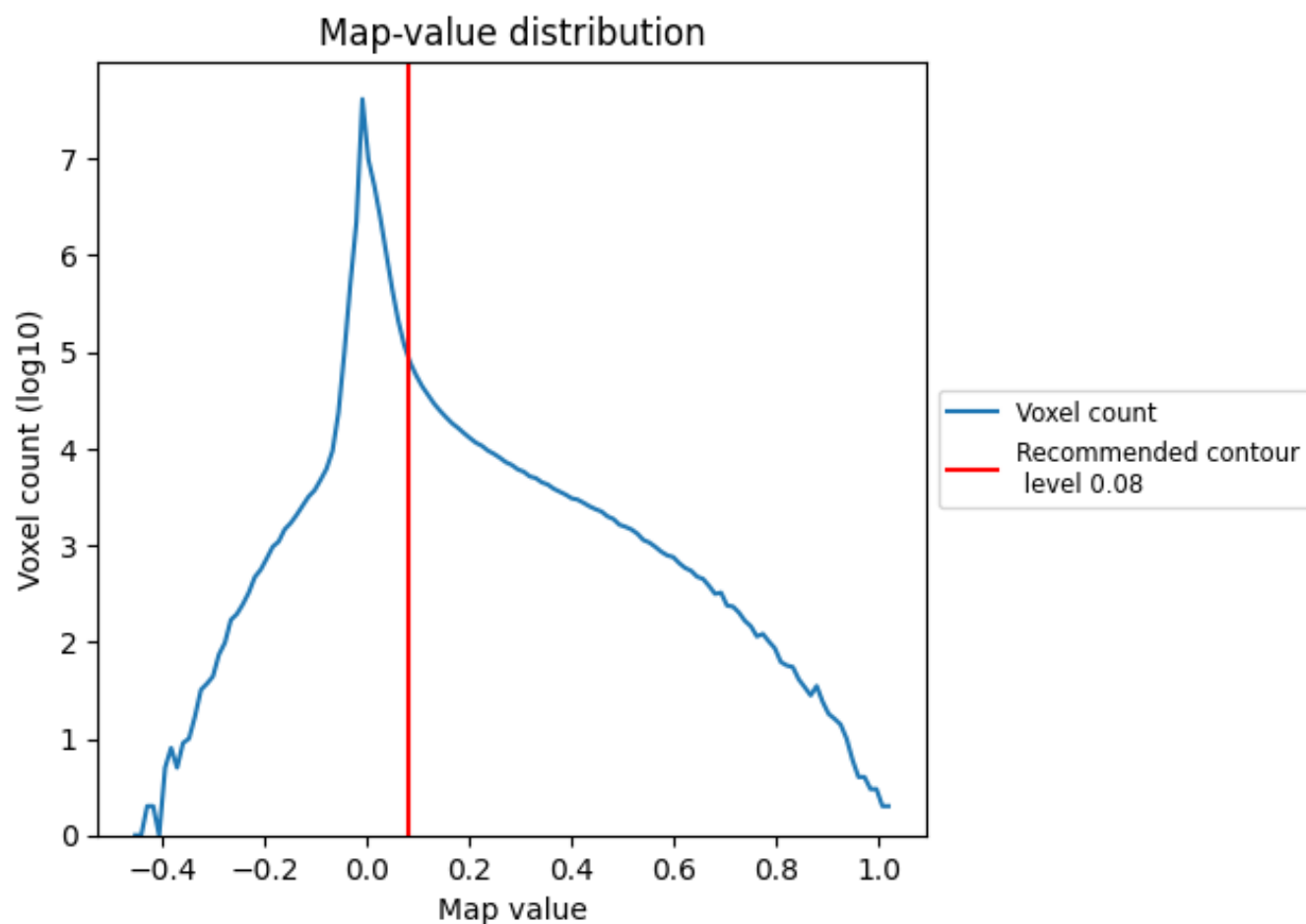

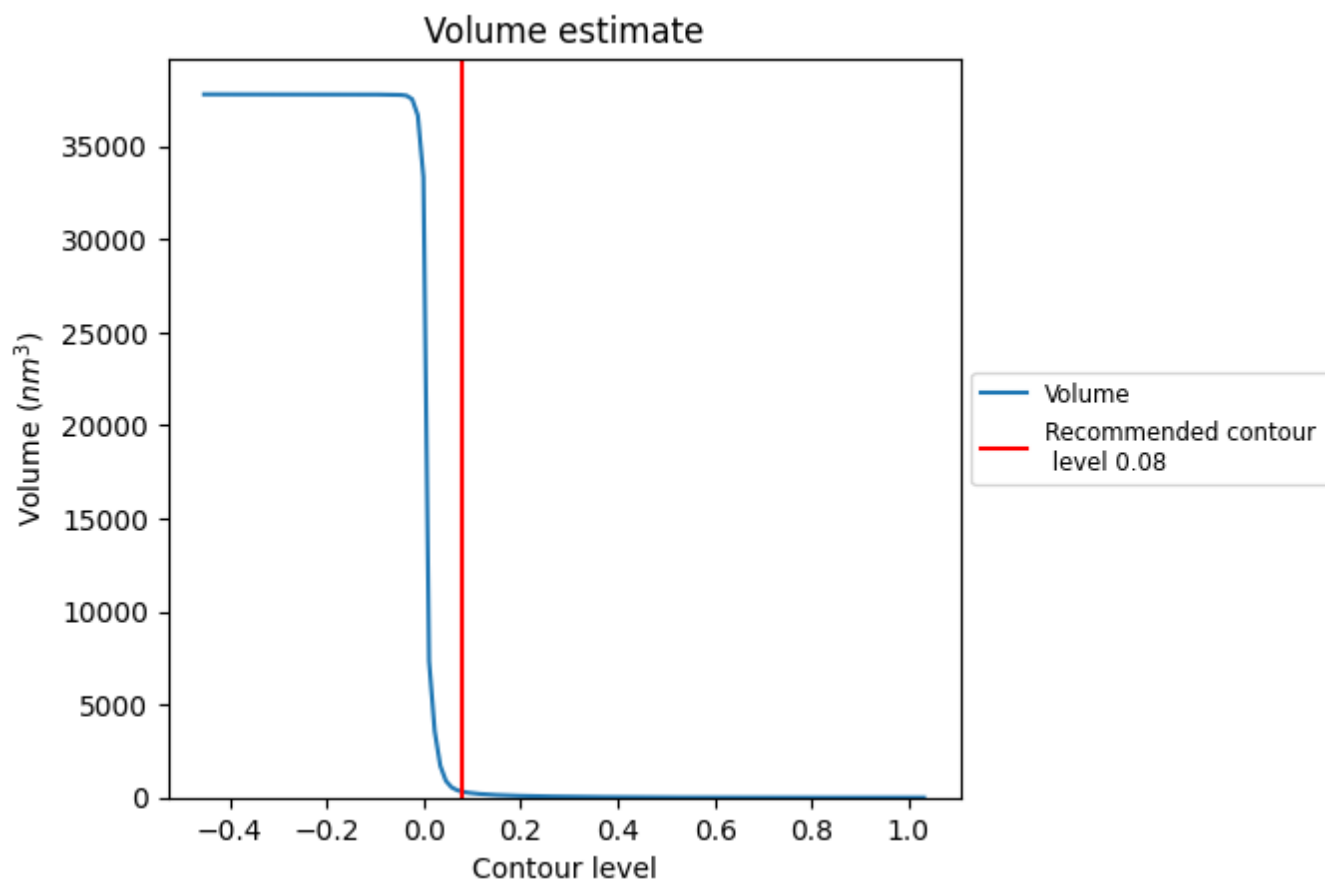

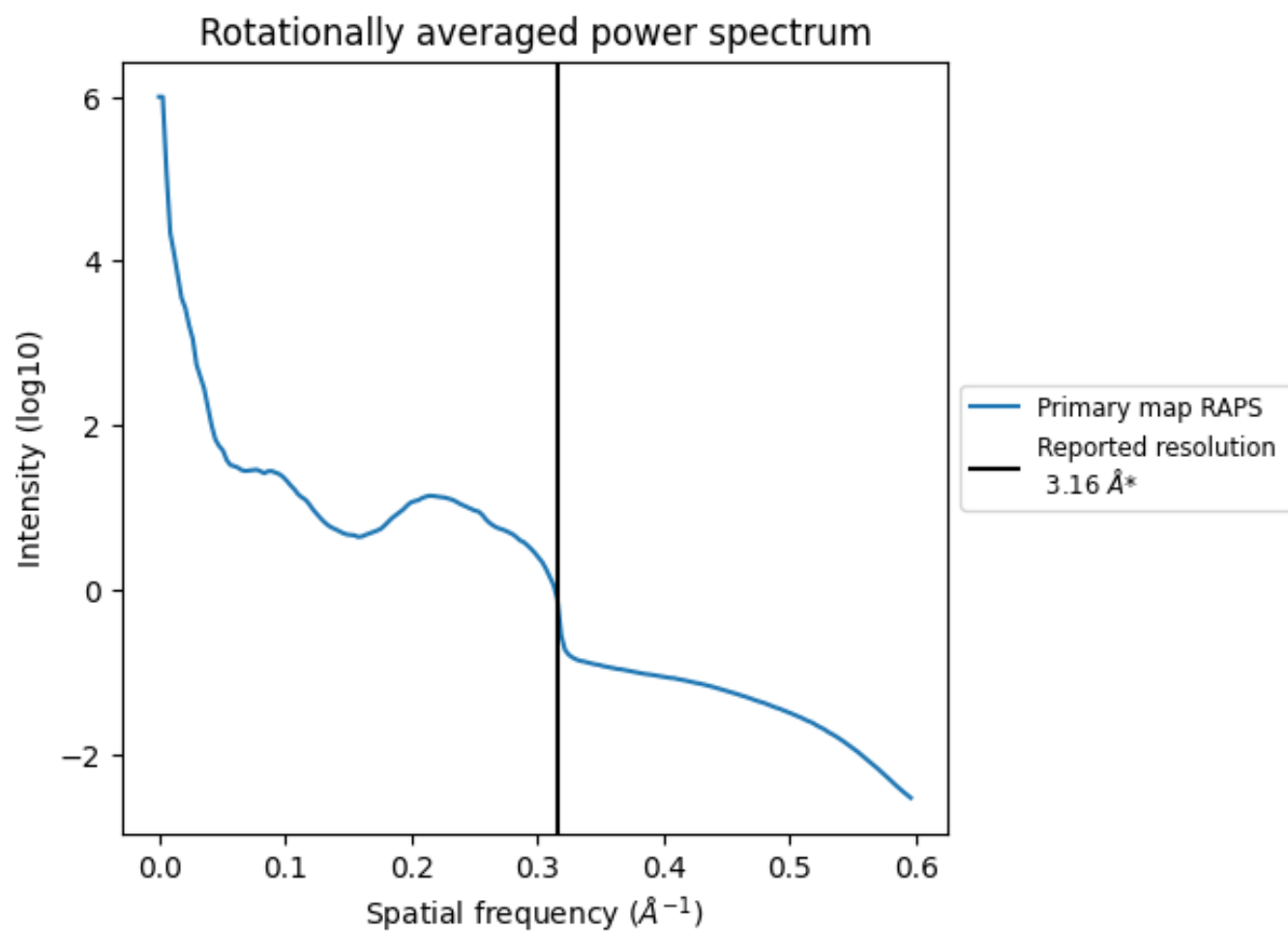

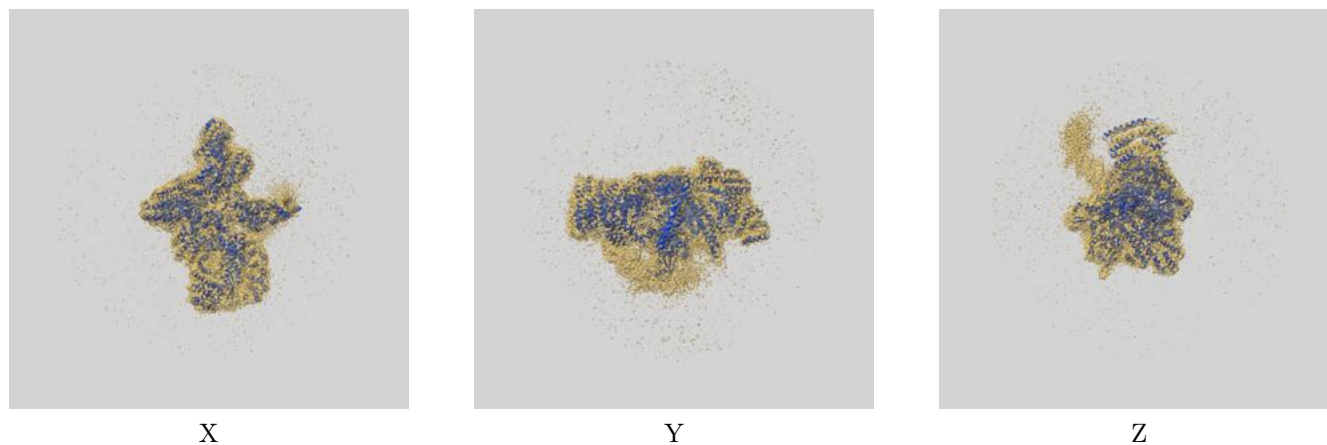

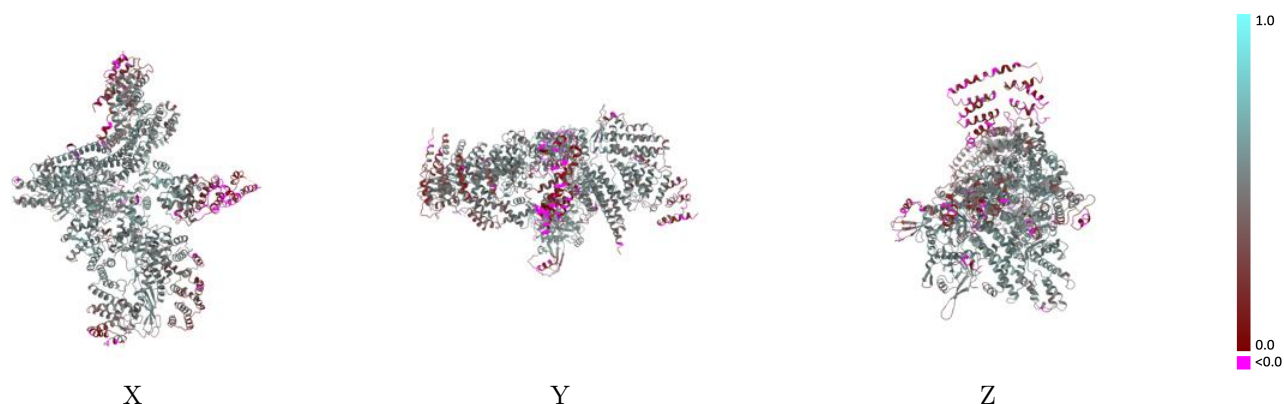

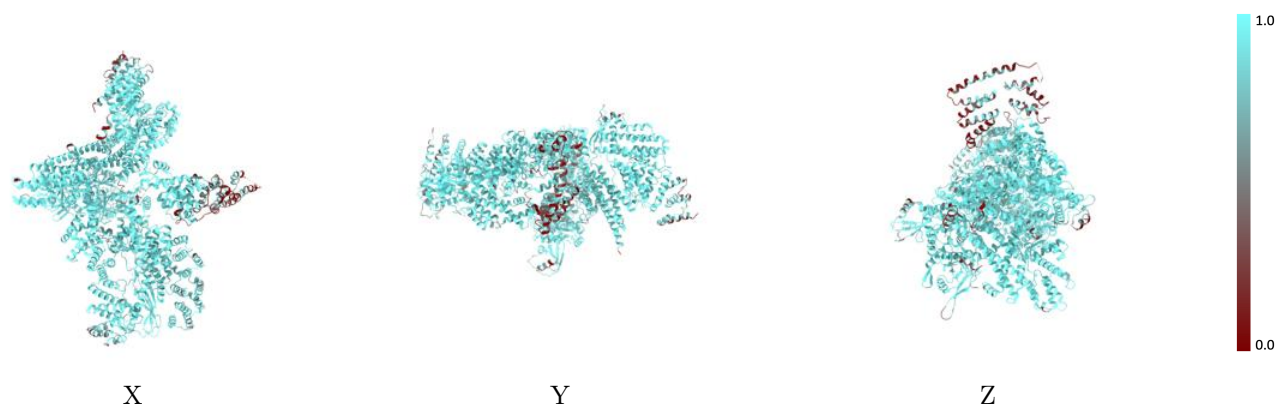

9.2 Q-score mapped to coordinate model [i](#)



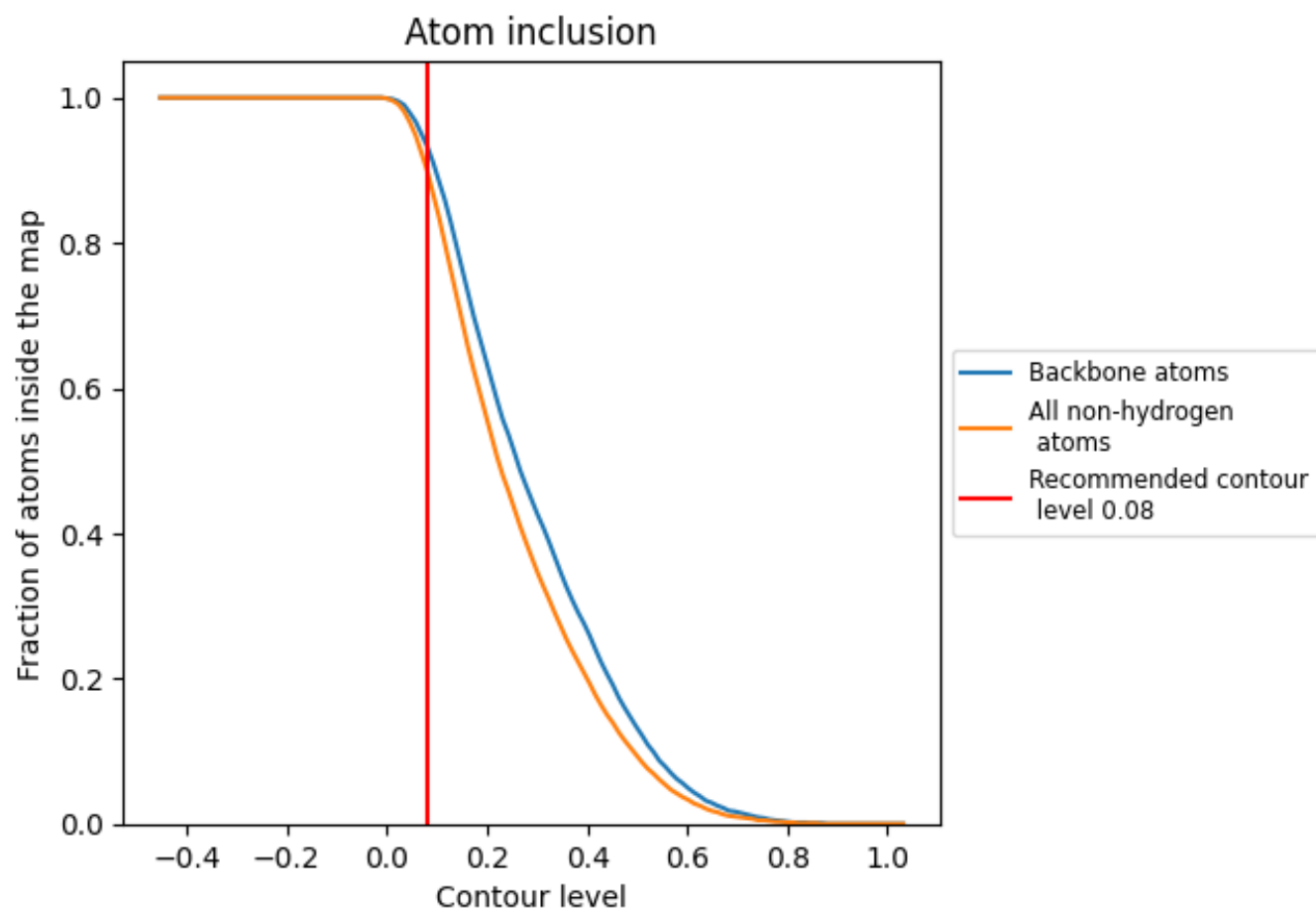
