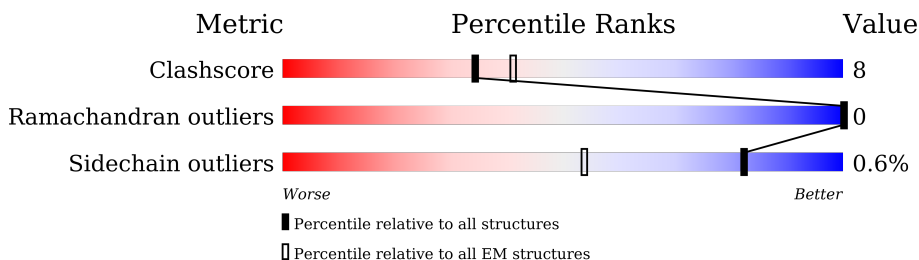
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 3.08 Å.

The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$.

2 Entry composition

There are 6 unique types of molecules in this entry. The entry contains 9693 atoms, of which 0 are hydrogens and 0 are deuteriums.

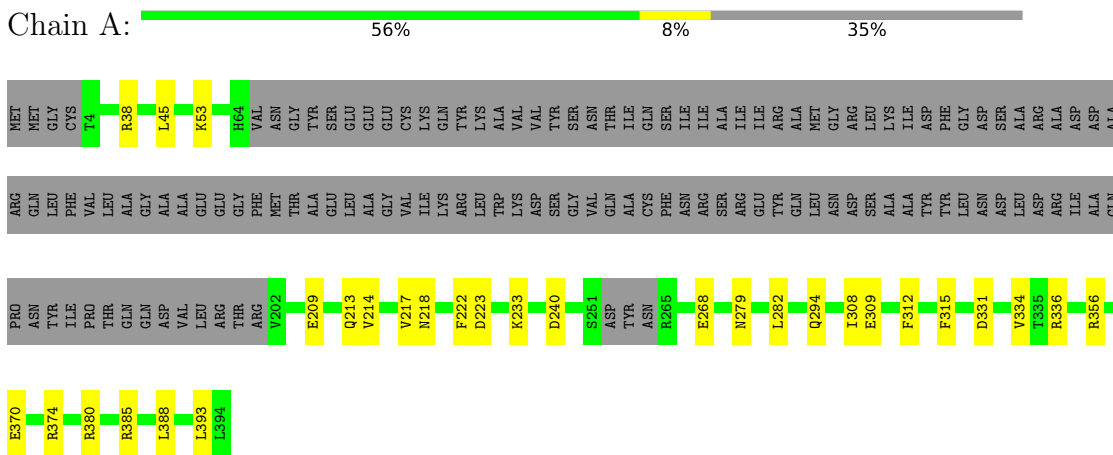

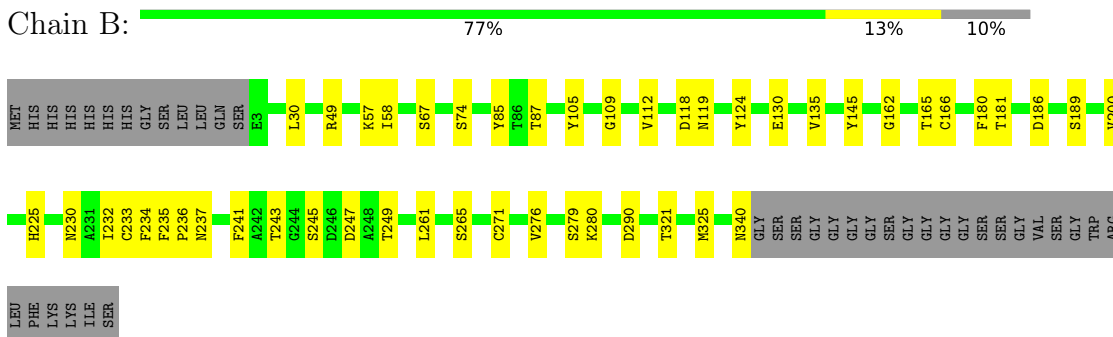
3 Residue-property plots

These plots are drawn for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic for a chain summarises the proportions of the various outlier classes displayed in the second graphic. The second graphic shows the sequence view annotated by issues in geometry. Residues are color-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outlier are shown as a green connector. Residues present in the sample, but not in the model, are shown in grey.

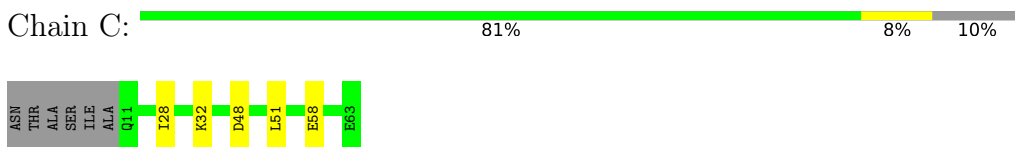
- Molecule 1: Guanine nucleotide-binding protein G(s) subunit alpha isoforms short



- Molecule 2: Guanine nucleotide-binding protein G(I)/G(S)/G(T) subunit beta-1

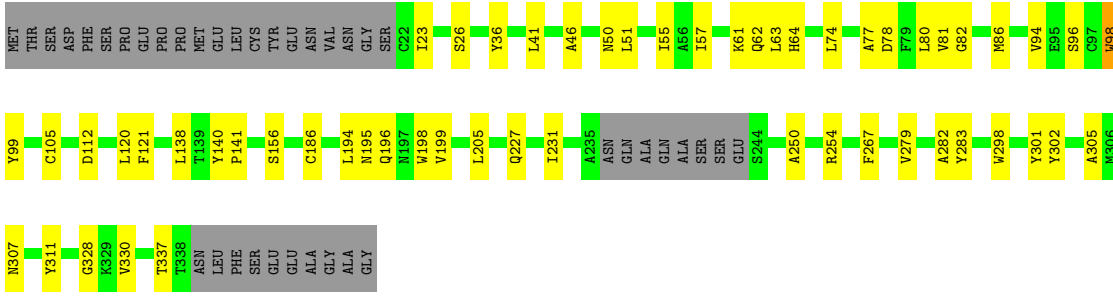


- Molecule 3: Guanine nucleotide-binding protein G(I)/G(S)/G(O) subunit gamma-2

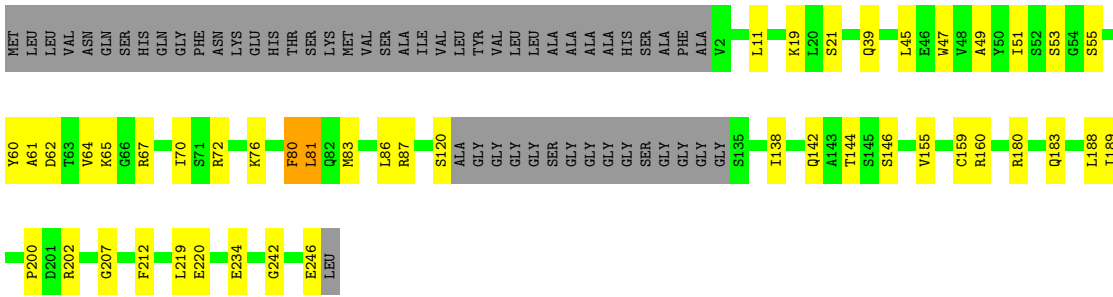


- Molecule 4: Trace amine-associated receptor 9

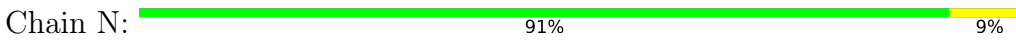




• Molecule 5: scFv16

5.1 Standard geometry [i](#)

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

5.2 Too-close contacts [i](#)

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in the chain respectively. The Clashes column lists the number of clashes within the asymmetric unit, whereas Symm-Clashes lists symmetry-related clashes.
