2 Ensemble composition and analysis

This entry contains 2 models. Identification of well-defined residues and clustering analysis are not possible.

3 Entry composition [i](#)

There are 2 unique types of molecules in this entry. The entry contains 570 atoms, of which 206 are hydrogens and 0 are deuteriums.

4 Residue-property plots

4.1 Average score per residue in the NMR ensemble


These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.





5 Refinement protocol and experimental data overview (i)

The models were refined using the following method: *matrix relaxation, molecular dynamics*.

Of the 6 calculated structures, 2 were deposited, based on the following criterion: *structures with the lowest energy*.
