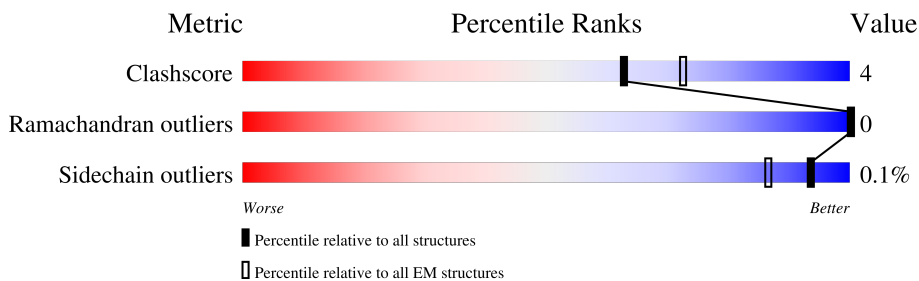
1 Overall quality at a glance i

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 3.20 Å.

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

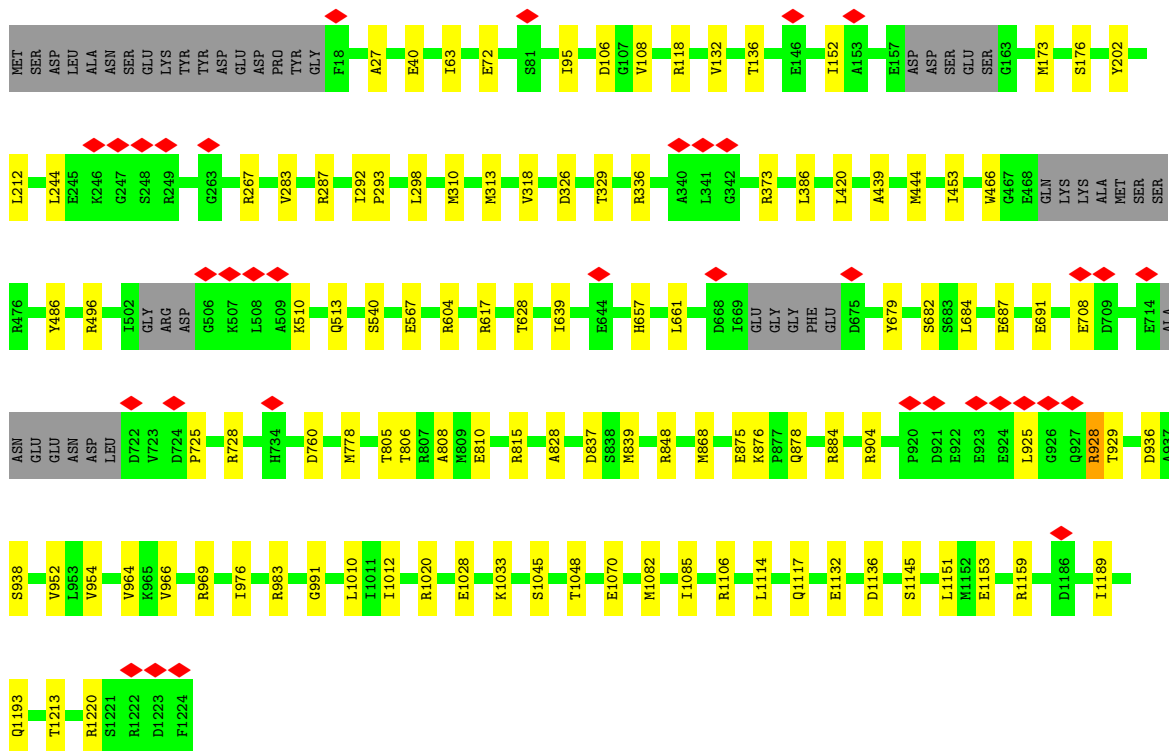


• Molecule 9: DNA-directed RNA polymerase II subunit RPB1

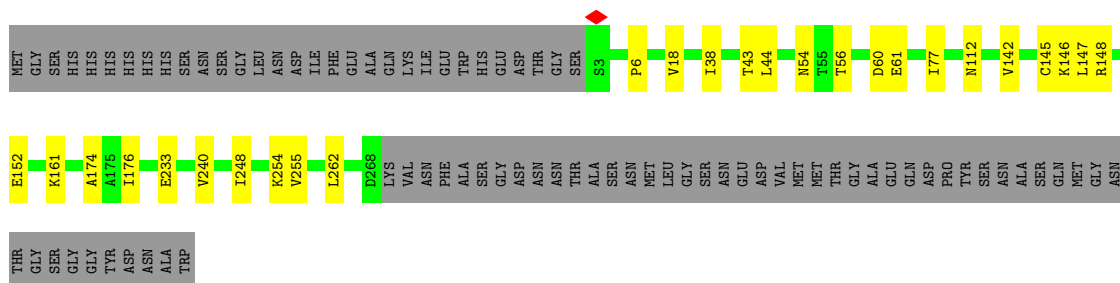


• Molecule 10: DNA-directed RNA polymerase II subunit RPB2

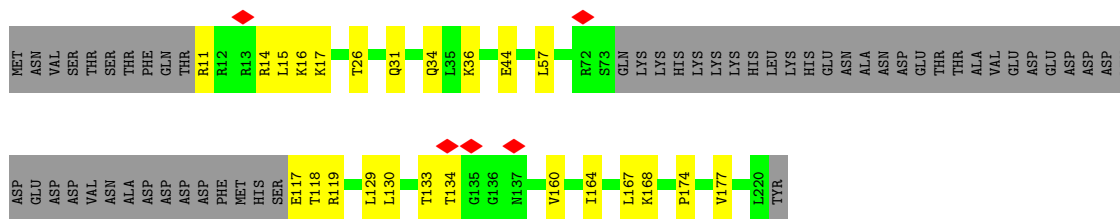




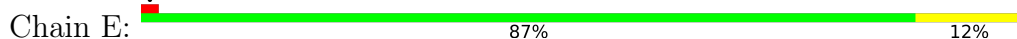
• Molecule 11: DNA-directed RNA polymerase II subunit RPB3

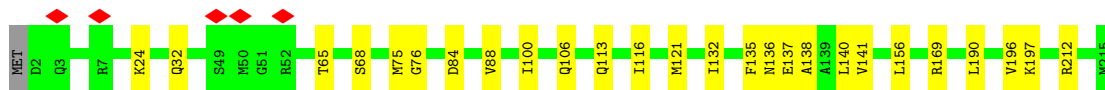


• Molecule 12: DNA-directed RNA polymerase II subunit RPB4

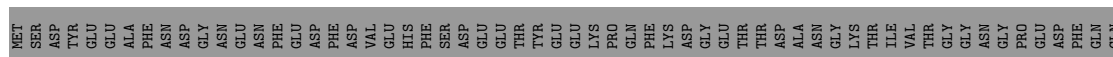


• Molecule 13: DNA-directed RNA polymerases I, II, and III subunit RPABC1

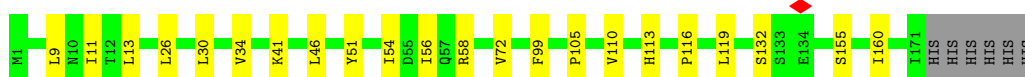
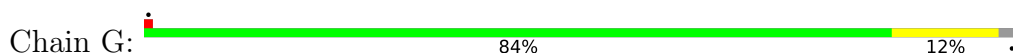




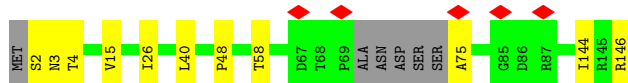
- Molecule 14: DNA-directed RNA polymerases I, II, and III subunit RPABC2



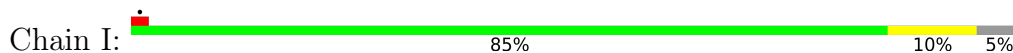

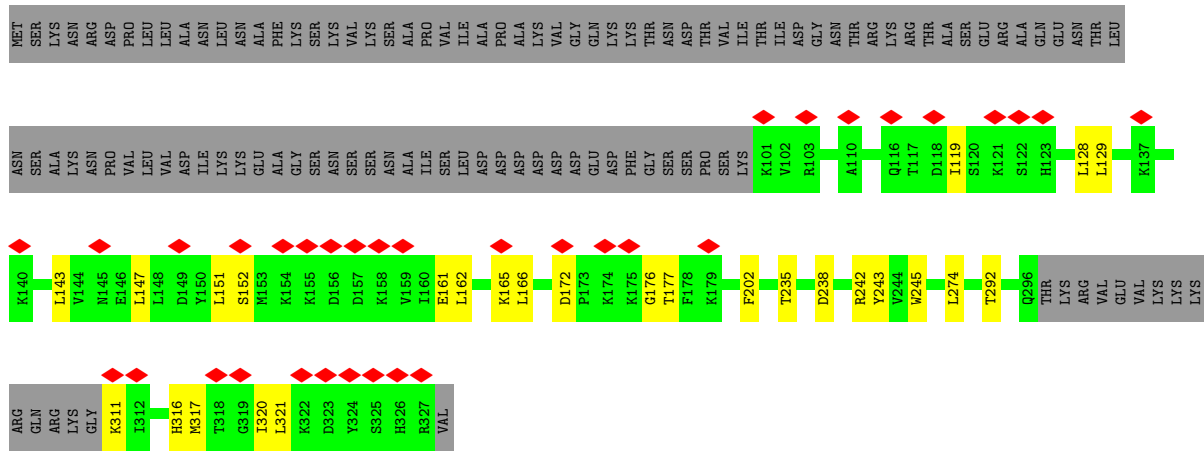

5.1 Standard geometry

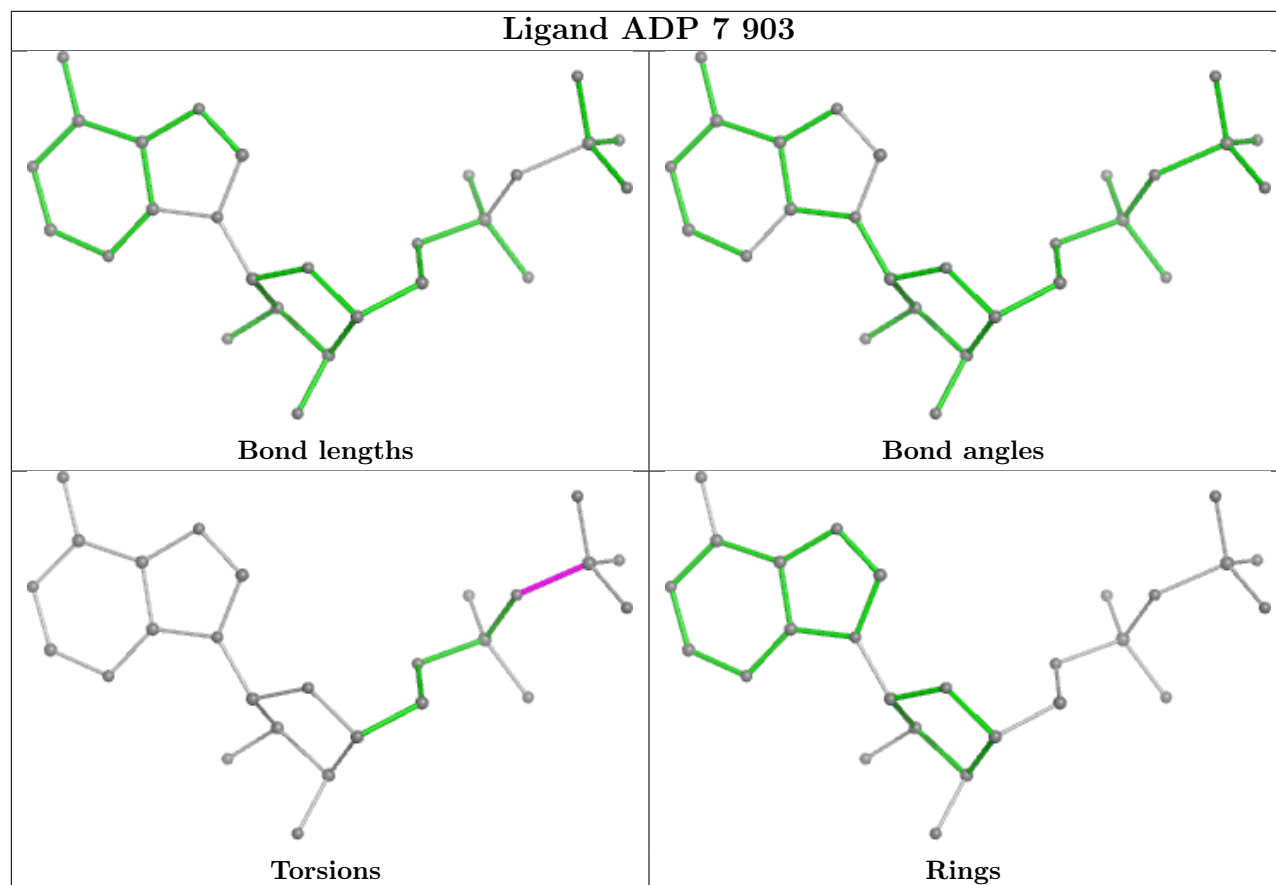

The following is a two-dimensional graphical depiction of Mogul quality analysis of bond lengths, bond angles, torsion angles, and ring geometry for all instances of the Ligand of Interest. 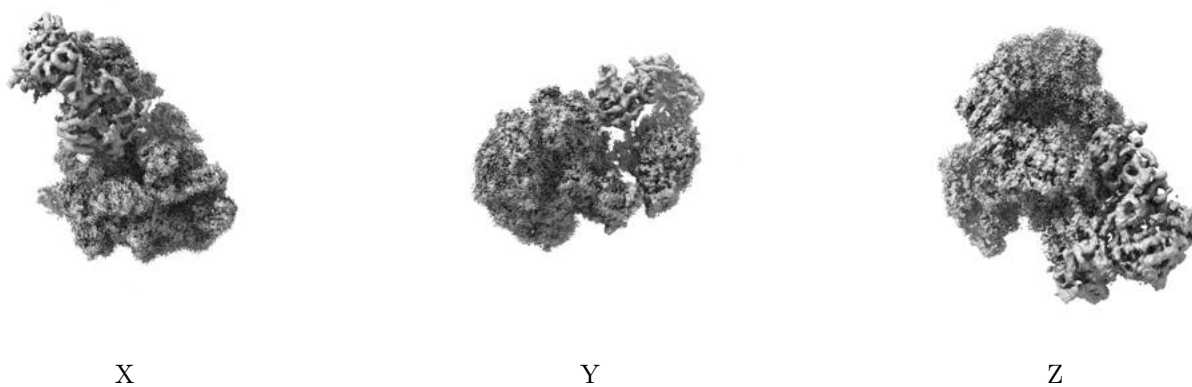

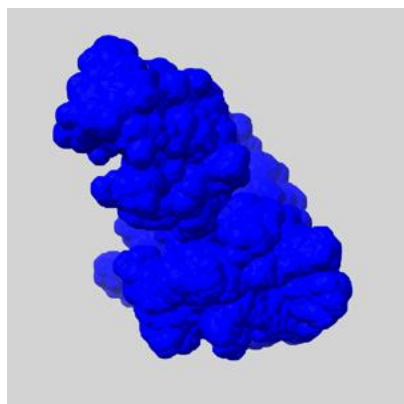

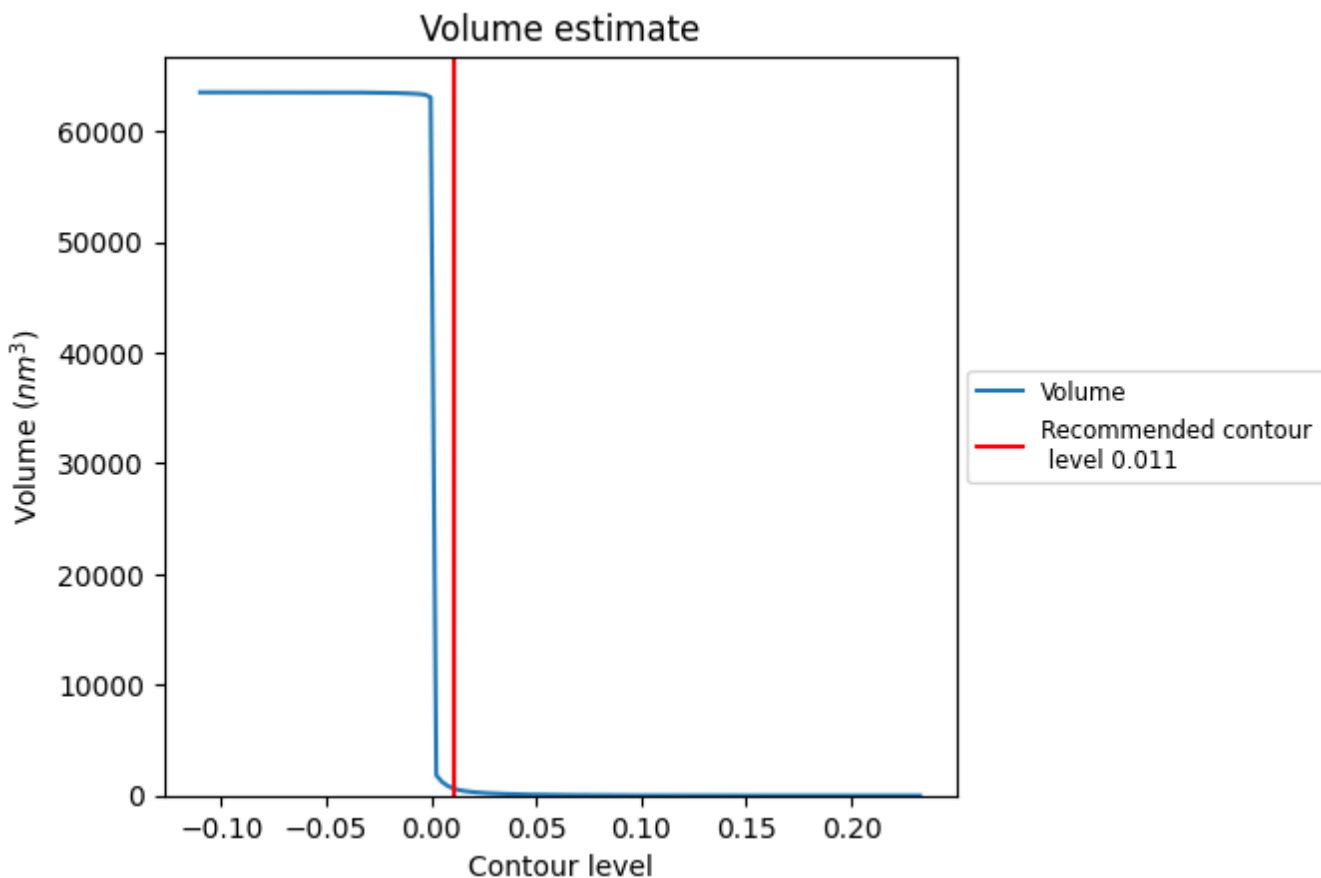

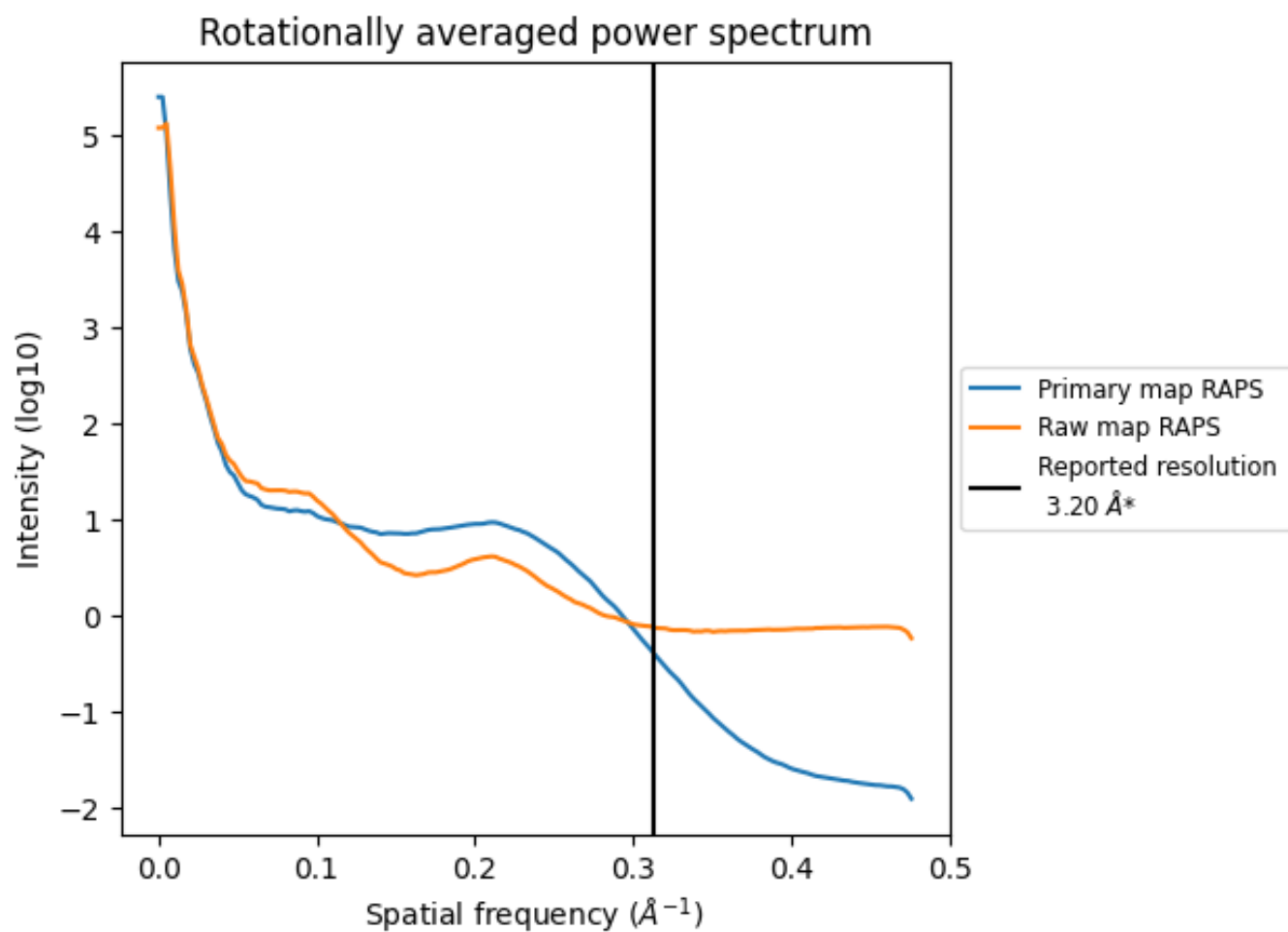

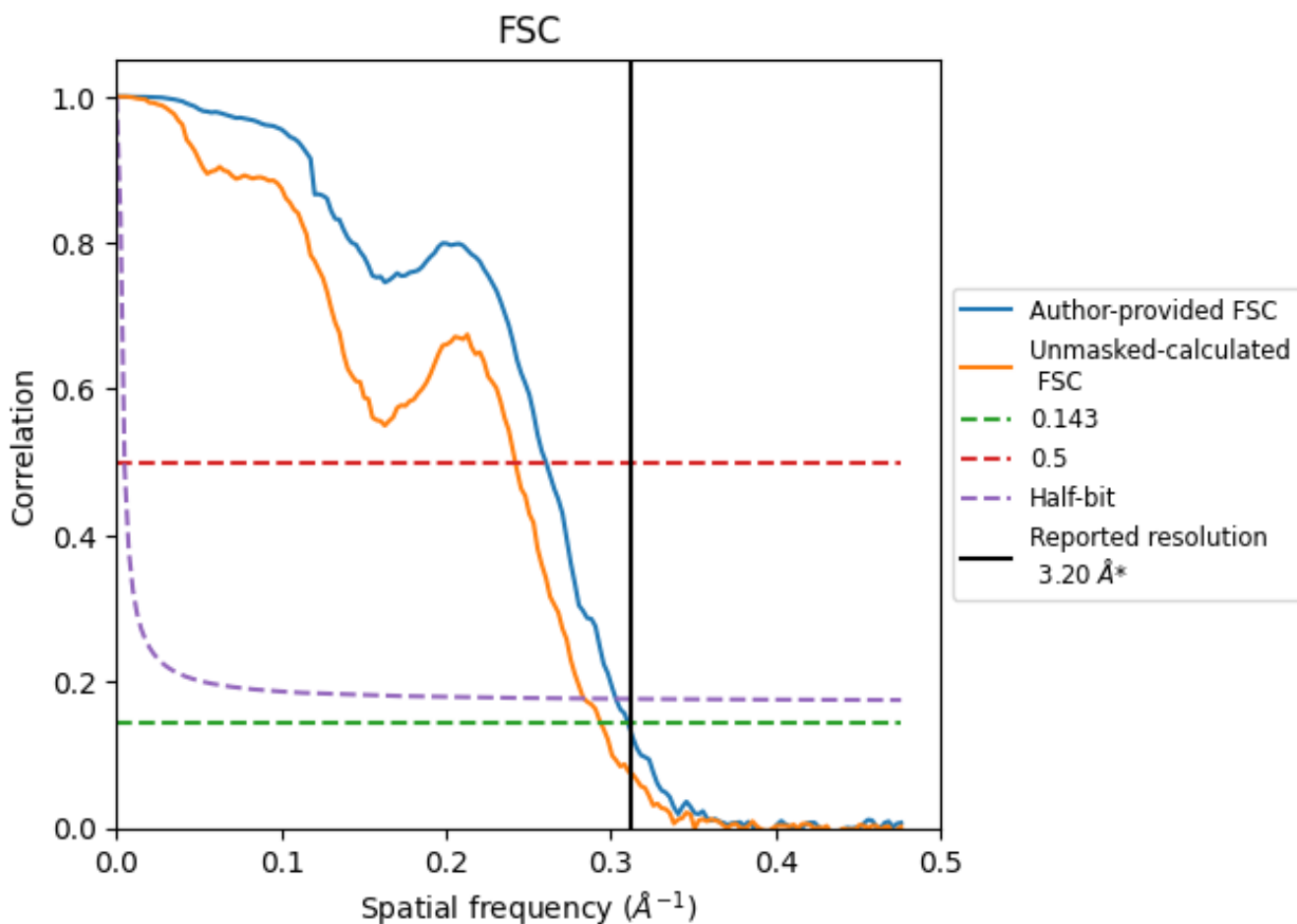

8 Fourier-Shell correlation [i](#)

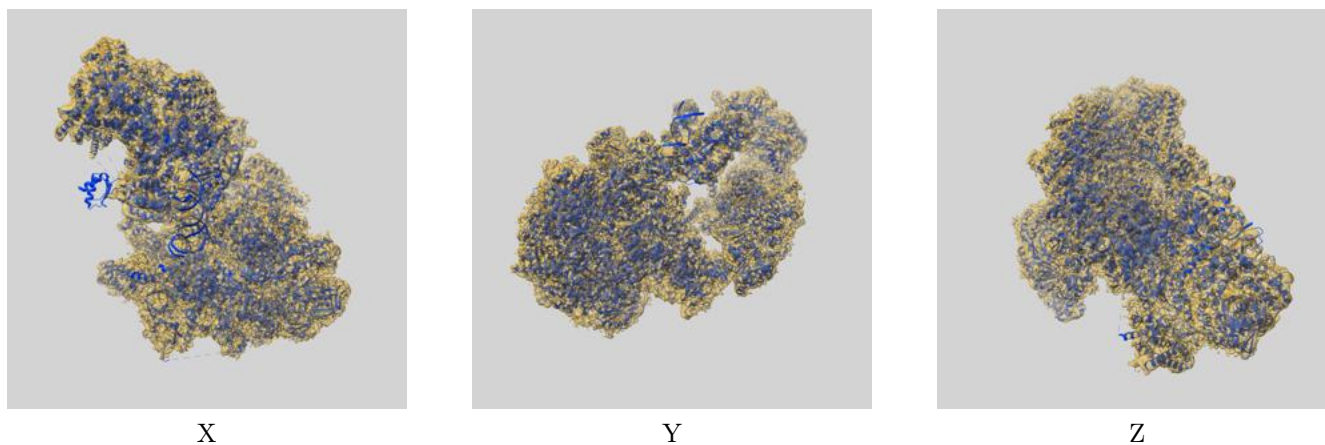

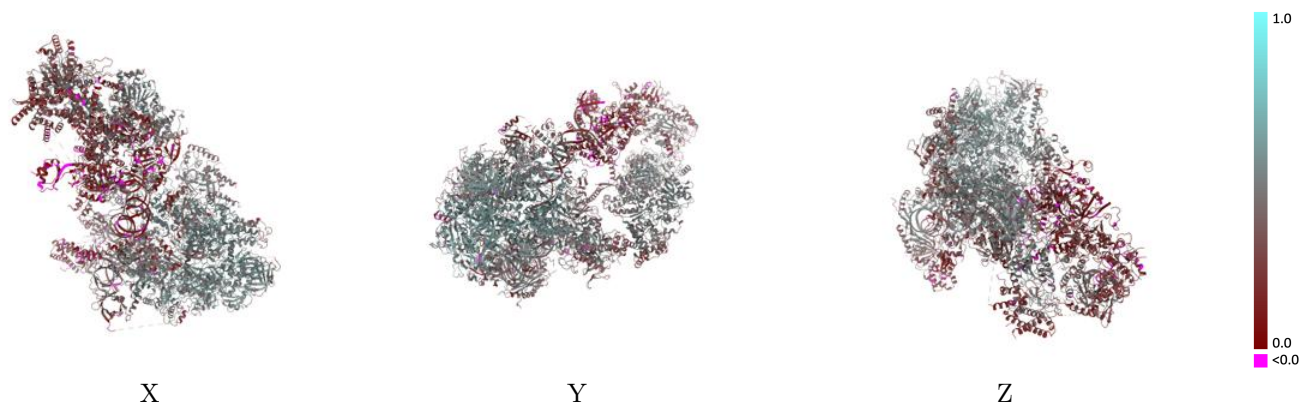

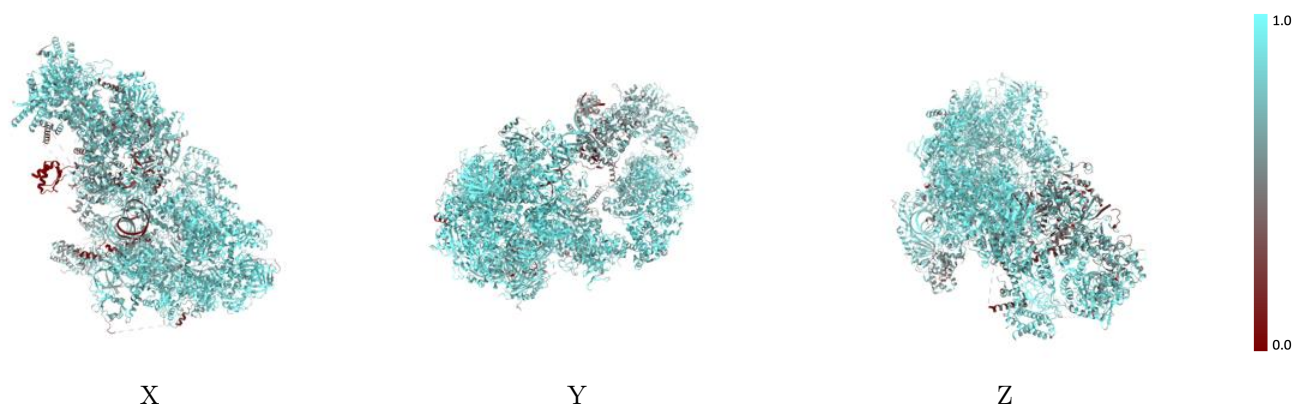

9.2 Q-score mapped to coordinate model [i](#)



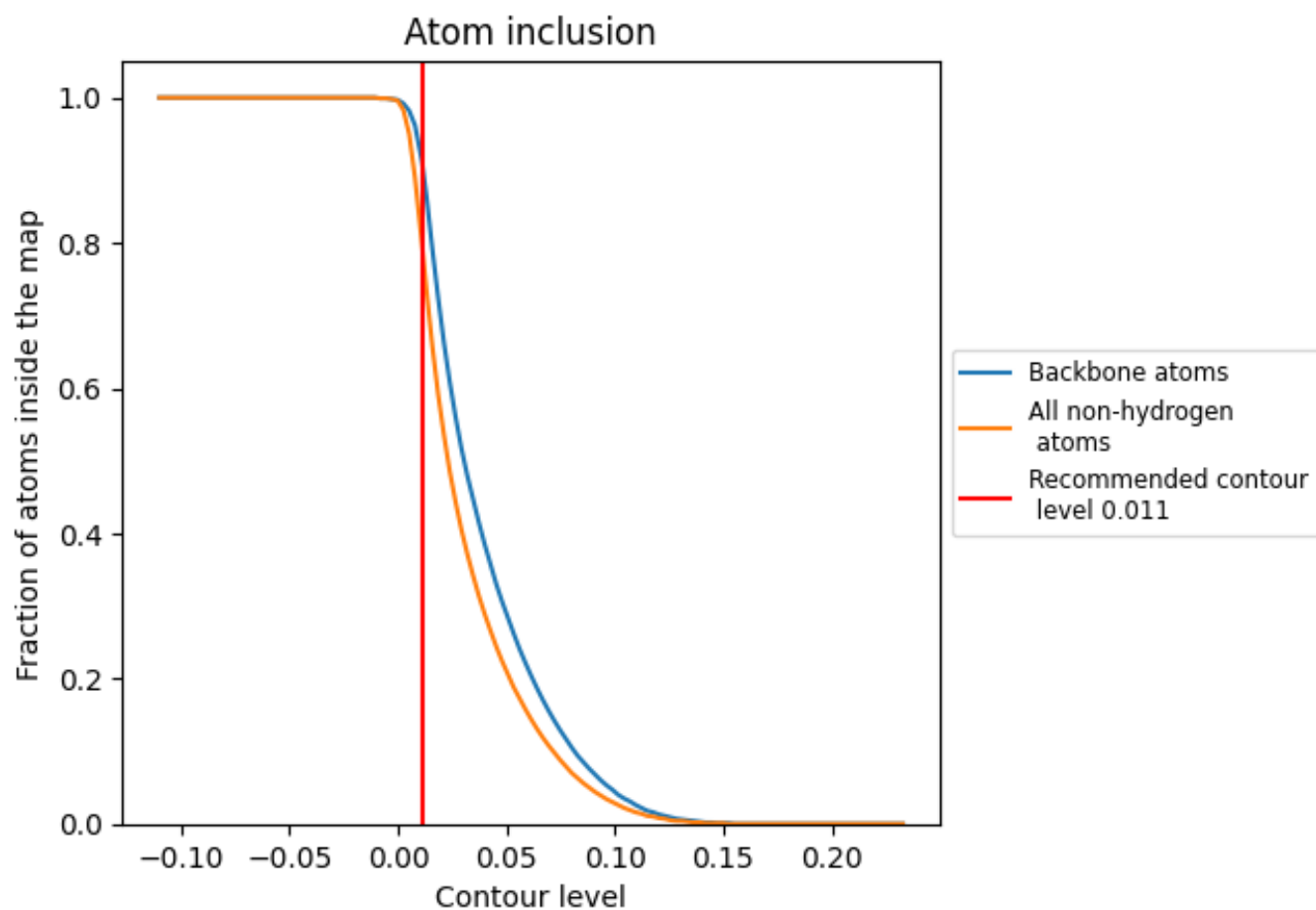


