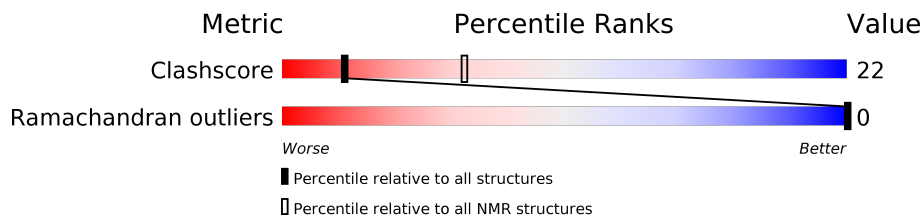
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

*SOLID-STATE NMR*

The overall completeness of chemical shifts assignment was not calculated.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$

## 2 Ensemble composition and analysis

This entry contains 1 models. Identification of well-defined residues and clustering analysis are not possible.

### 3 Entry composition

There is only 1 type of molecule in this entry. The entry contains 91 atoms, of which 18 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called VPU protein.

## 4 Residue-property plots [i](#)

These plots are provided for all protein, RNA and DNA chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

- Molecule 1: VPU protein

## 5 Refinement protocol and experimental data overview

The models were refined using the following method: *Direct structural fitting of 2D solid-state NMR data*.

Of the 100 calculated structures, 1 were deposited, based on the following criterion: *minimized average structure*.

The following table shows the software used for structure solution, optimisation and refinement.

No chemical shift data was provided. Note: This is a solid-state NMR structure, where hydrogen atoms are typically not assigned a chemical shift value, which may lead to lower completeness of assignment measure.

No validations of the models with respect to experimental NMR restraints is performed at this time.

## 6 Model quality [i](#)

### 6.1 Standard geometry [i](#)

There are no covalent bond-length or bond-angle outliers.

### 6.2 Too-close contacts [i](#)

In the following table, the Non-H and H(model) columns list the number of non-hydrogen atoms and hydrogen atoms in each chain respectively. The H(added) column lists the number of hydrogen atoms added and optimized by MolProbity. The Clashes column lists the number of clashes averaged over the ensemble.

The all-atom clashscore is defined as the number of clashes found per 1000 atoms (including hydrogen atoms). The all-atom clashscore for this structure is 22.
