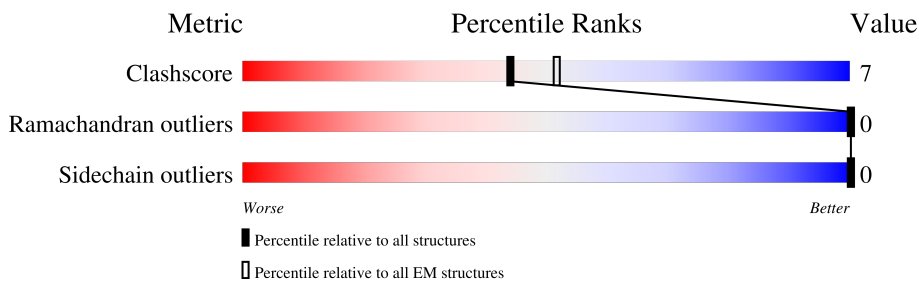
1 Overall quality at a glance i

The following experimental techniques were used to determine the structure:

ELECTRON MICROSCOPY

The reported resolution of this entry is 3.46 Å.

The red, orange, yellow and green segments of the bar indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria respectively. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the EM map (all-atom inclusion $< 40\%$). The numeric value is given above the bar.

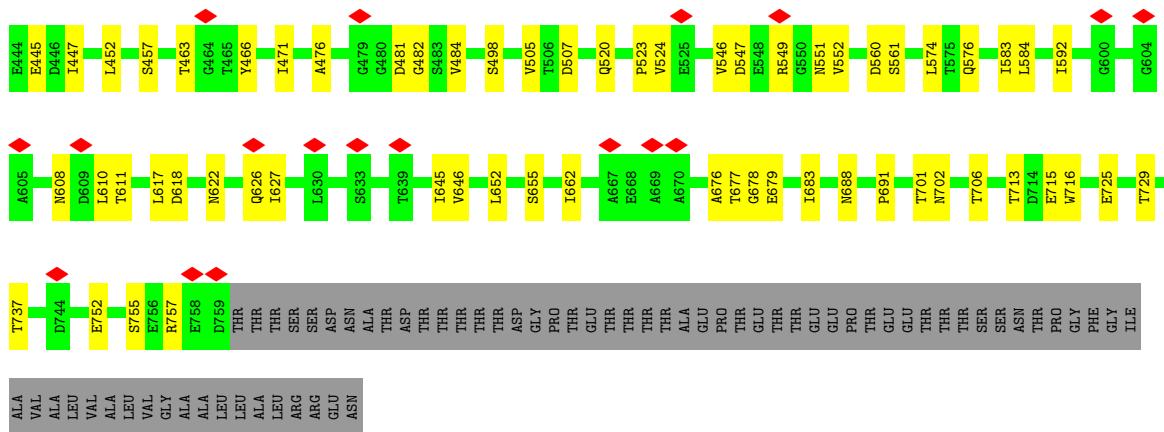

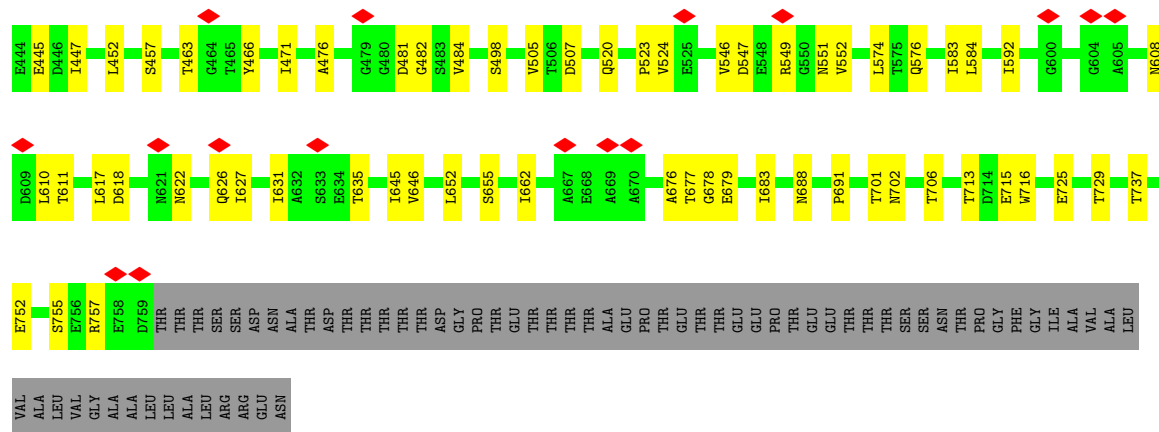


• Molecule 1: Cell surface glycoprotein

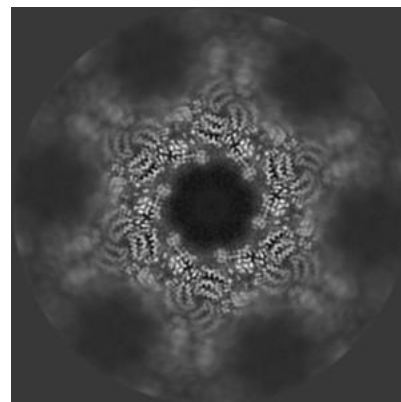

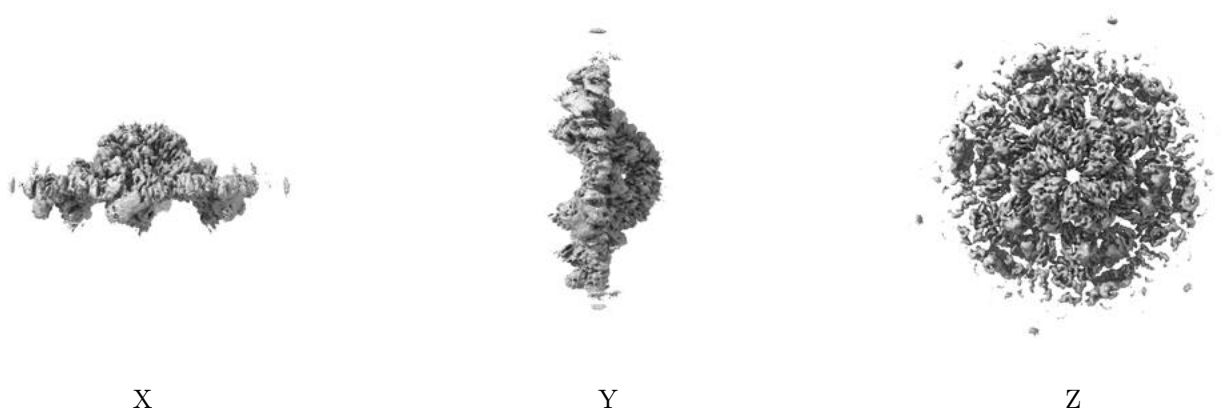

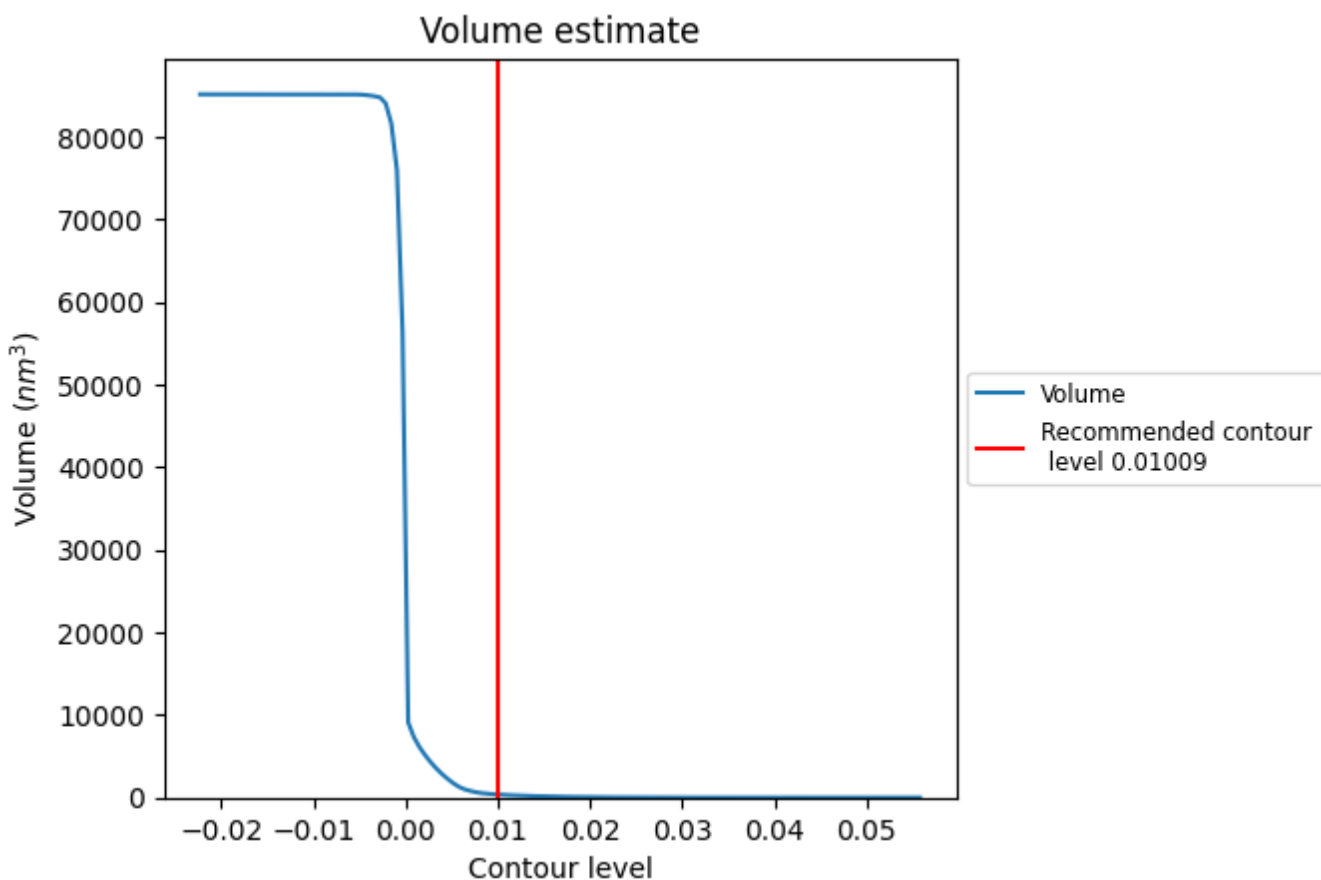

7.1 Map-value distribution [i](#)



The map-value distribution is plotted in 128 intervals along the x-axis. The y-axis is logarithmic. A spike in this graph at zero usually indicates that the volume has been masked.

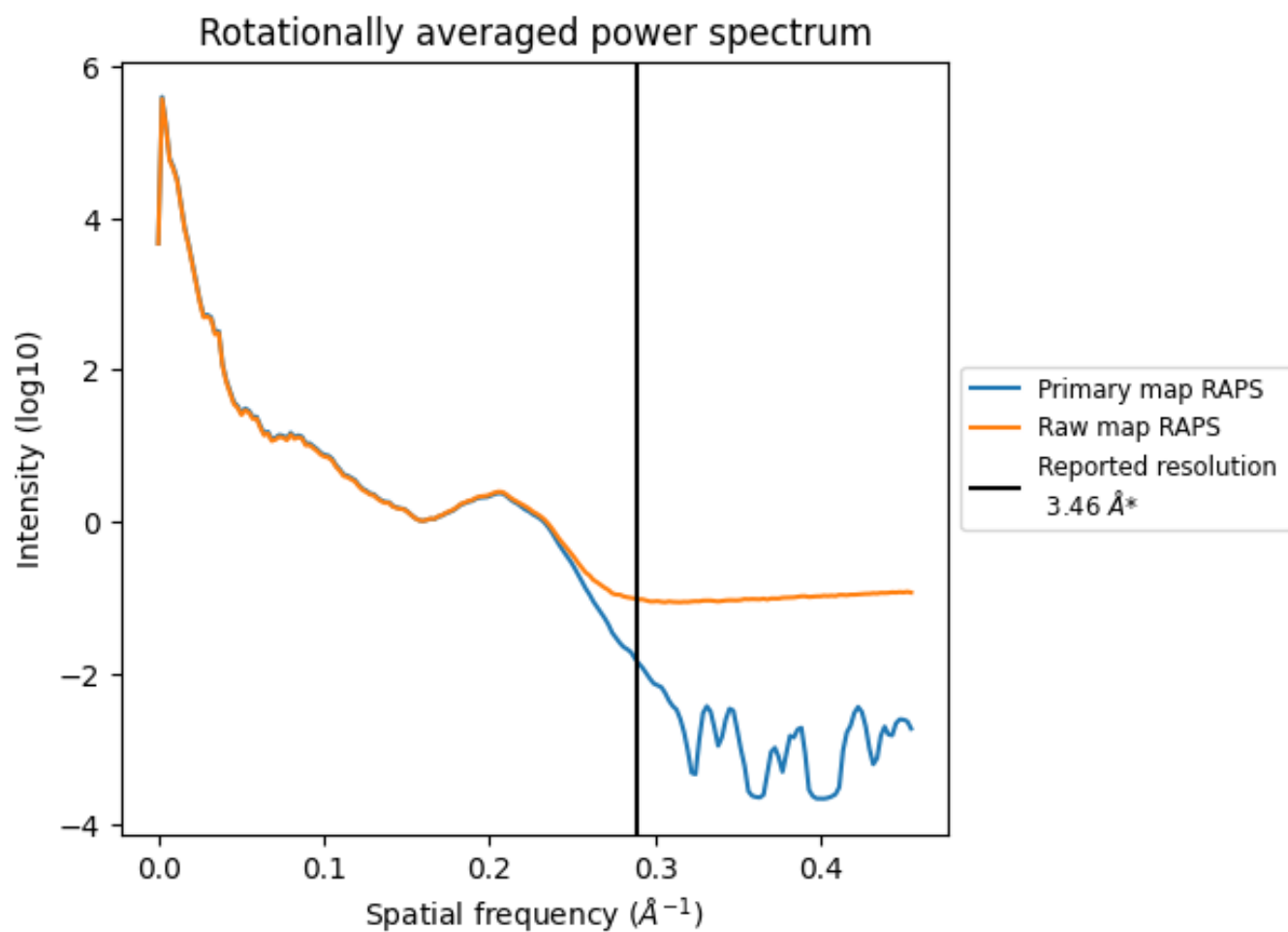
7.2 Volume estimate [i](#)



The volume at the recommended contour level is 362 nm³; this corresponds to an approximate mass of 327 kDa.

The volume estimate graph shows how the enclosed volume varies with the contour level. The recommended contour level is shown as a vertical line and the intersection between the line and the curve gives the volume of the enclosed surface at the given level.

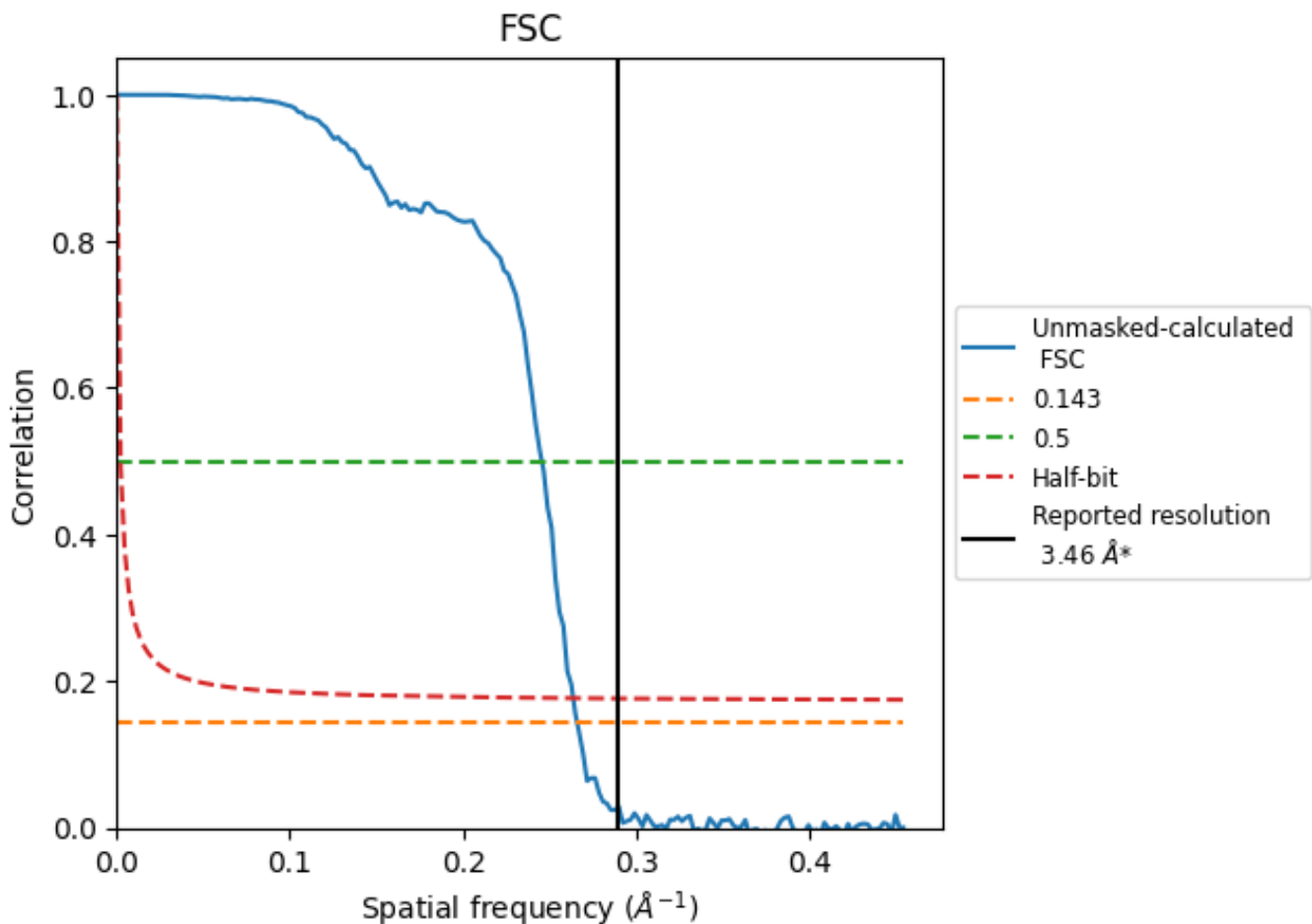

8 Fourier-Shell correlation [i](#)

Fourier-Shell Correlation (FSC) is the most commonly used method to estimate the resolution of single-particle and subtomogram-averaged maps. The shape of the curve depends on the imposed symmetry, mask and whether or not the two 3D reconstructions used were processed from a common reference. The reported resolution is shown as a black line. A curve is displayed for the half-bit criterion in addition to lines showing the 0.143 gold standard cut-off and 0.5 cut-off.

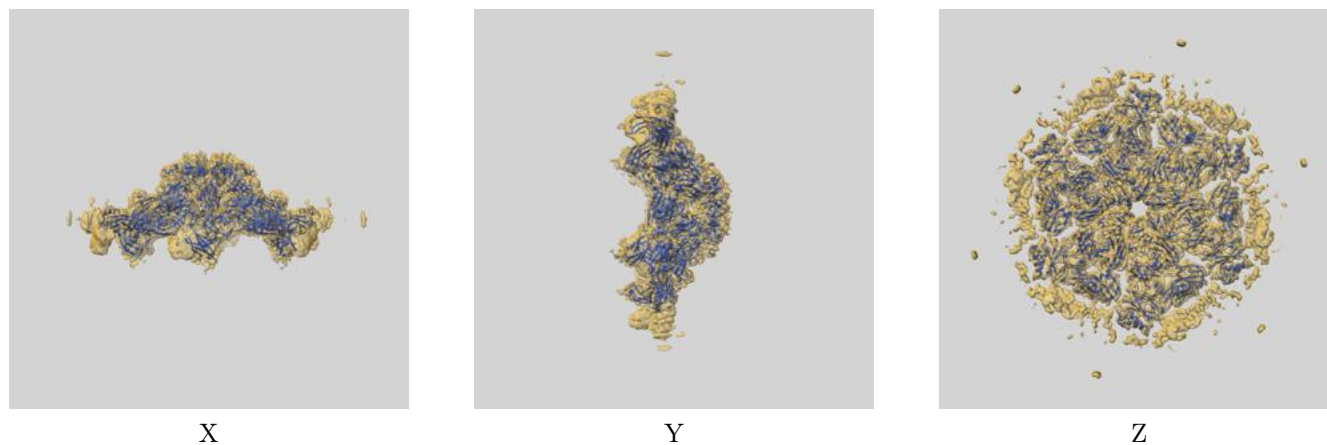

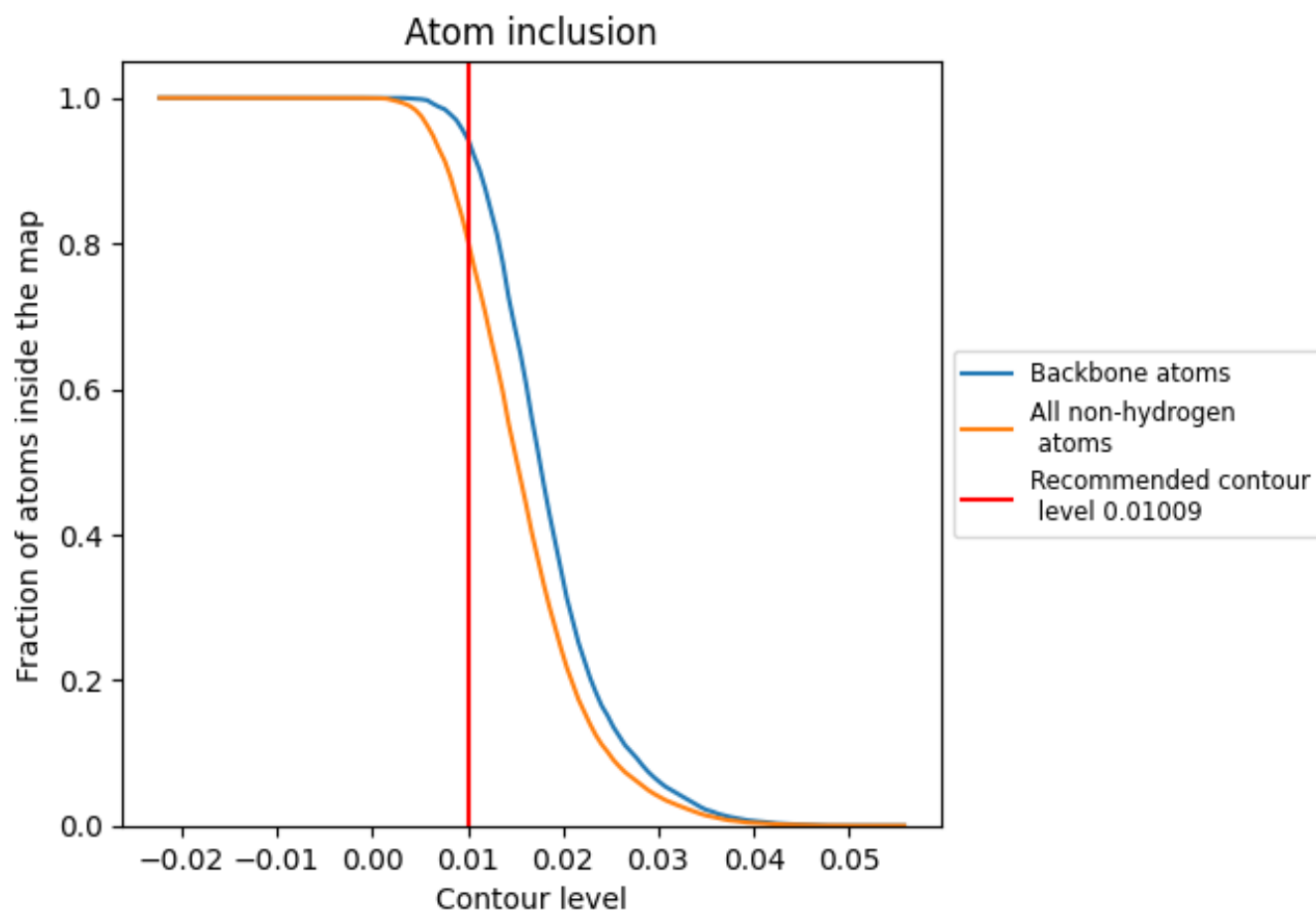

The images above show the 3D surface view of the map at the recommended contour level 0.01009 at 50% transparency in yellow overlaid with a ribbon representation of the model coloured in blue. These images allow for the visual assessment of the quality of fit between the atomic model and the map.

9.2 Atom inclusion [i](#)



At the recommended contour level, 94% of all backbone atoms, 80% of all non-hydrogen atoms, are inside the map.
