

1 Overall quality at a glance (i)

2 Entry composition (i)

There are 6 unique types of molecules in this entry. The entry contains 2052 atoms, of which 0 are hydrogens and 0 are deuteriums.



Xtriage's analysis on translational NCS is as follows: The largest off-origin peak in the Patterson function is 3.04% of the height of the origin peak. No significant pseudotranslation is detected.








The following is a graphical depiction of the model fit to experimental electron density of all




