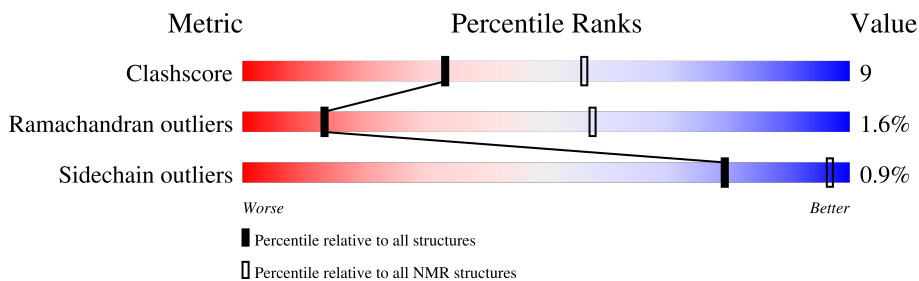
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

SOLUTION NMR

The overall completeness of chemical shifts assignment was not calculated.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The table below summarises the geometric issues observed across the polymeric chains and their fit to the experimental data. The red, orange, yellow and green segments indicate the fraction of residues that contain outliers for ≥ 3 , 2, 1 and 0 types of geometric quality criteria. A cyan segment indicates the fraction of residues that are not part of the well-defined cores, and a grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$

2 Ensemble composition and analysis

This entry contains 21 models. The atoms present in the NMR models are not consistent. Some calculations may have failed as a result. All residues are included in the validation scores. The authors have identified model 1 as representative, based on the following criterion: *restrained minimized mean*. No medoid model was calculated.

The following residues are included in the computation of the global validation metrics.

Ill-defined regions of proteins are excluded from the global statistics.

Ligands and non-protein polymers are included in the analysis.

NmrClust was unable to cluster the ensemble.

3 Entry composition

There is only 1 type of molecule in this entry. The entry contains 2810 atoms, of which 1400 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called PROTEIN (BARRIER-TO-AUTOINTEGRATION FACTOR).

4 Residue-property plots

4.1 Average score per residue in the NMR ensemble


These plots are provided for all protein, RNA, DNA and oligosaccharide chains in the entry. The first graphic is the same as shown in the summary in section 1 of this report. The second graphic shows the sequence where residues are colour-coded according to the number of geometric quality criteria for which they contain at least one outlier: green = 0, yellow = 1, orange = 2 and red = 3 or more. Stretches of 2 or more consecutive residues without any outliers are shown as green connectors. Residues which are classified as ill-defined in the NMR ensemble, are shown in cyan with an underline colour-coded according to the previous scheme. Residues which were present in the experimental sample, but not modelled in the final structure are shown in grey.

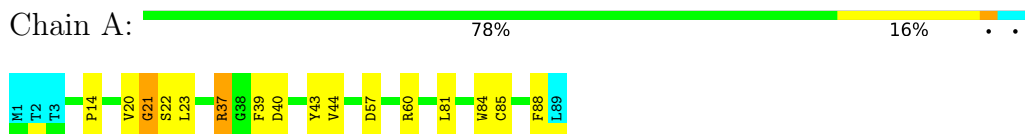

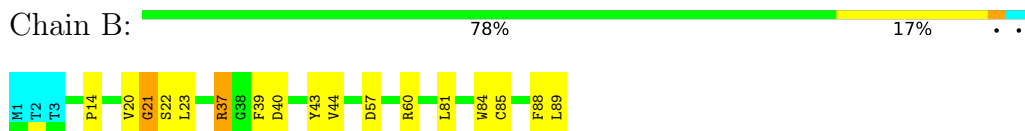

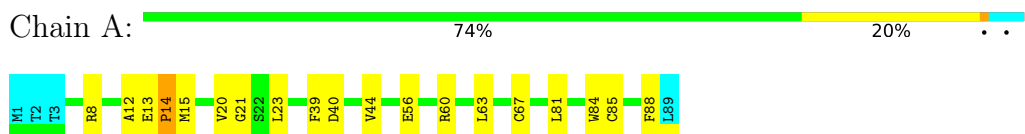

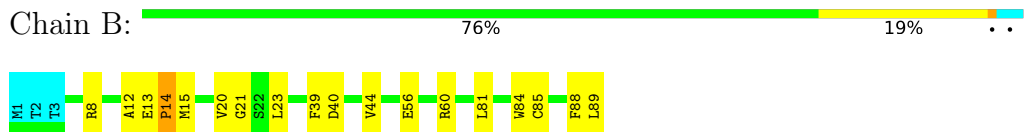


4.2.3 Score per residue for model 3

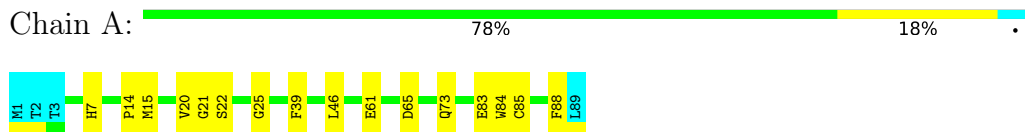

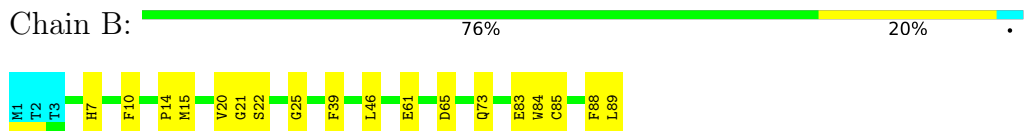


4.2.4 Score per residue for model 4

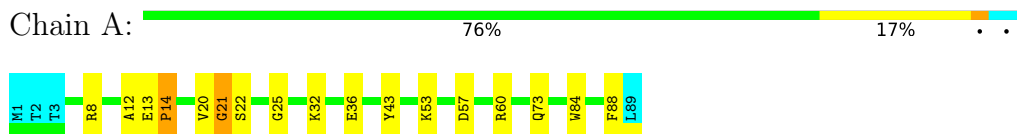

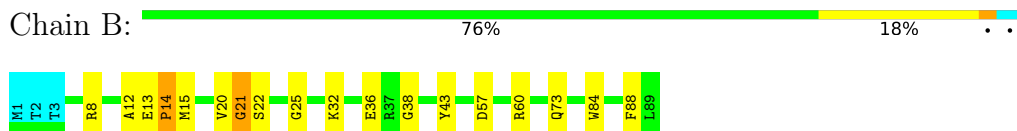


4.2.5 Score per residue for model 5

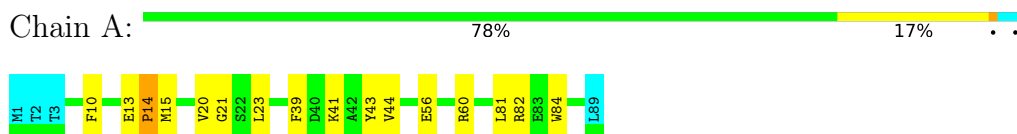

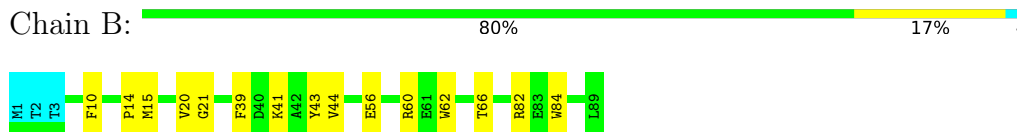


4.2.6 Score per residue for model 6

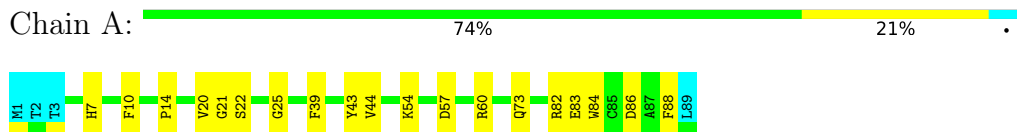

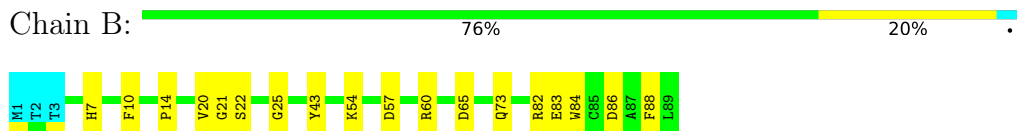


4.2.7 Score per residue for model 7

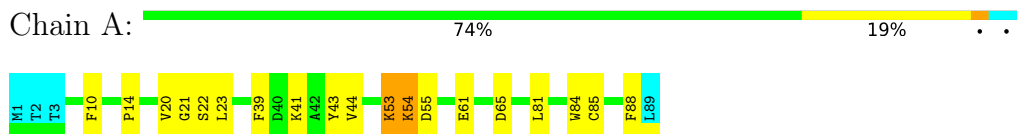

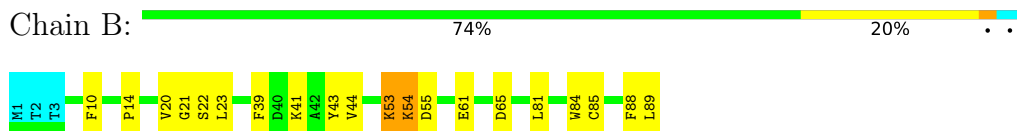


4.2.8 Score per residue for model 8

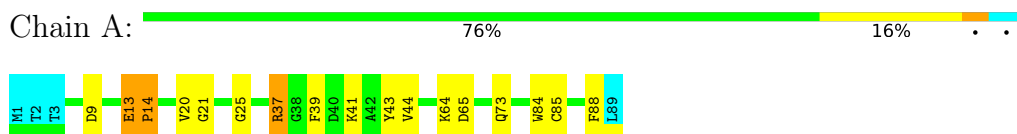

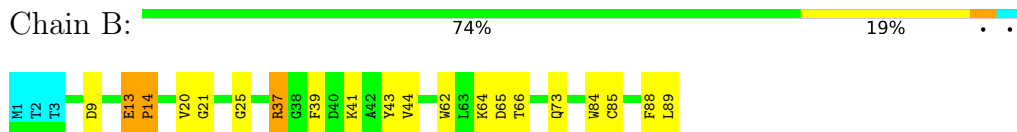


4.2.9 Score per residue for model 9

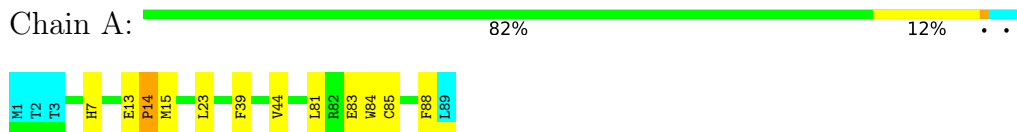

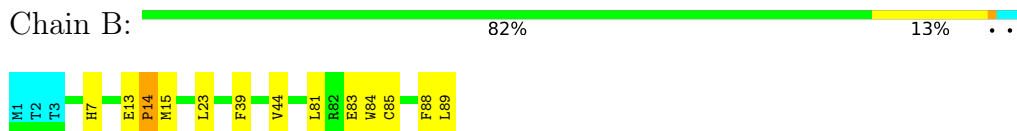


4.2.10 Score per residue for model 10

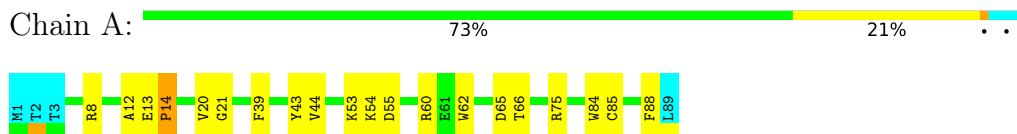

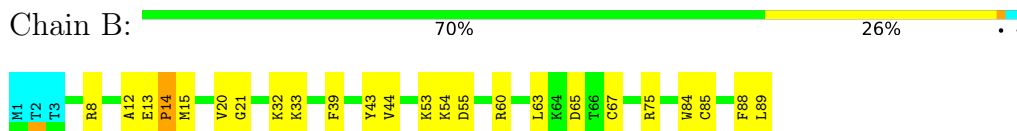


4.2.11 Score per residue for model 11

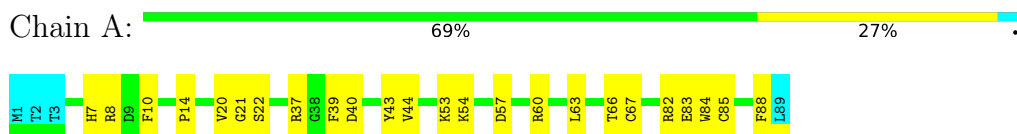

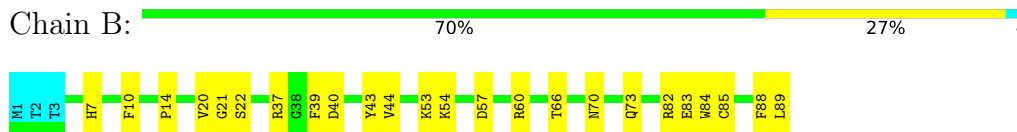


4.2.12 Score per residue for model 12

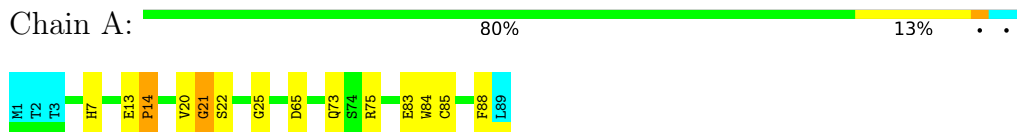

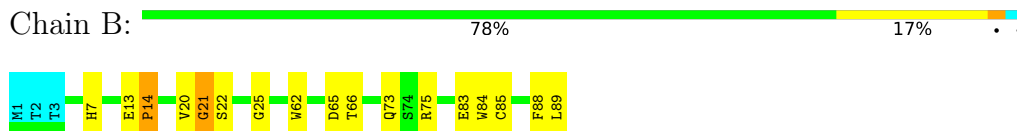


4.2.13 Score per residue for model 13

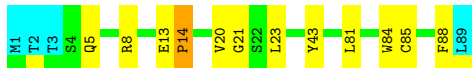

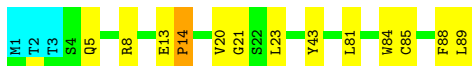

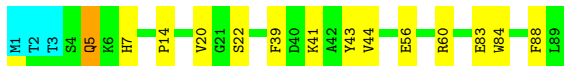

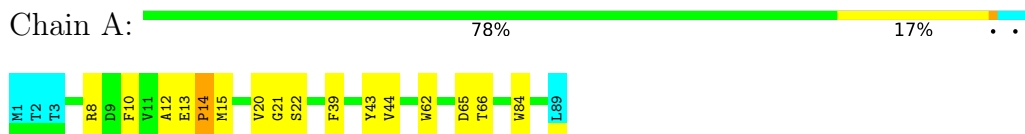

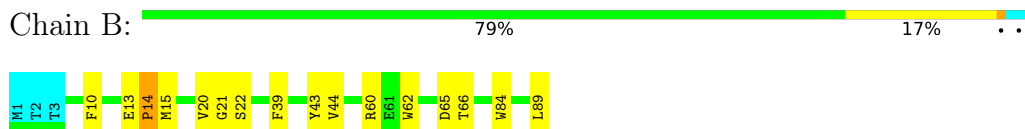


4.2.17 Score per residue for model 17

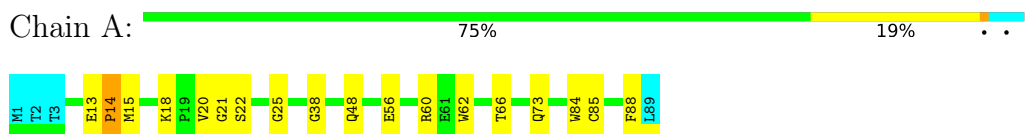

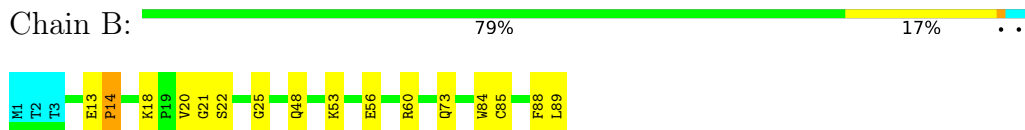


4.2.18 Score per residue for model 18

- Molecule 1: PROTEIN (BARRIER-TO-AUTOINTEGRATION FACTOR)

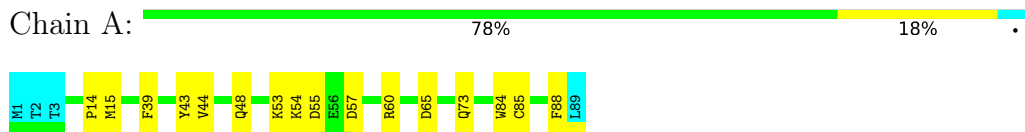


- Molecule 1: PROTEIN (BARRIER-TO-AUTOINTEGRATION FACTOR)

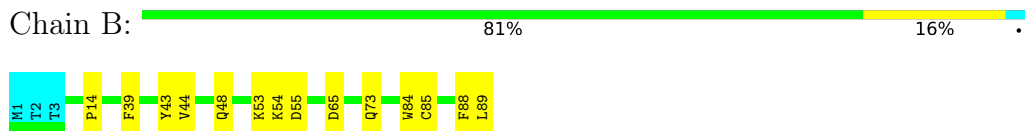


4.2.19 Score per residue for model 19

- Molecule 1: PROTEIN (BARRIER-TO-AUTOINTEGRATION FACTOR)

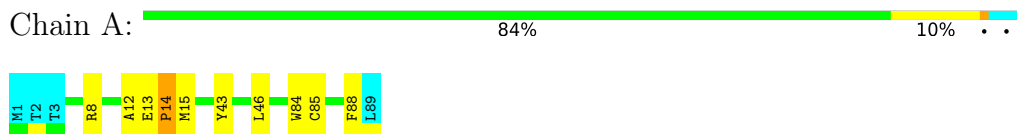

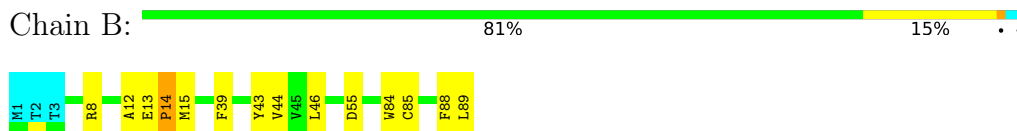


4.2.20 Score per residue for model 20

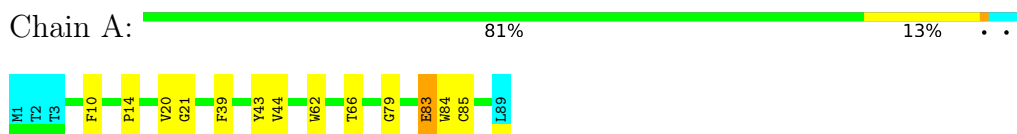

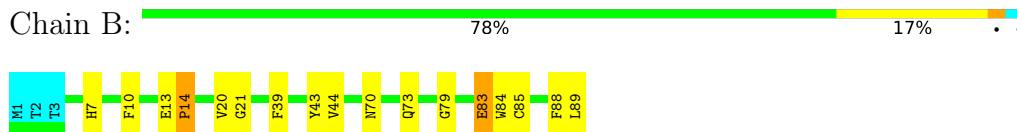


4.2.21 Score per residue for model 21

5 Refinement protocol and experimental data overview

The models were refined using the following method: *SEE REMARK 7*.

Of the 20 calculated structures, 21 were deposited, based on the following criterion: *INDIVIDUAL SIMULATED ANNEALING STRUCTURES*.

6.1 Standard geometry [i](#)

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the (average) root-mean-square of all Z scores of the bond lengths (or angles).
