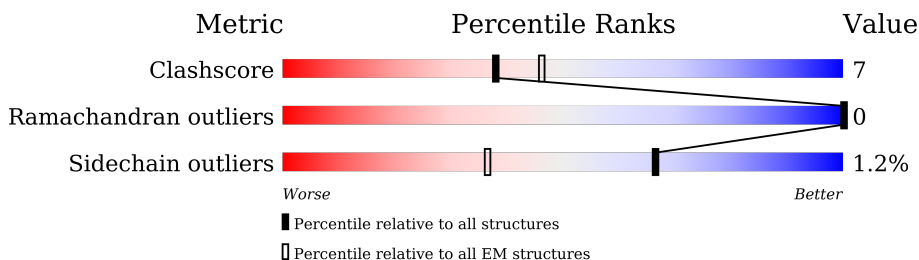
1 Overall quality at a glance i

5.2 Too-close contacts [i](#)
