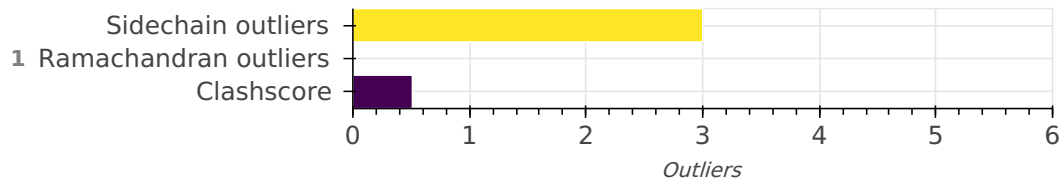

Too-close contacts
