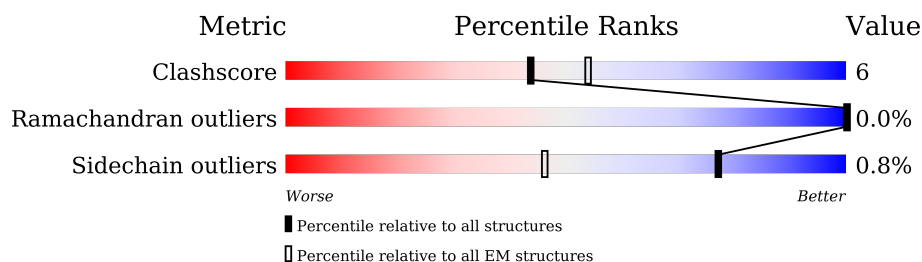
1 Overall quality at a glance

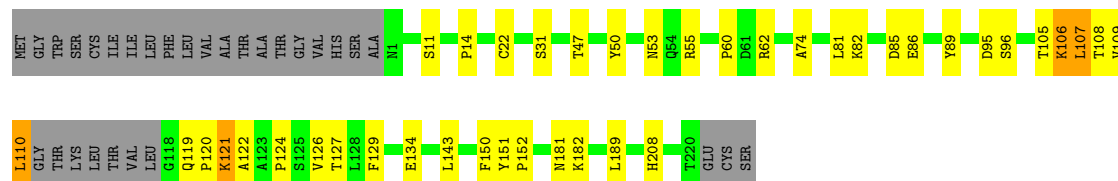
- Molecule 4: Light chain of H18 Fab

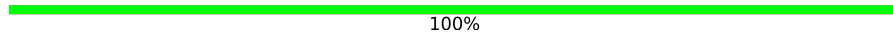

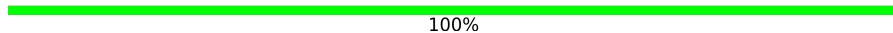

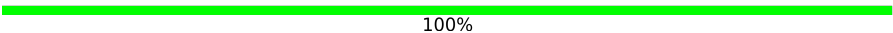

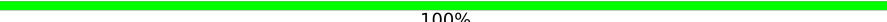
